**DESCRIPTION**

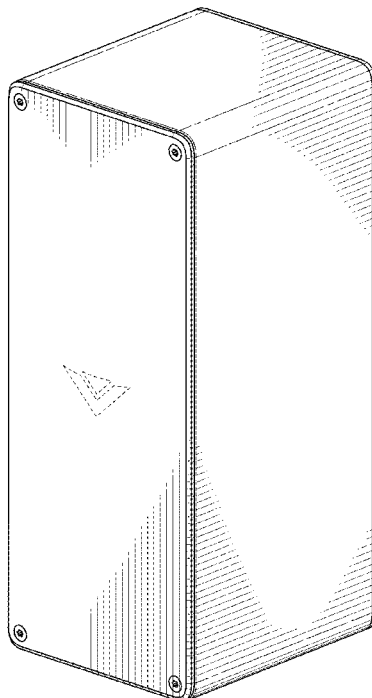
FIG. 1 is a perspective view of a satellite speaker, showing our new design;

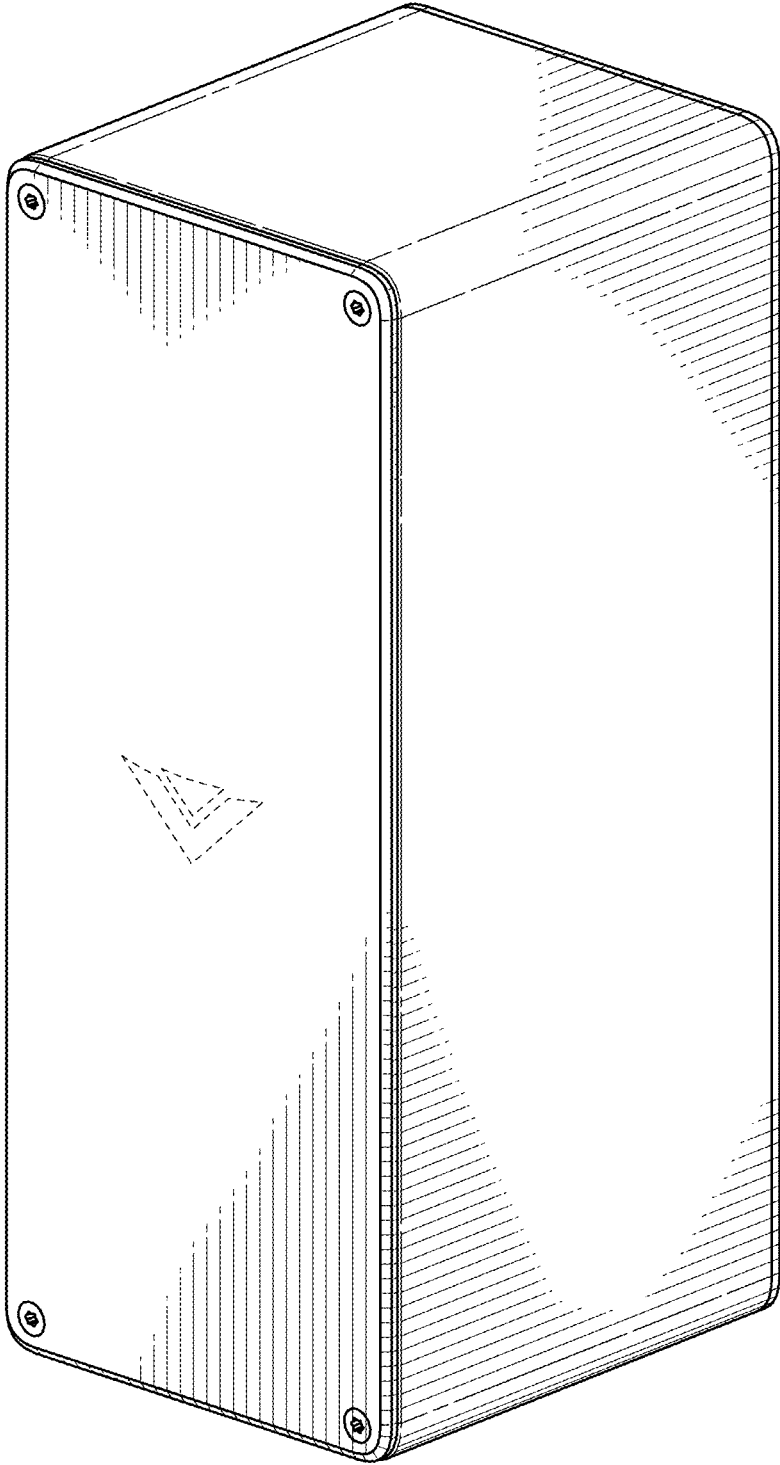

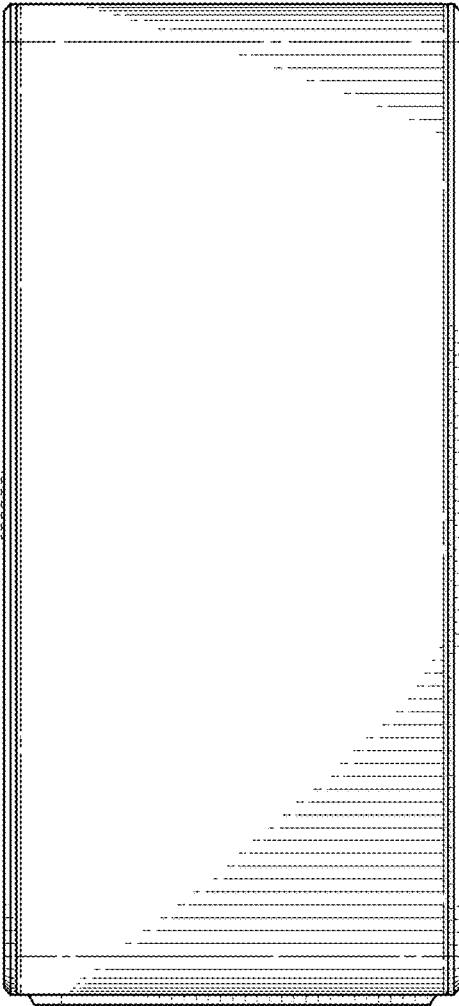

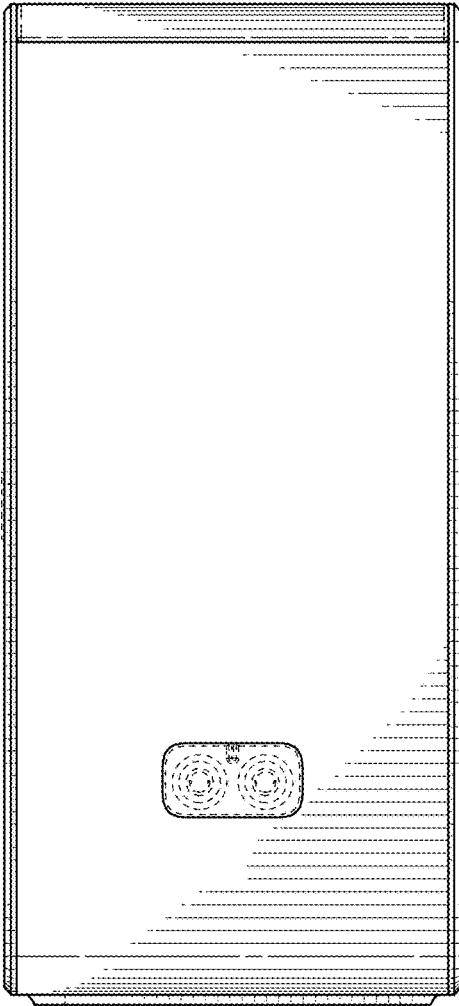

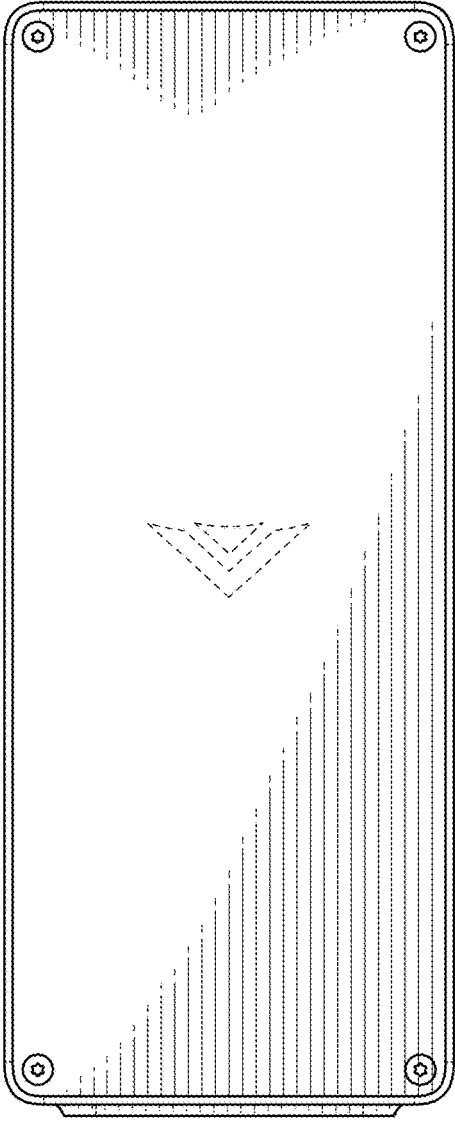

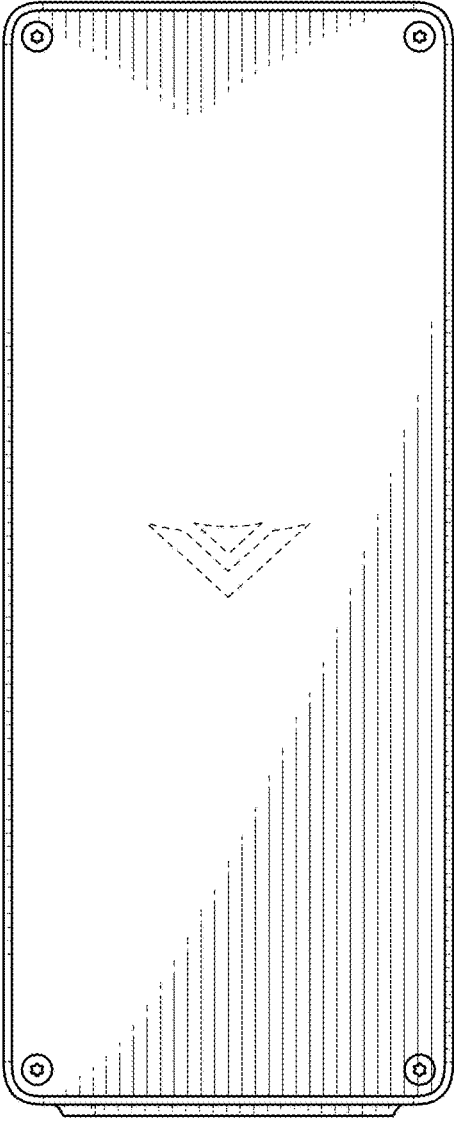

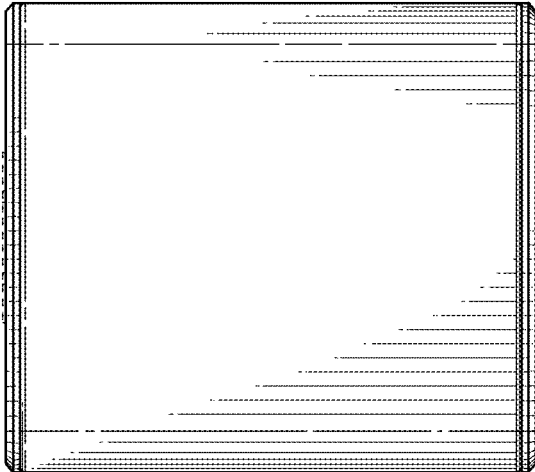

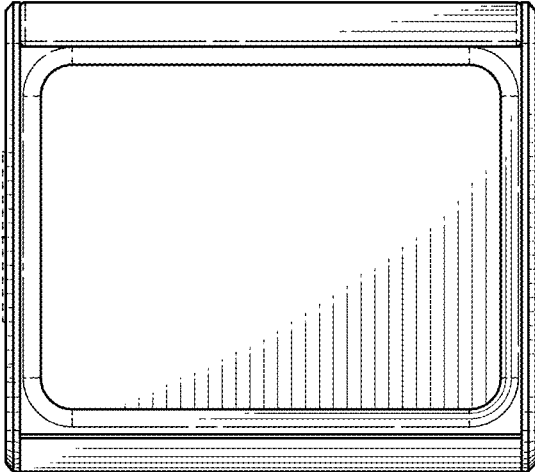
