DESCRIPTION

FIG. 1 is a perspective view of a clip, showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a bottom plan view thereof;

FIG. 4 is a front elevational view thereof;

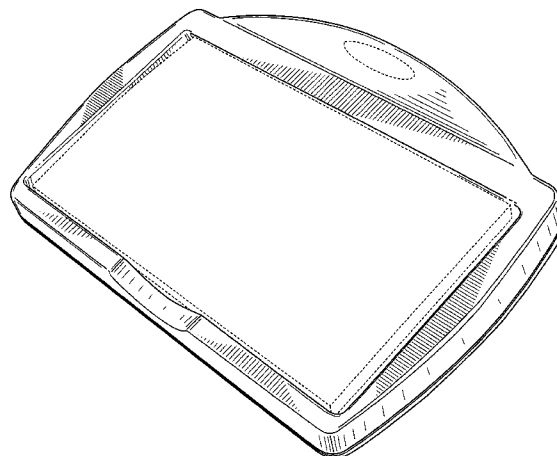
FIG. 5 is a rear elevational view thereof; opposite that shown in FIG. 4;

FIG. 6 is a side elevational view thereof; and,

FIG. 7 is a perspective view of the clip of FIG. 1 shown in its environment.

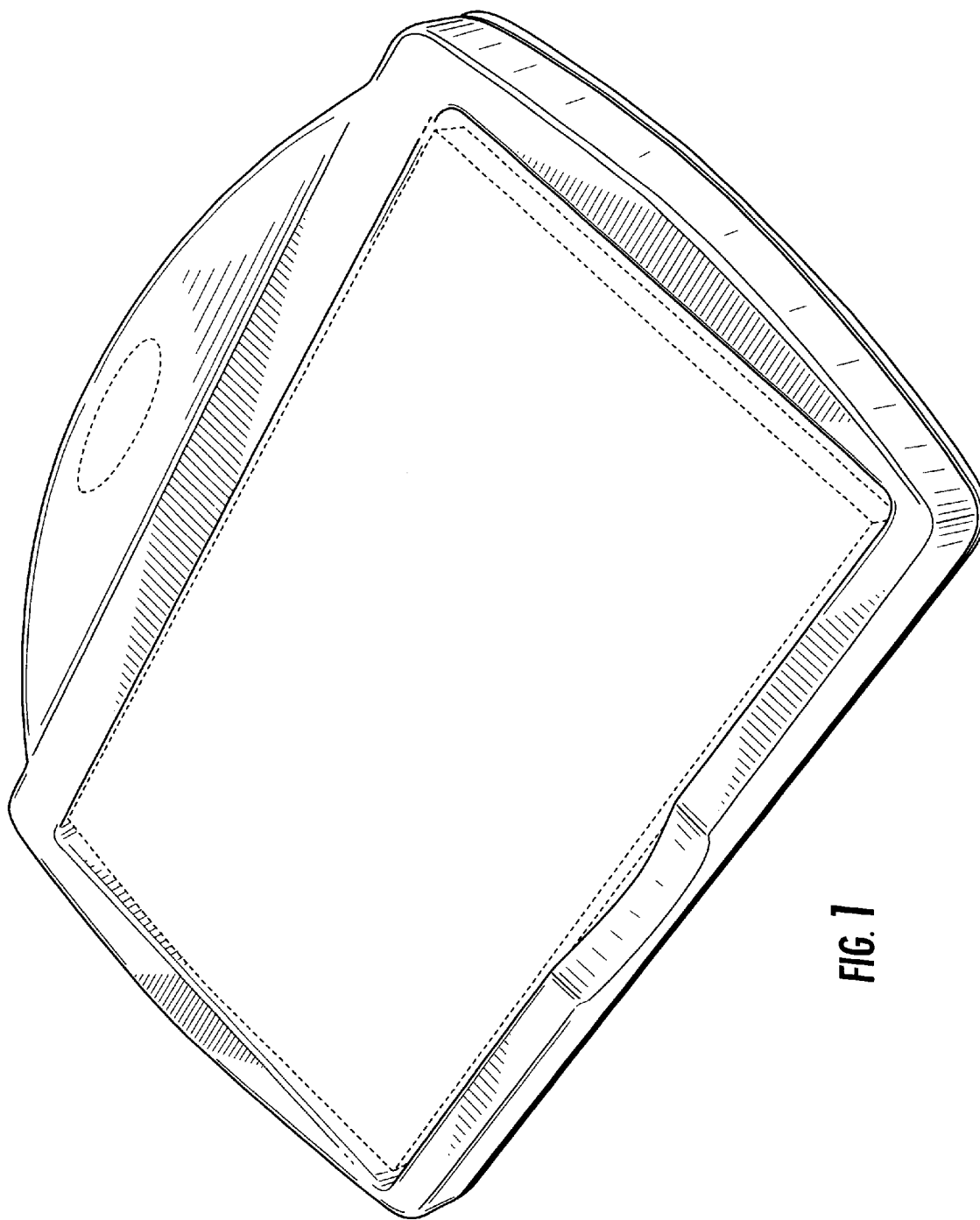

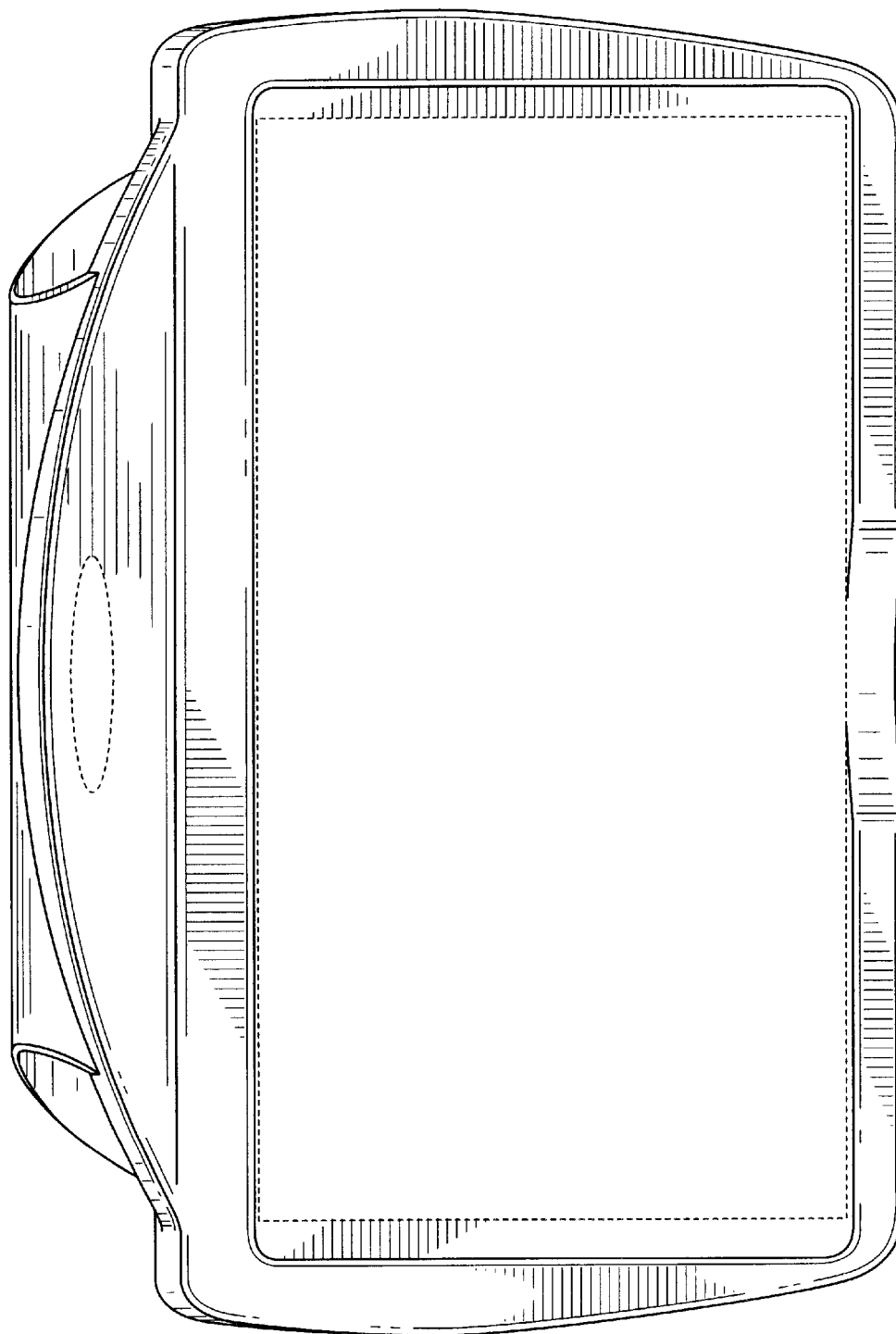

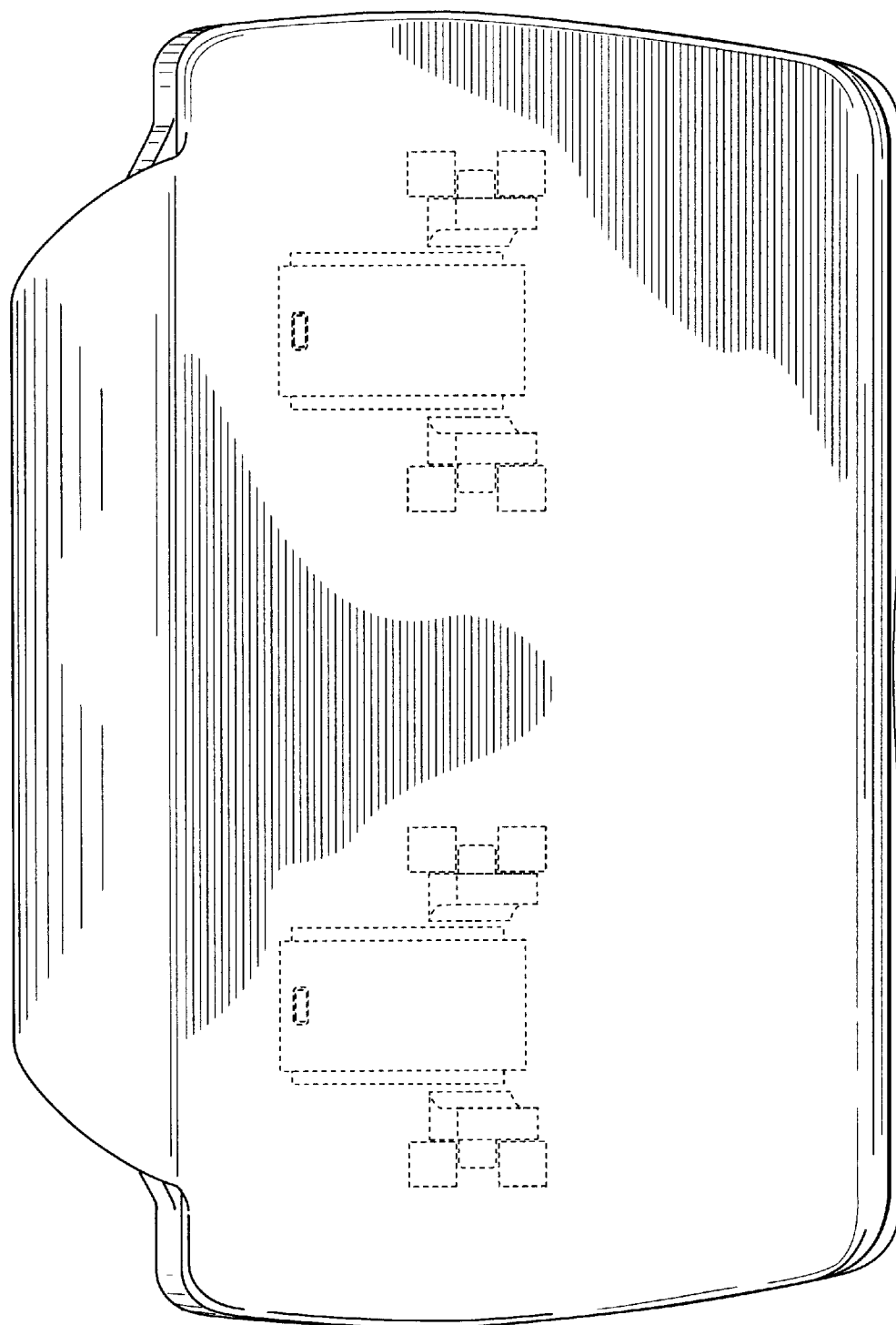

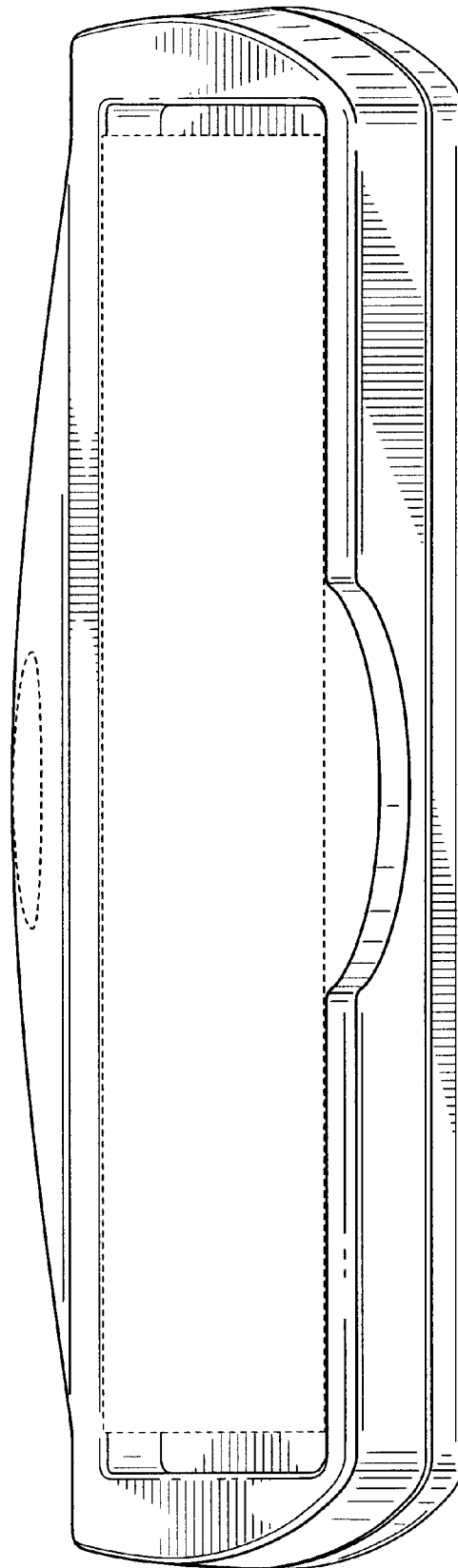

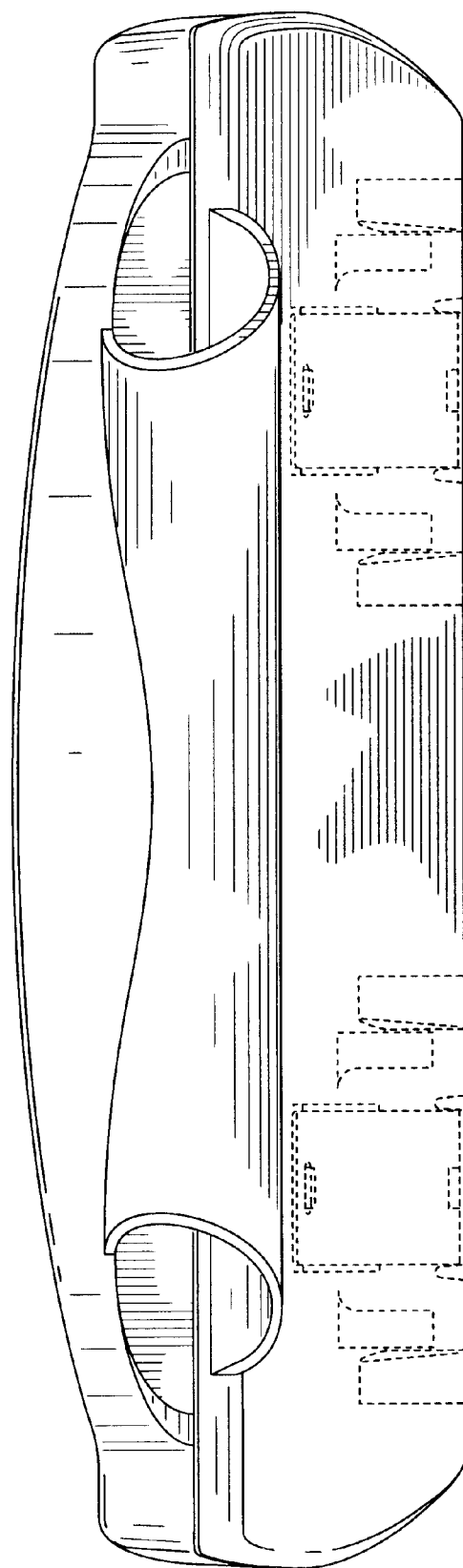

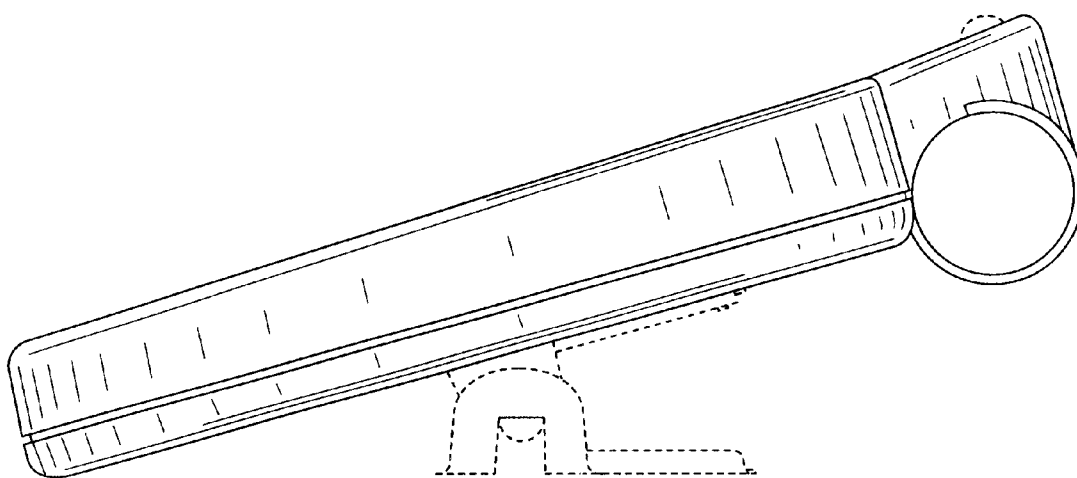
