DESCRIPTION

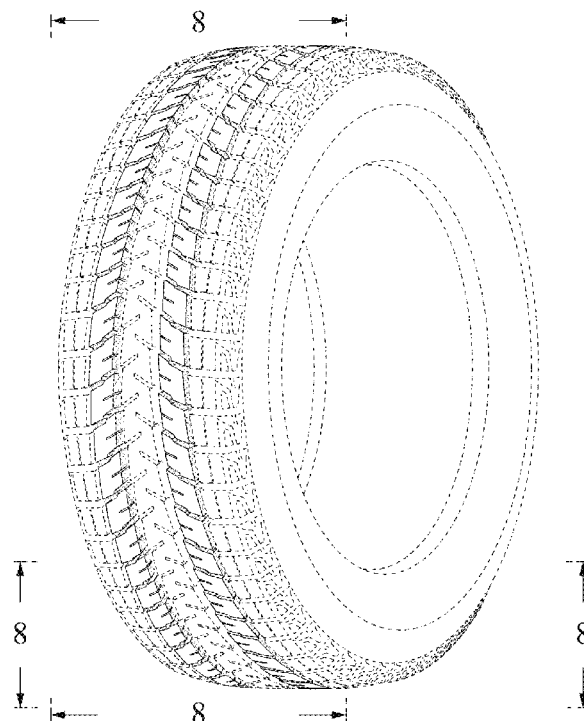

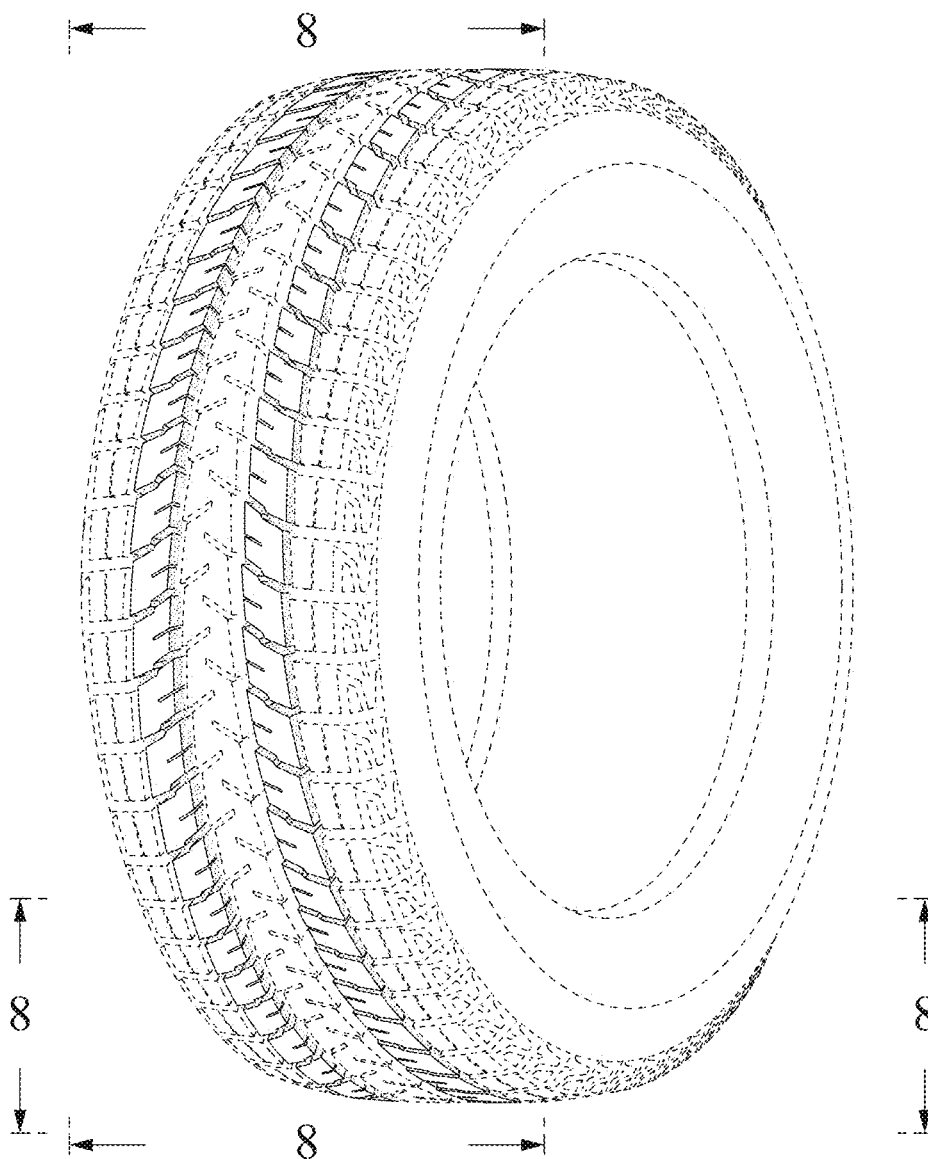

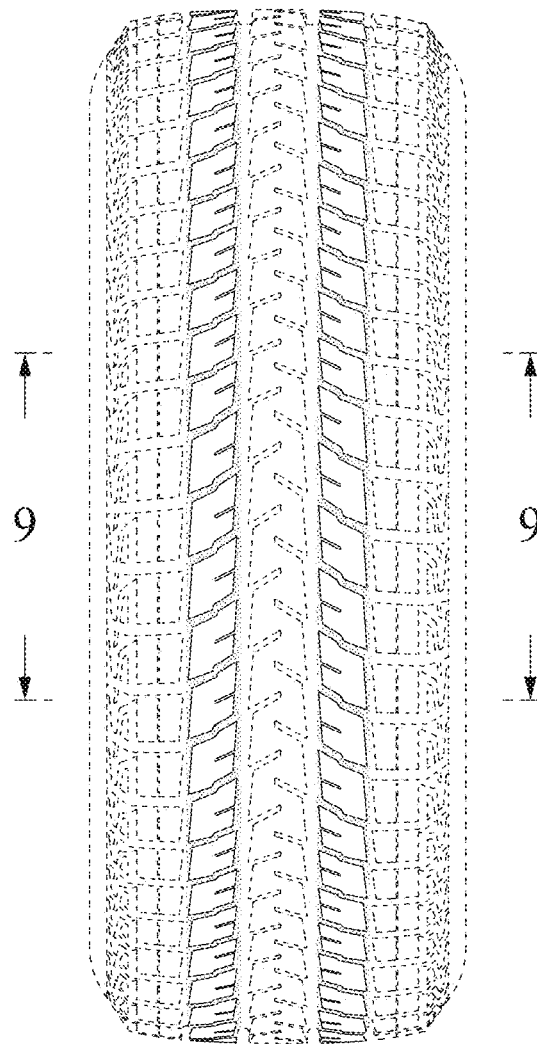

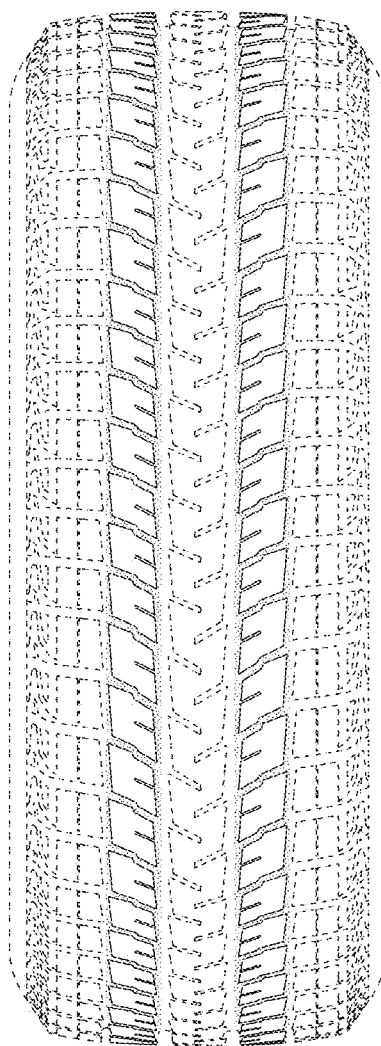

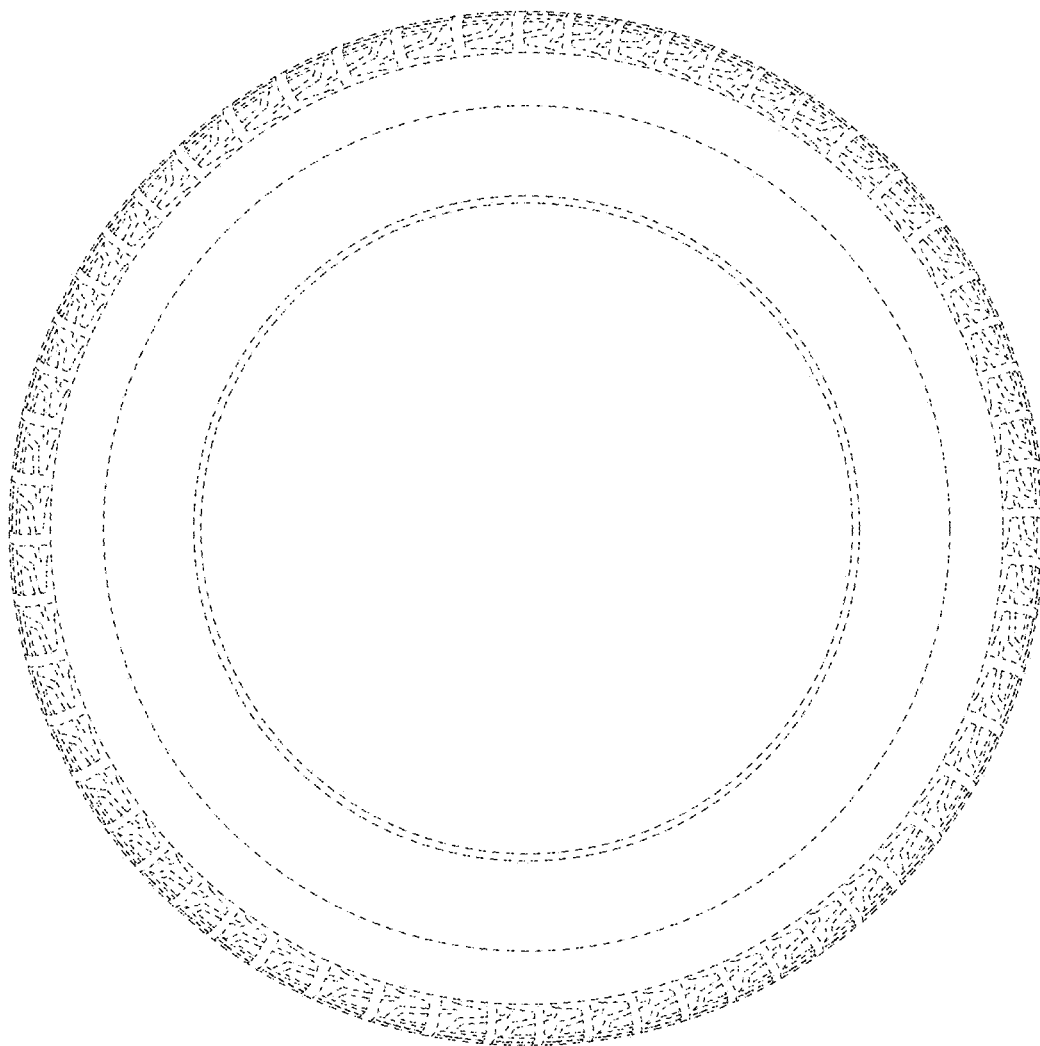

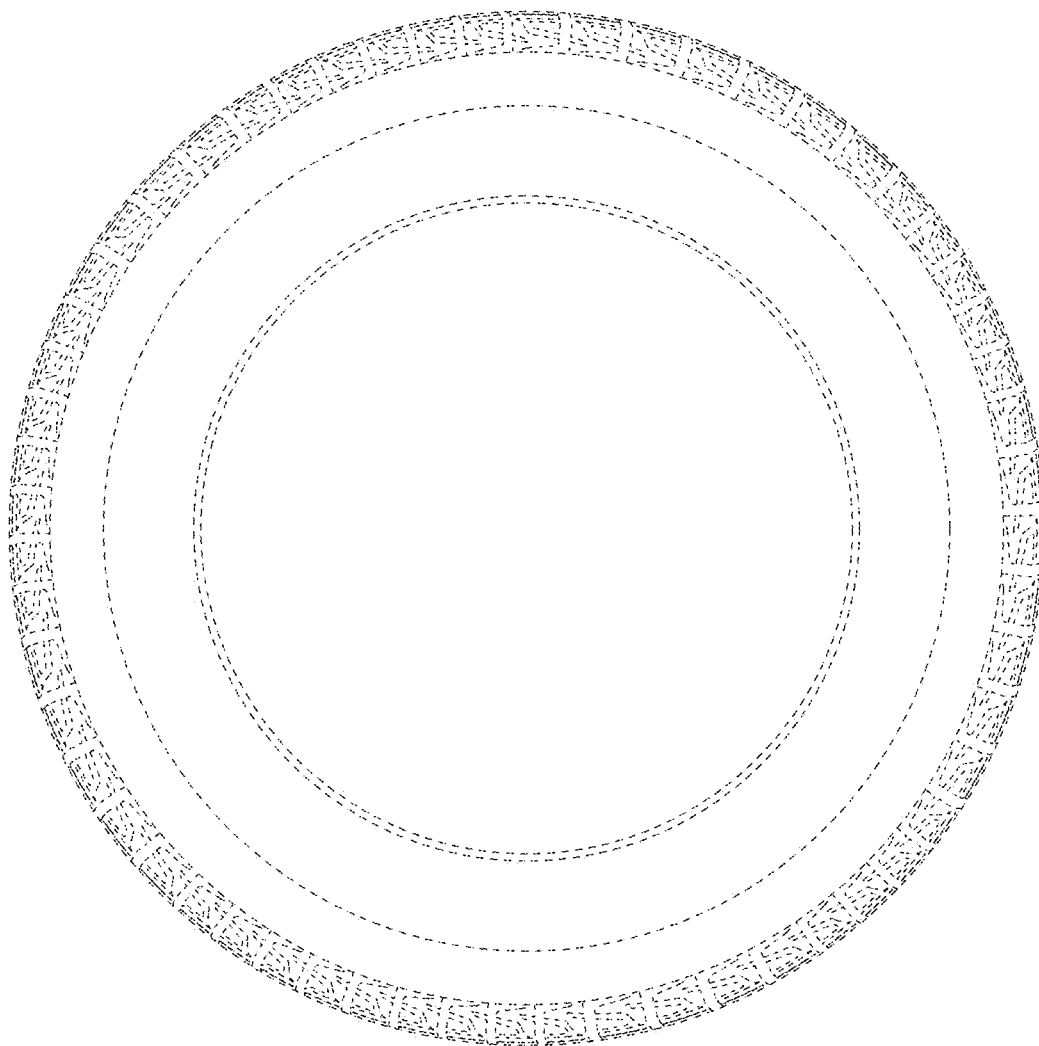

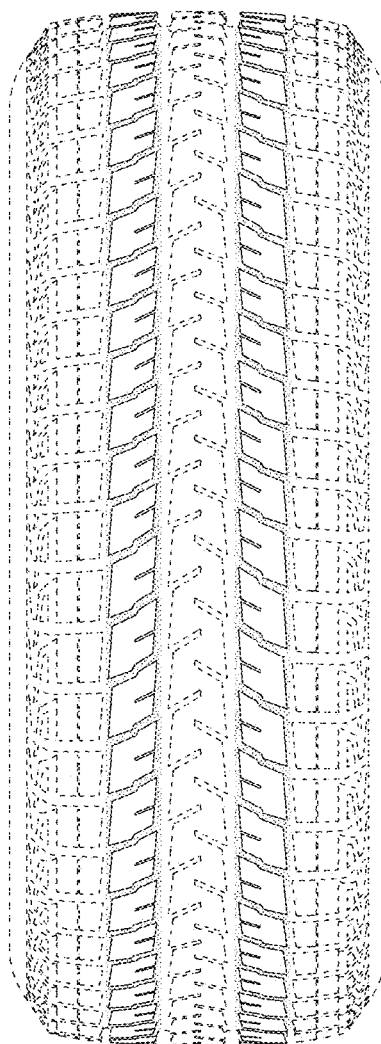

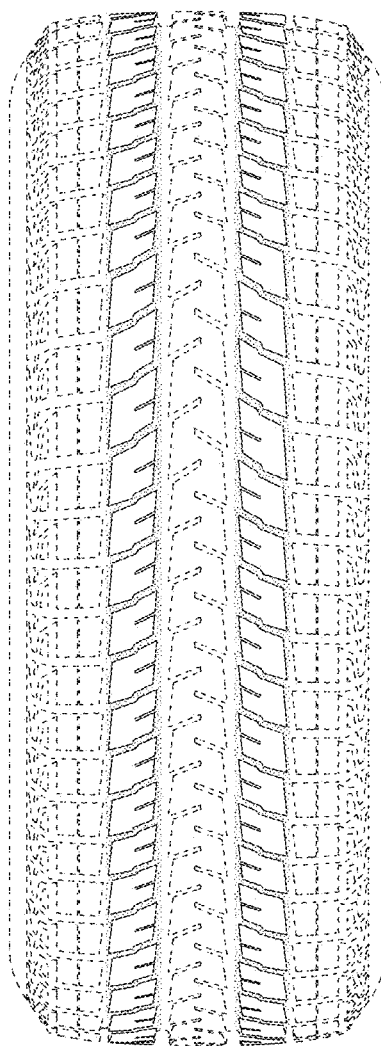

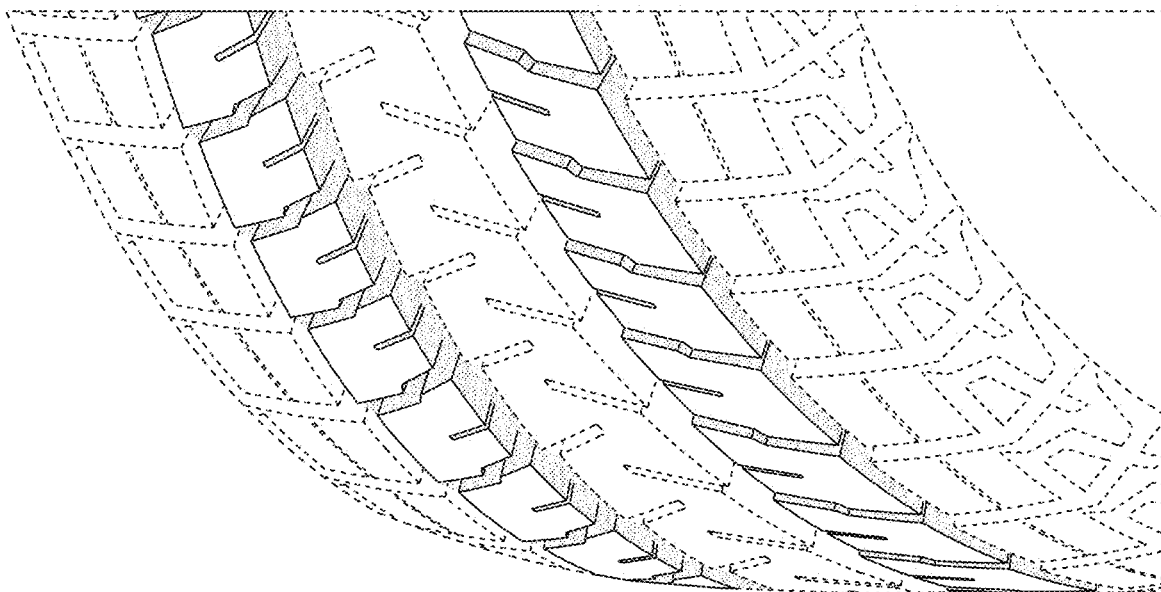

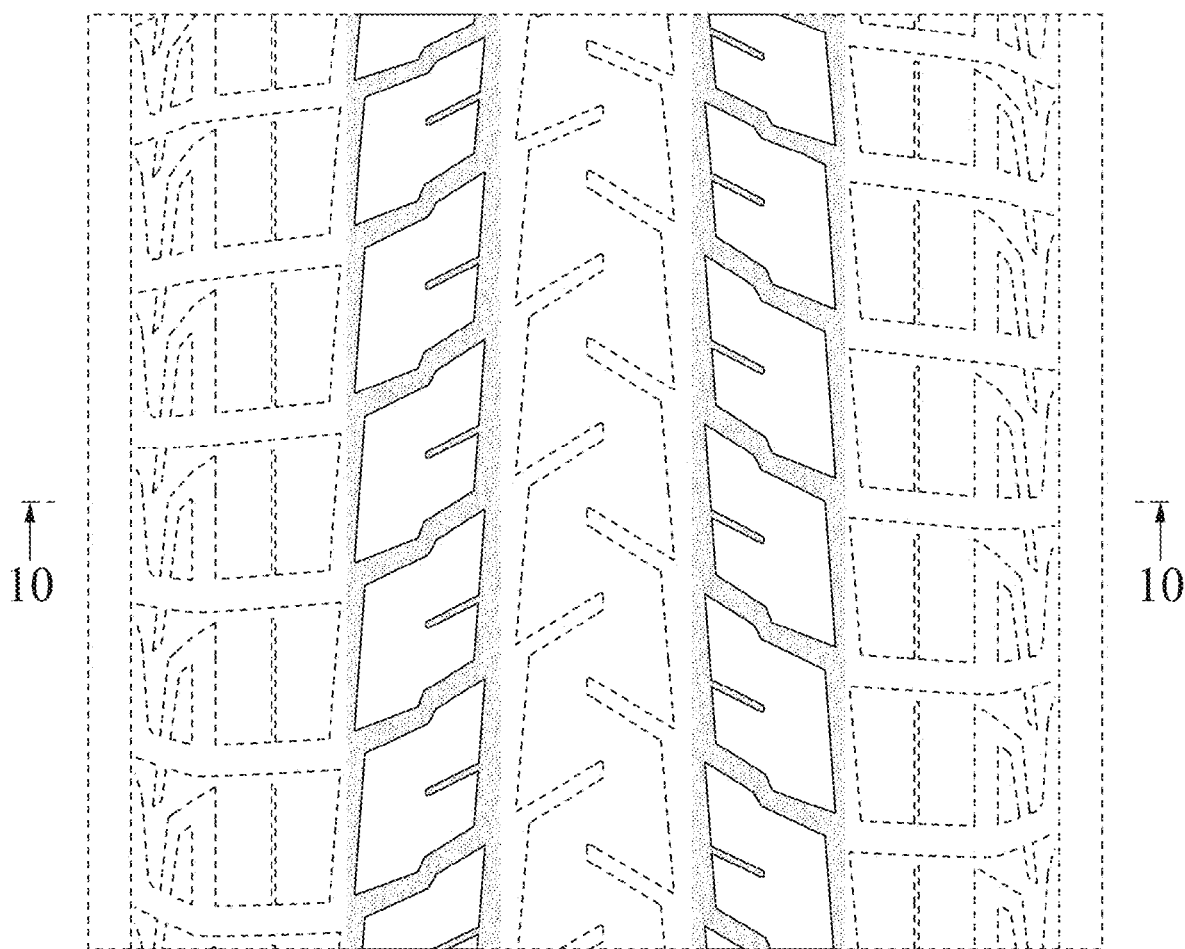
