(57) **CLAIM**

The ornamental design for an earring, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a first embodiment of an earring showing my new design;

FIG. 2 is a front perspective view of the design thereof;

FIG. 3 is a rear view of the design thereof;

FIG. 4 is a left side view of the design thereof;

FIG. 5 is a right side view of the design thereof;


FIG. 6 is a top view of the design thereof; and,














