(57) **CLAIM**

The ornamental design for the exercise ball, as shown and described.

**DESCRIPTION**

FIG. 1 is a right-side perspective view of the exercise ball of my design;

FIG. 2 is a front view of the exercise ball of the design of FIG. 1;

FIG. 3 is a top view of the exercise ball of the design of FIG. 1;

FIG. 4 is a bottom view of the exercise ball of the design of FIG. 1;

FIG. 5 is a right-side view of the exercise ball of the design of FIG. 1;

FIG. 6 is a left-side view of the exercise ball of the design of FIG. 1;

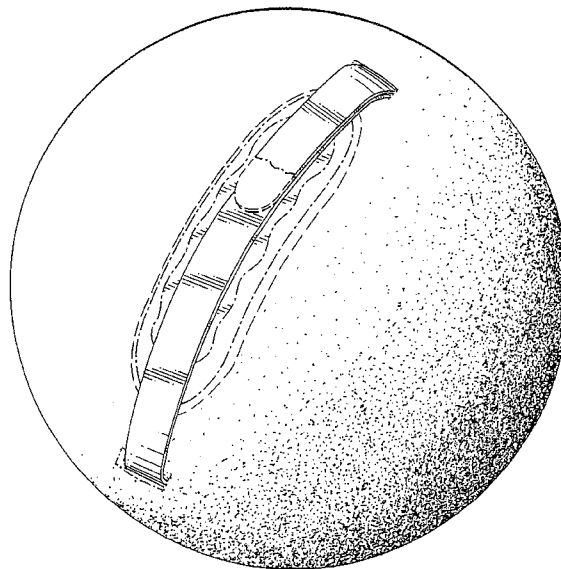
FIG. 7 is a right-side view of the exercise ball of the design of FIG. 1 showing the handle in an alternate position;

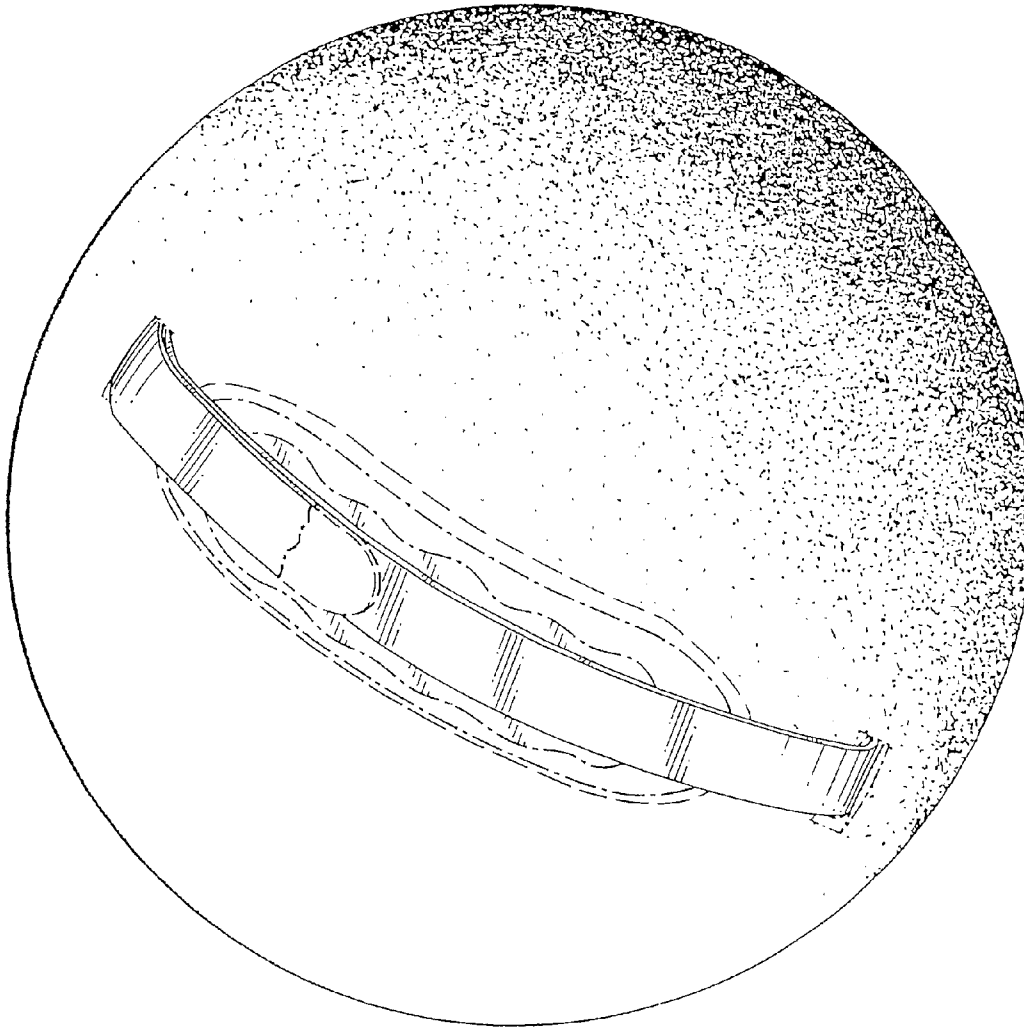
FIG. 8 is a left-side view of the exercise ball of the design of FIG. 1 showing the handle in an alternate position; and,

FIG. 9 is a front view of the exercise ball of the design of FIG. 1 showing the handle in an alternate position from that shown in FIG. 2.

The portions of one handle and portions of its associated openings, the remaining handle, the stitching, and the handle openings, shown in broken lines, are illustrative and are not part of the claimed design.

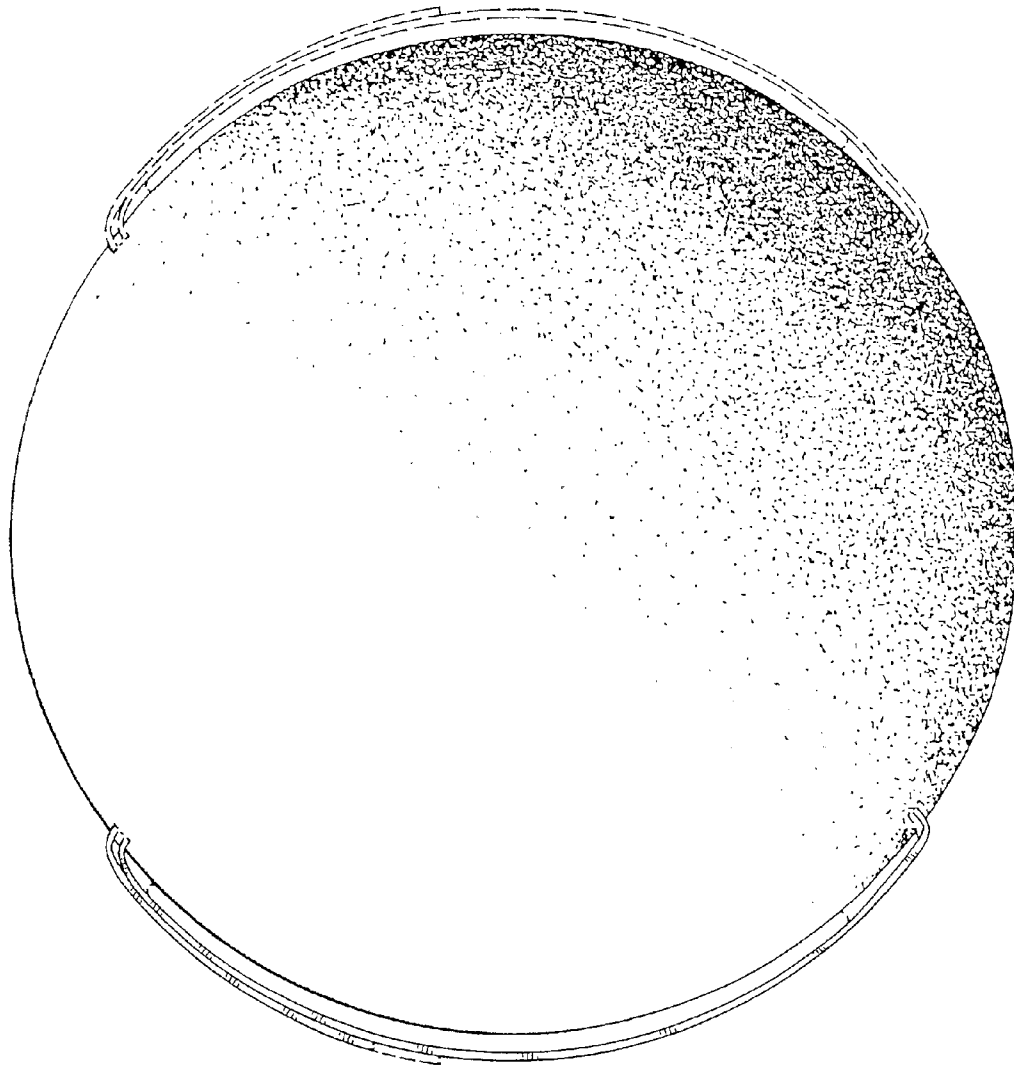

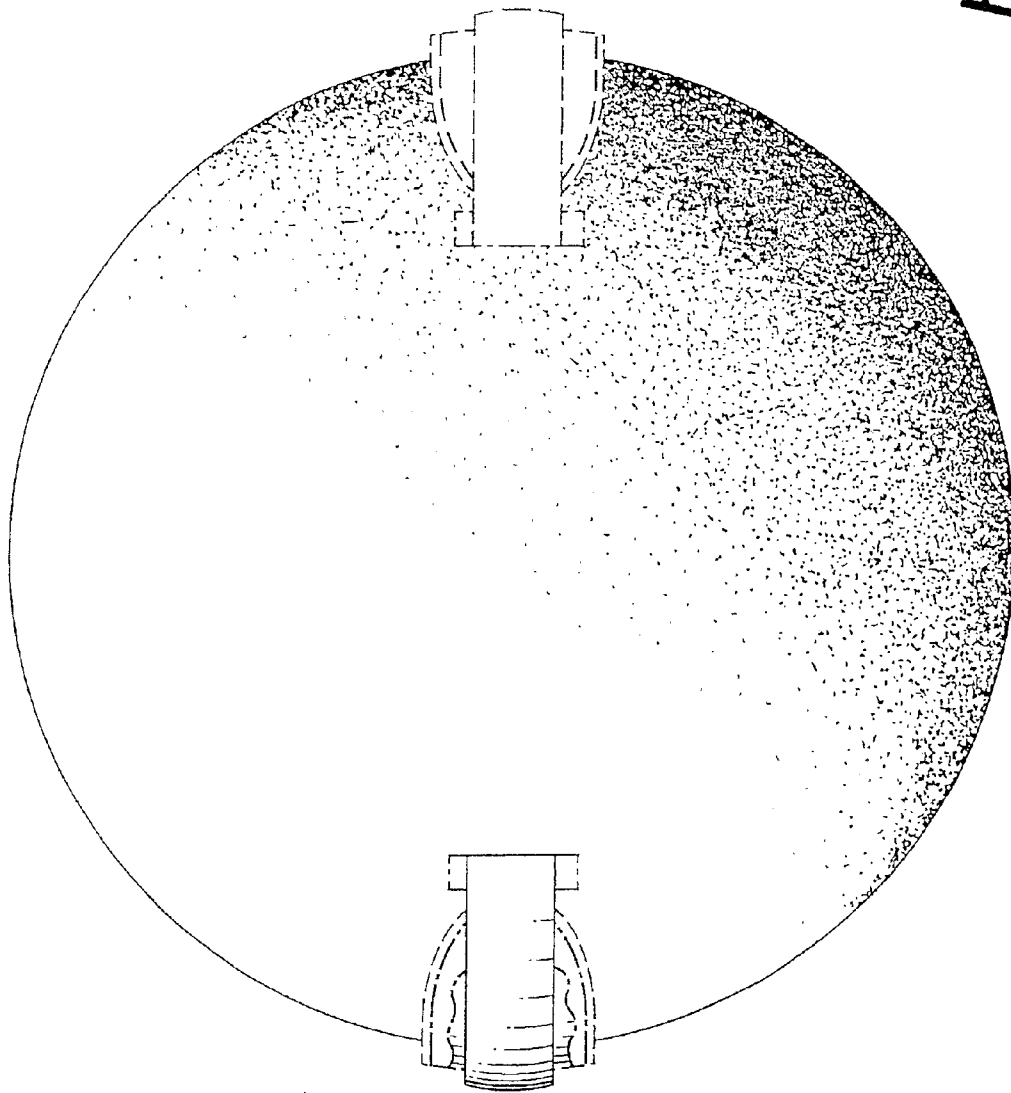

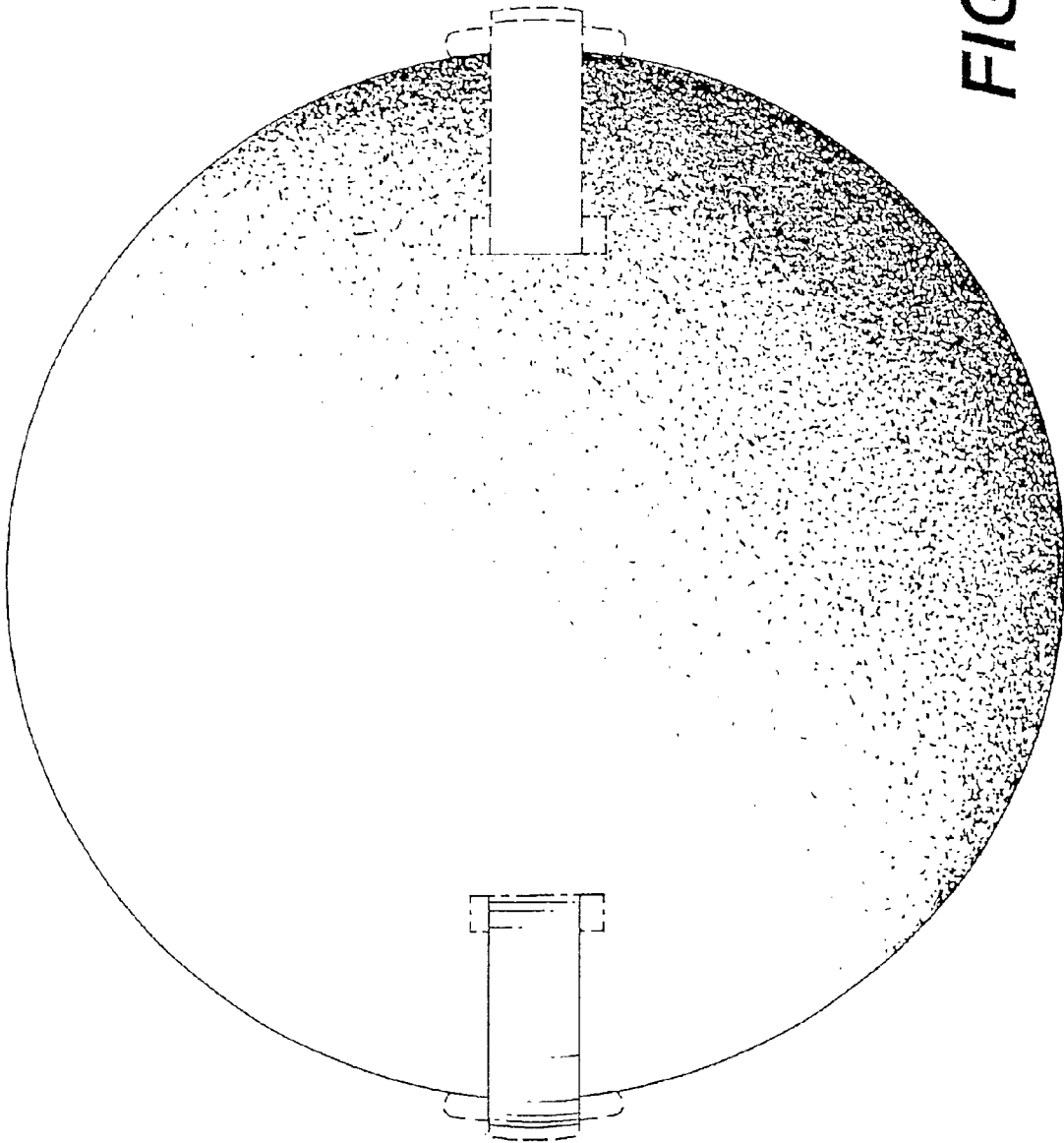

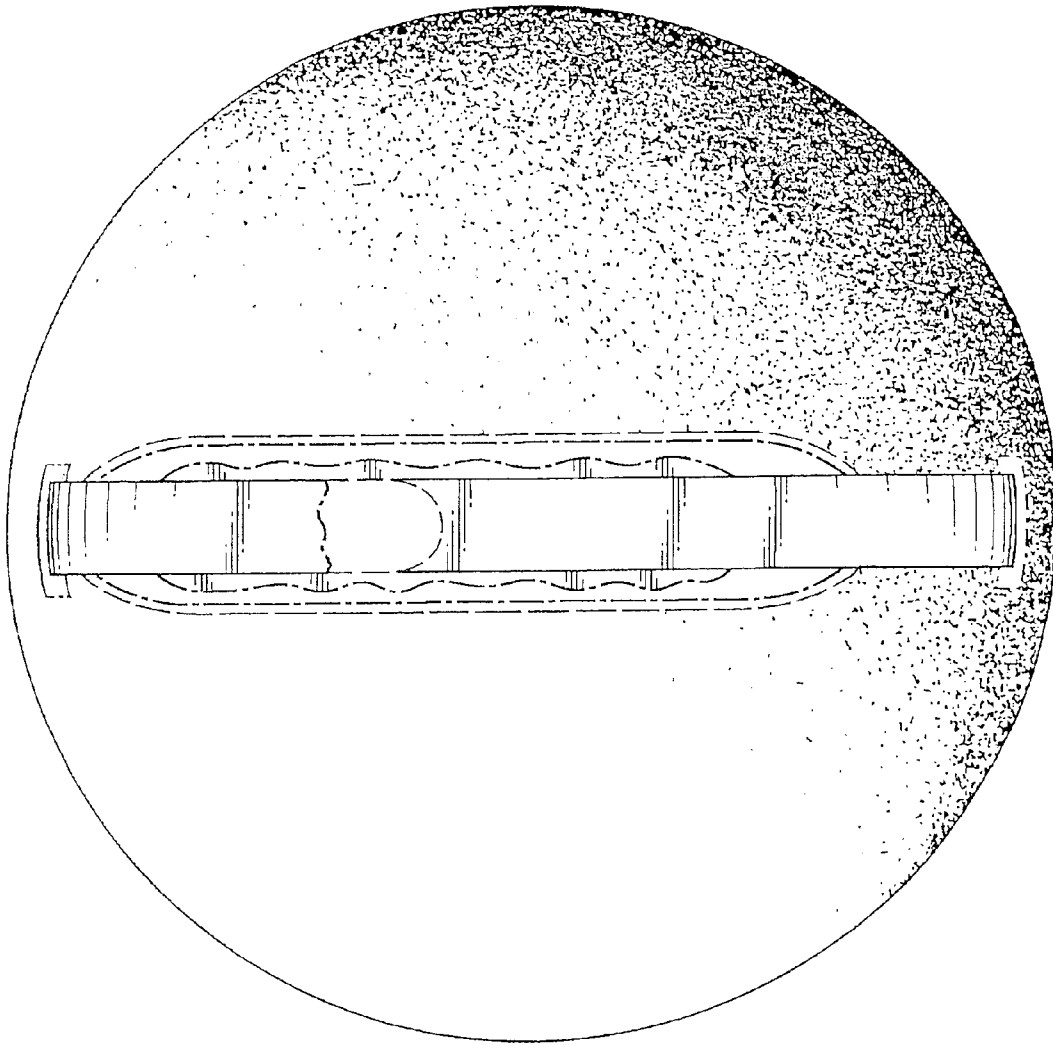

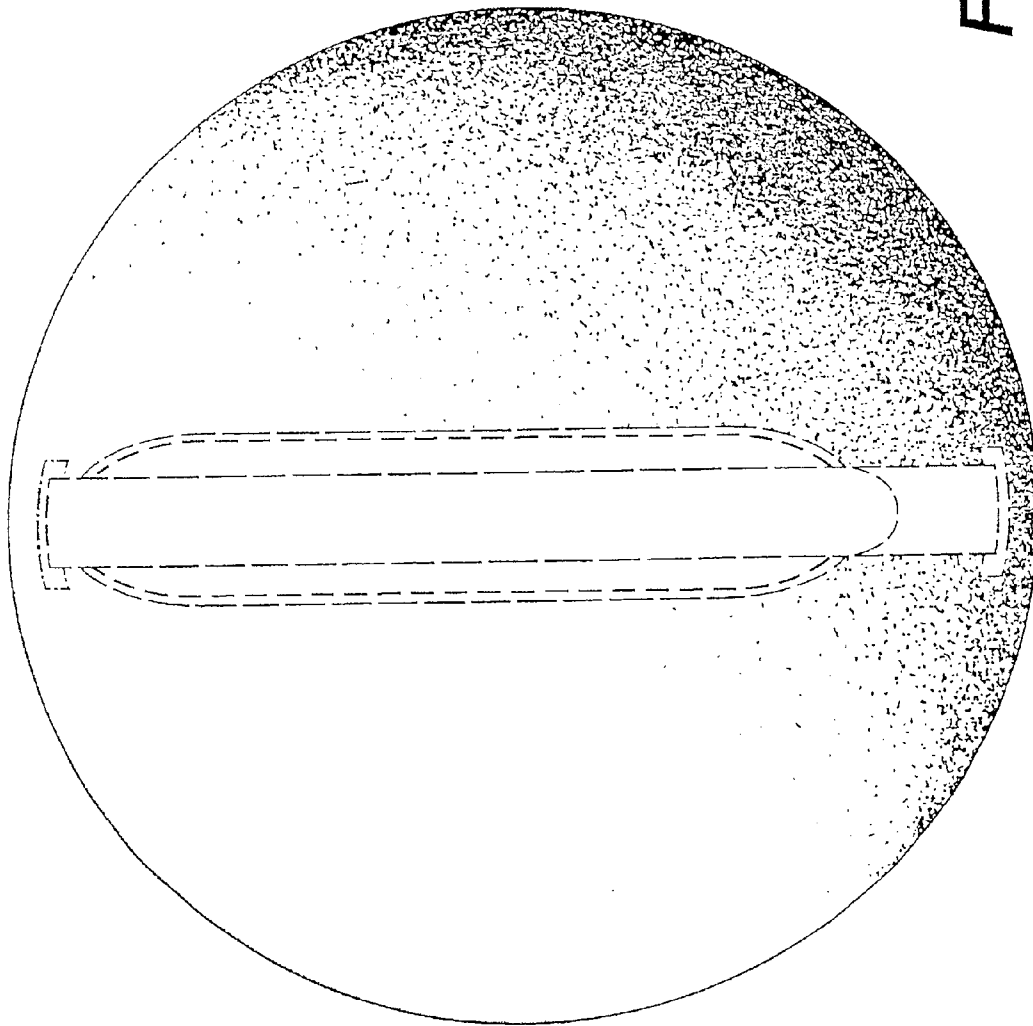

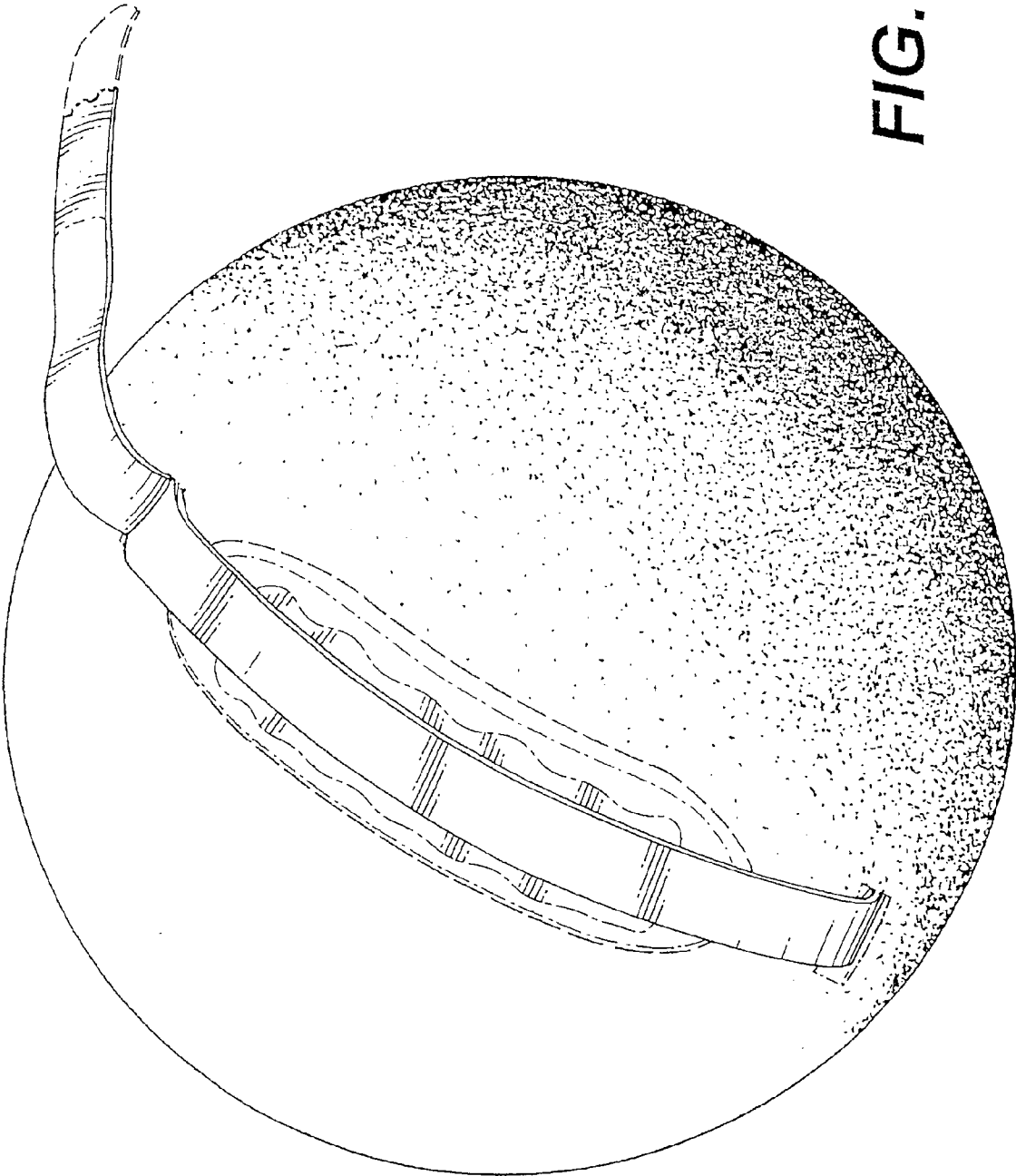
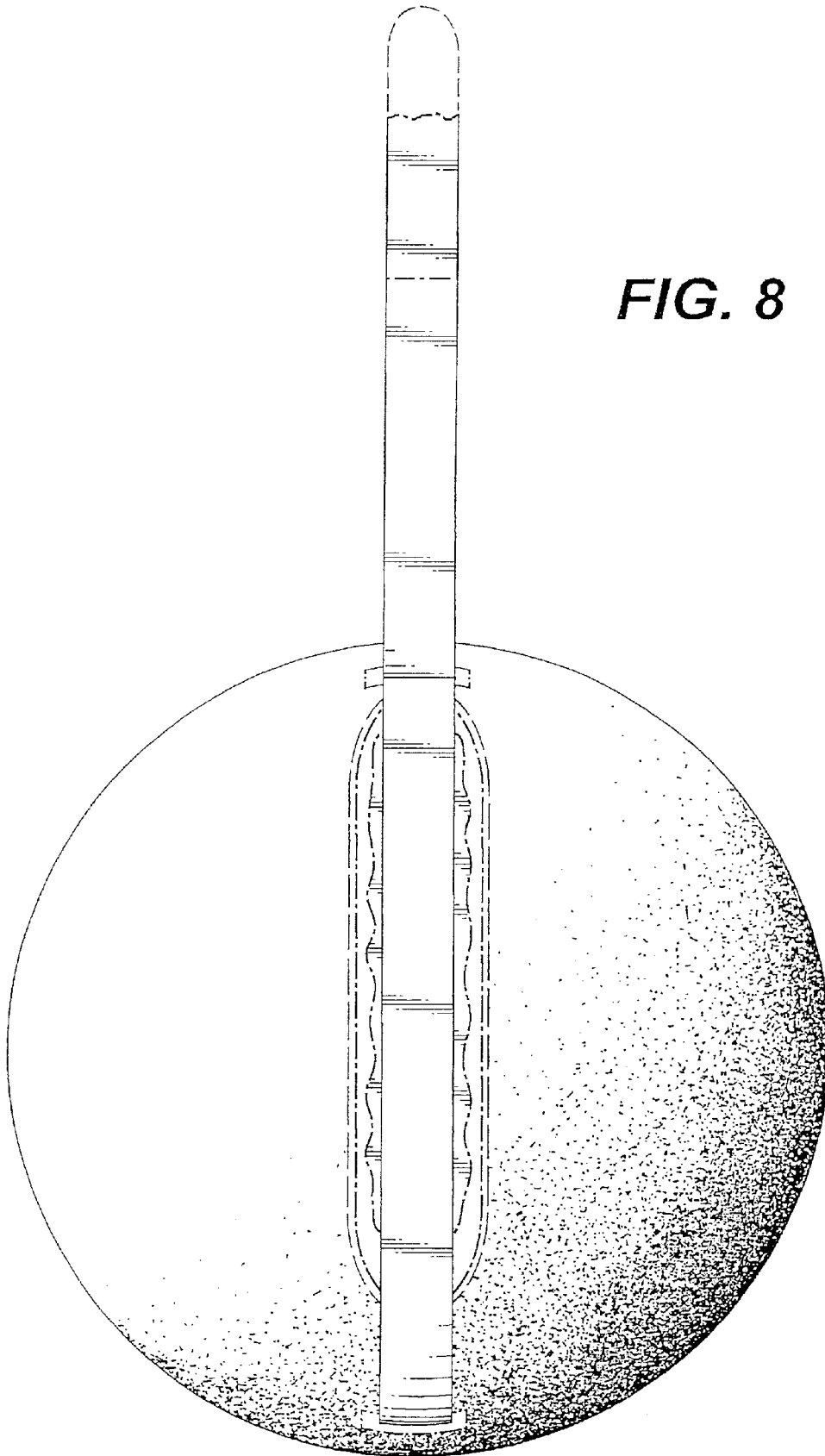

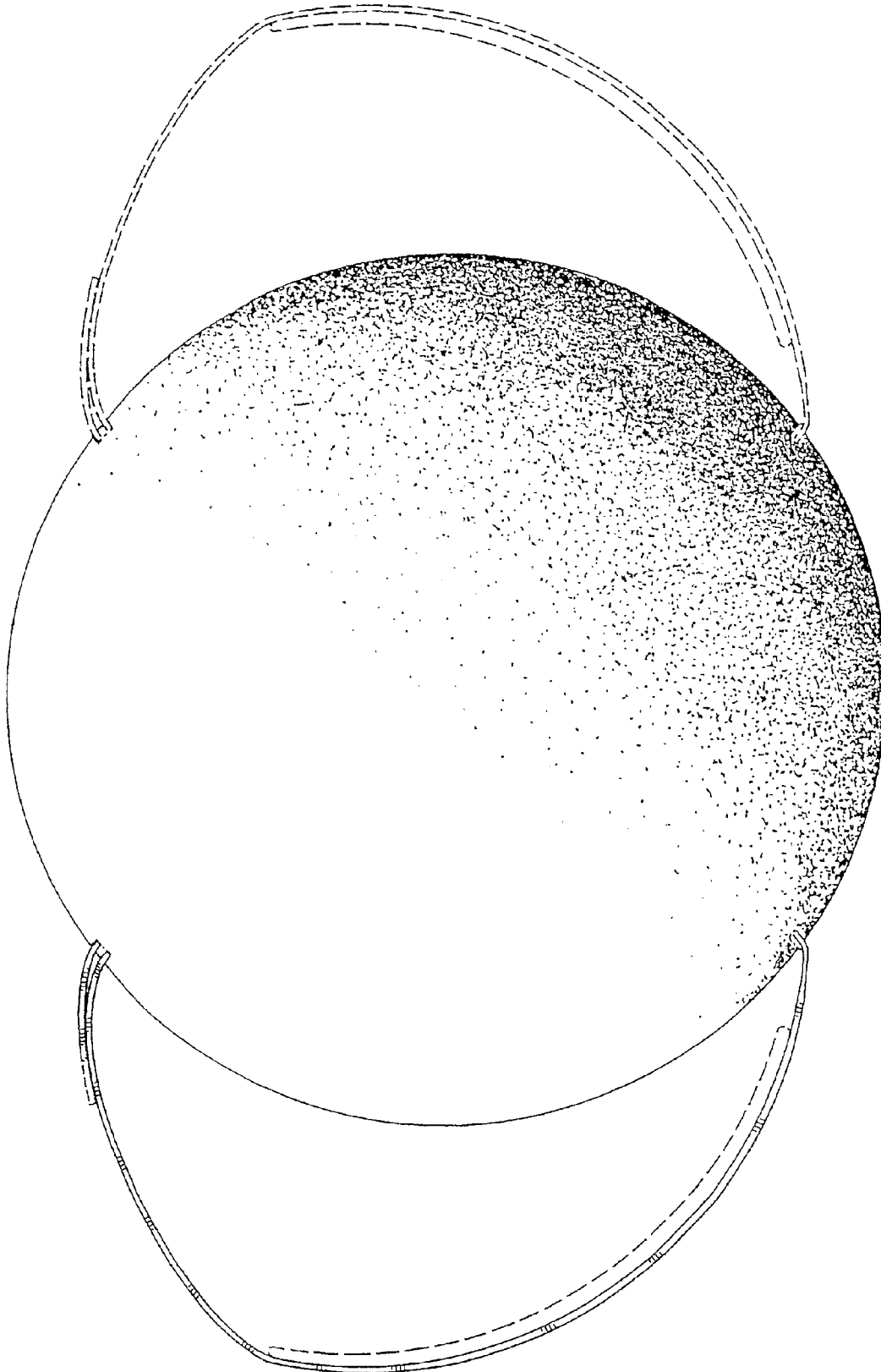
