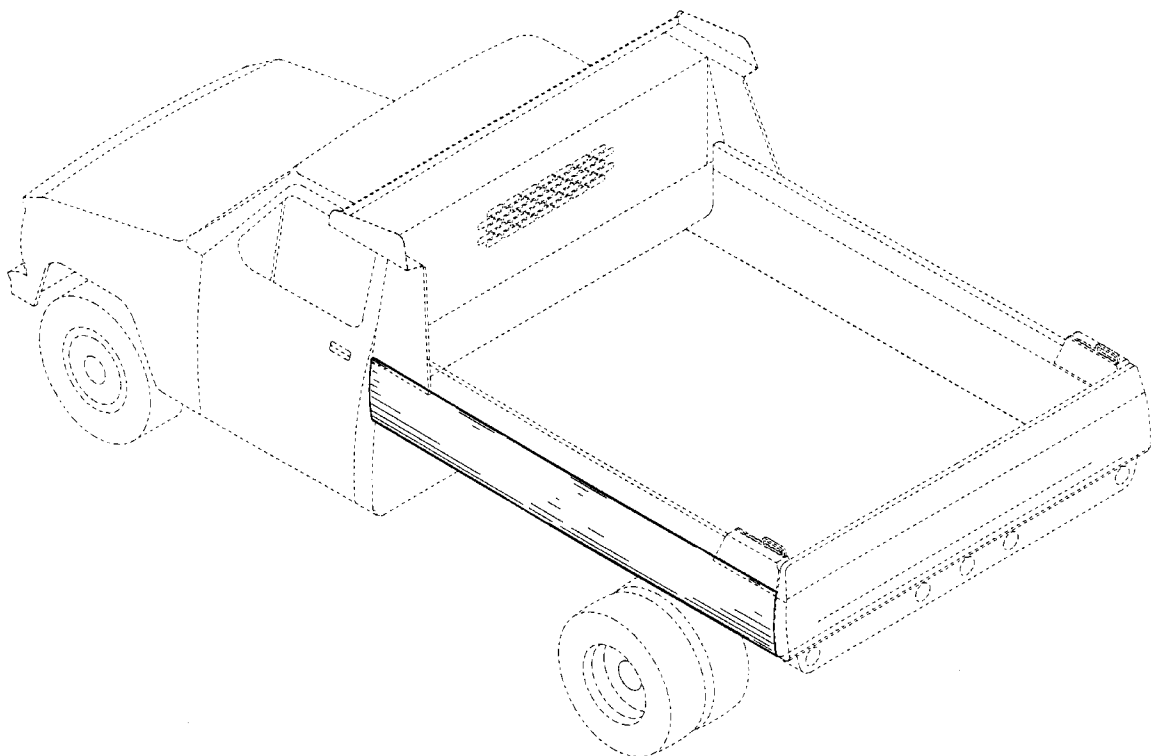

FIG. 4 is a top plan view of the left side panel;  
FIGS. 5 is a bottom plan view of the left side panel;  
FIG. 6 is a greatly enlarged cross-sectional view of the left  
side panel as seen from the plane indicated by the line 6—6  
in FIG. 2, the right side panel being a mirror image thereof.  
The broken lines shown are for illustrative purposes only  
and form no part of the claimed design.

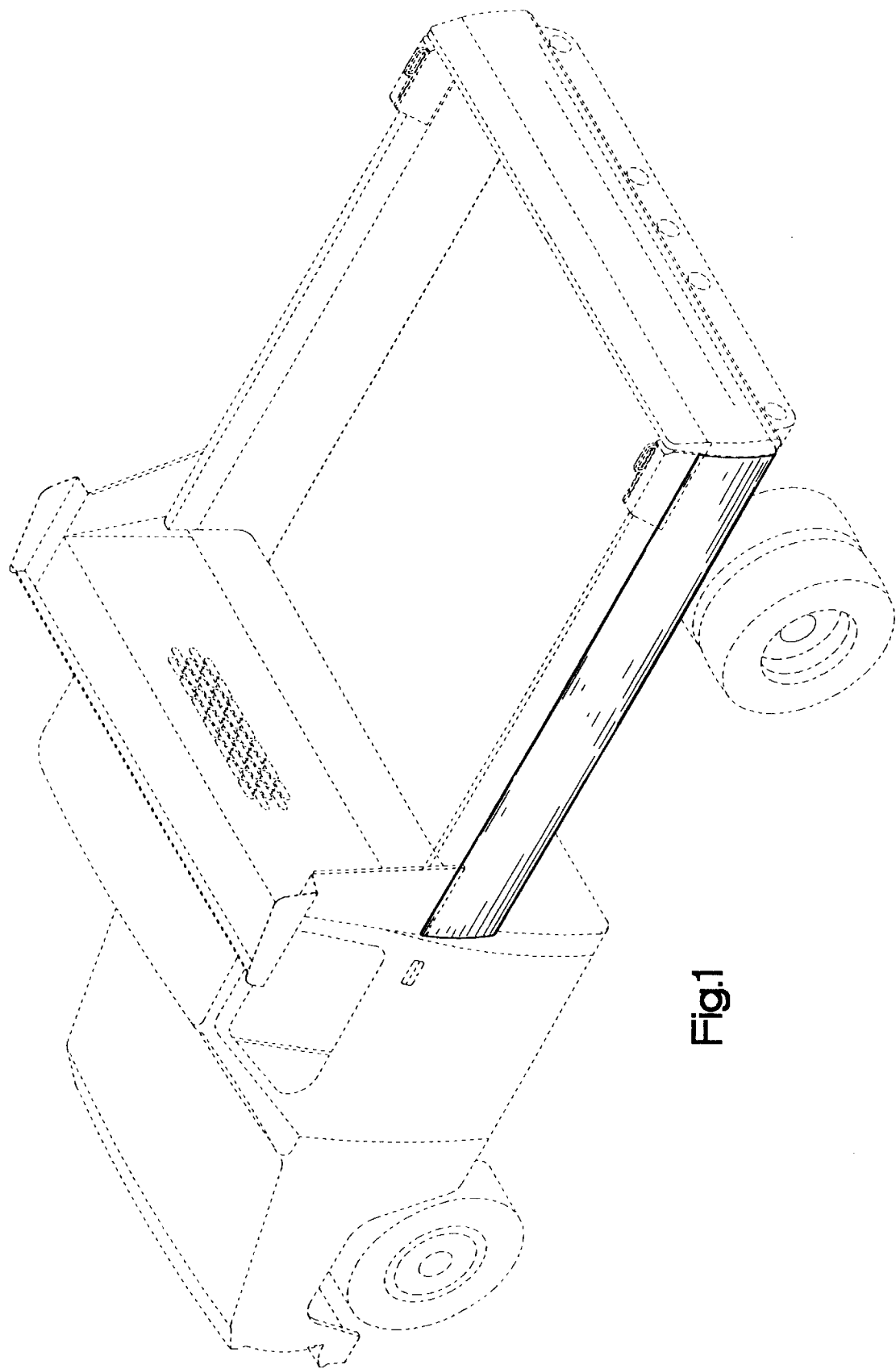

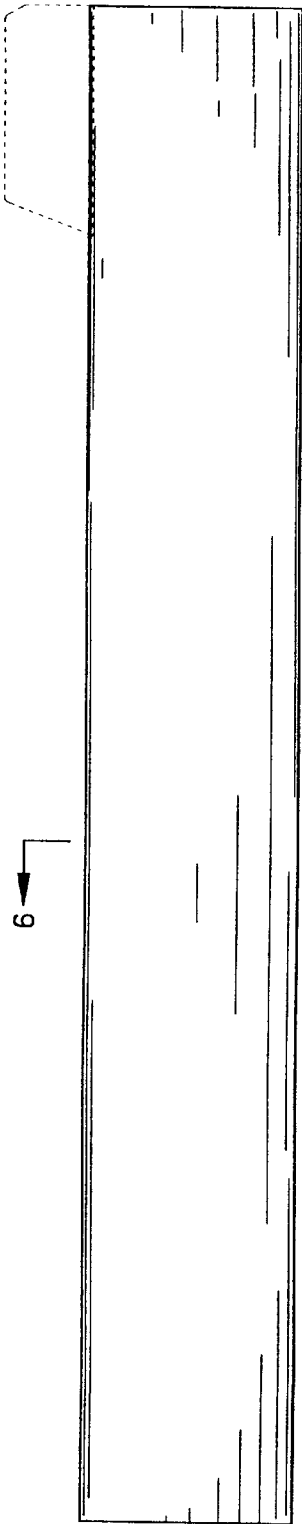

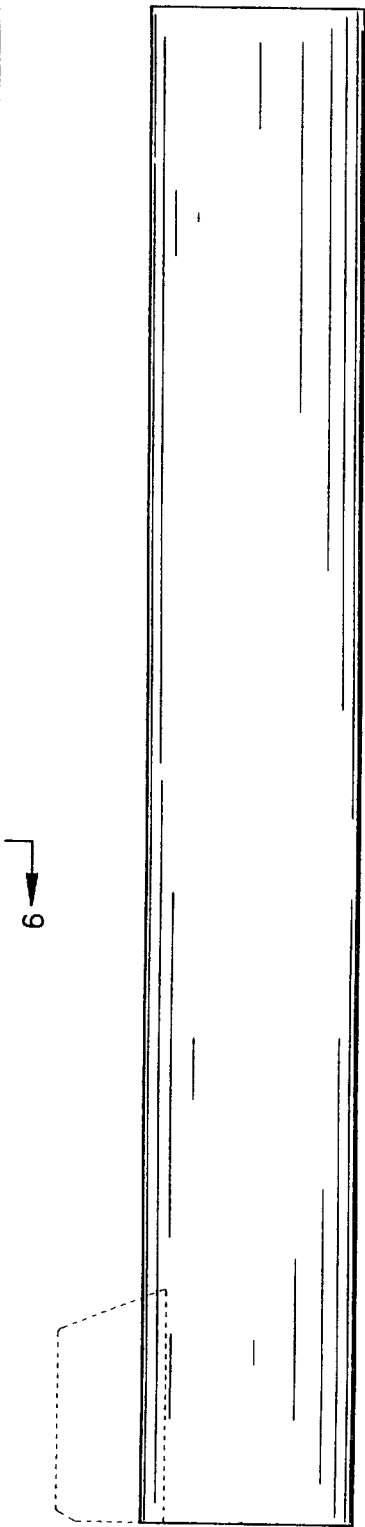

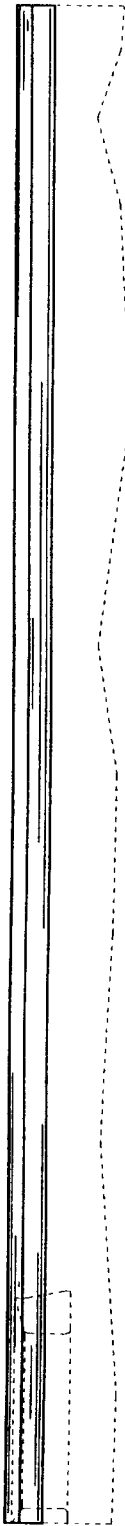

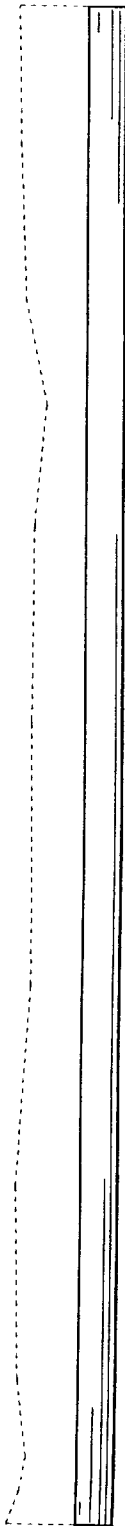

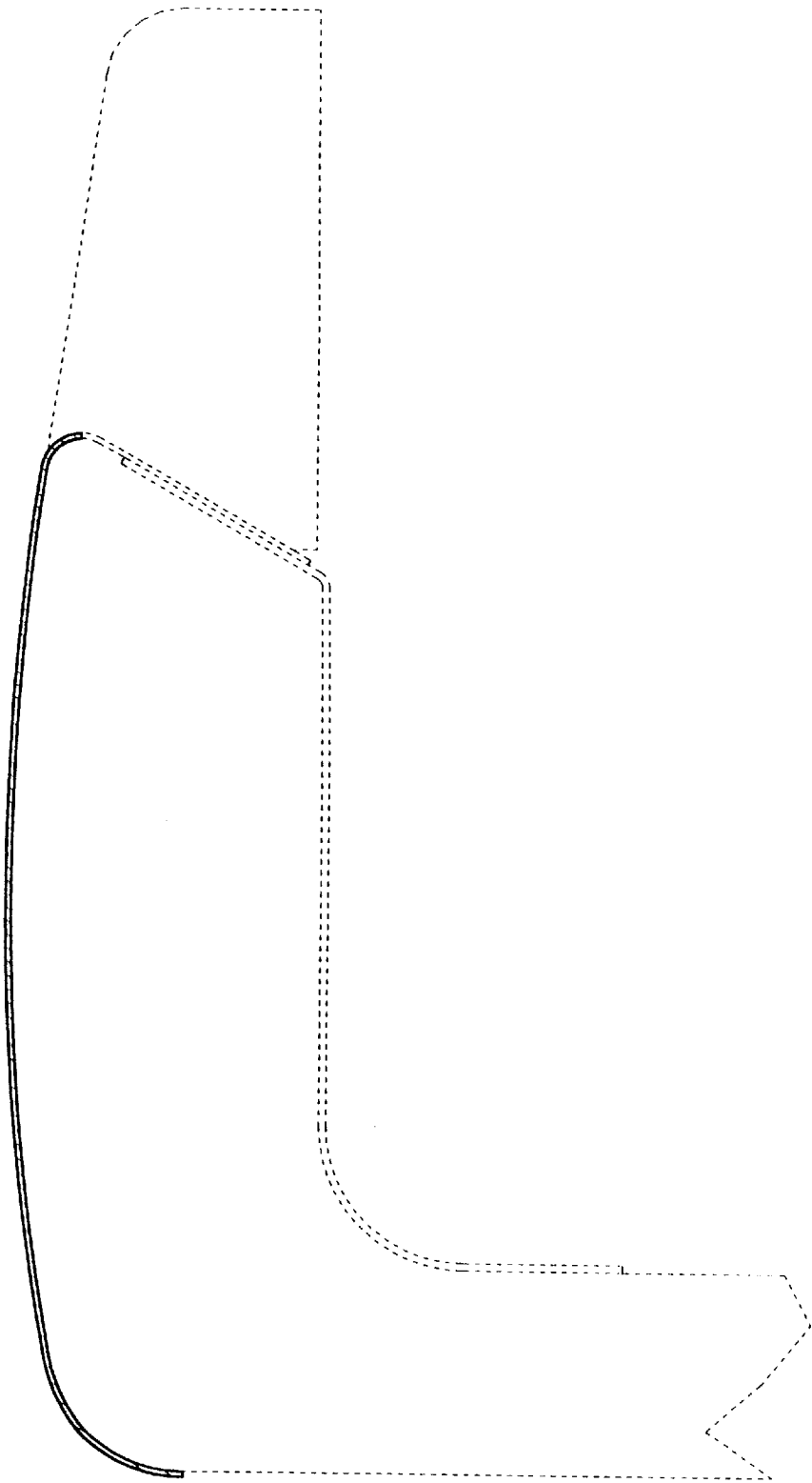
