




The ornamental design for a extension cord rack, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of an extension cord rack showing our new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a bottom plan view thereof; and,
FIG. 6 is a left side elevational view thereof, the right side elevational view being a mirror image of the left side elevational view.






