

(57) Abstract: A lithographic system for an integrated circuit fabrication process includes a computer (30, 32) and a configurable mask (20). The configurable mask is coupled to the computer. The configurable mask allows light to be transmitted in the pattern (150) controlled by a control signal from the computer. The mask can allow ASIC type functionality for designing custom design integrated circuits.
