(57) **CLAIM**
The ornamental design for a combined bottle storage, transport and display box, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, right side perspective view of a combined bottle storage, transport and display box showing my new design.

FIG. 2 is a front view thereof.

FIG. 3 is a rear view thereof.

FIG. 4 is a left side view thereof.

FIG. 5 is a right side view thereof.

FIG. 6 is a top plan view thereof.

FIG. 7 is a bottom plan view thereof.

FIG. 8 is a bottom, front, right side perspective view thereof.

FIG. 9 is a top, front, right side perspective view thereof, the bottles are shown in broken lines for illustrative purposes only and form no part of the claimed design.

FIG. 10 is a top, front, right side perspective view thereof, it being understood the claim is directed only to the design for the portions of the storage case that are shown, the appearance of any portion of the article between the break lines forms no part of the claimed design.

FIG. 11 is a front view of FIG. 10.

FIG. 12 is a rear view of FIG. 10.

FIG. 13 is a left side view of FIG. 10.

FIG. 14 is a right side view of FIG. 10.

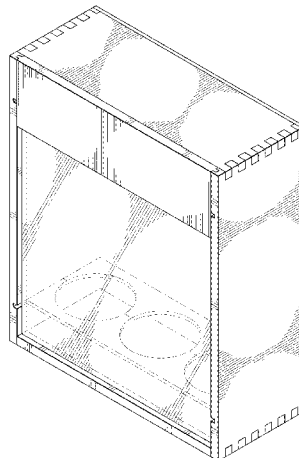
FIG. 15 is a top plan view of FIG. 10.

FIG. 17 is a bottom, front, right side view of FIG. 10; and, FIG. 18 is a top, front, right side view of FIG. 10, the bottles are shown in broken lines for illustrative purposes only and form no part of the claimed design.

Reference is made to the drawings for an appreciation of the features of the box, including but not limited to a front panel having an area comprising a non-transparent header member, below which extends a transparent member, the transparent member comprising a majority of the area of the front panel and presenting visibility to the box interior and of a bottom bottle support member suspended above the bottom of the box.

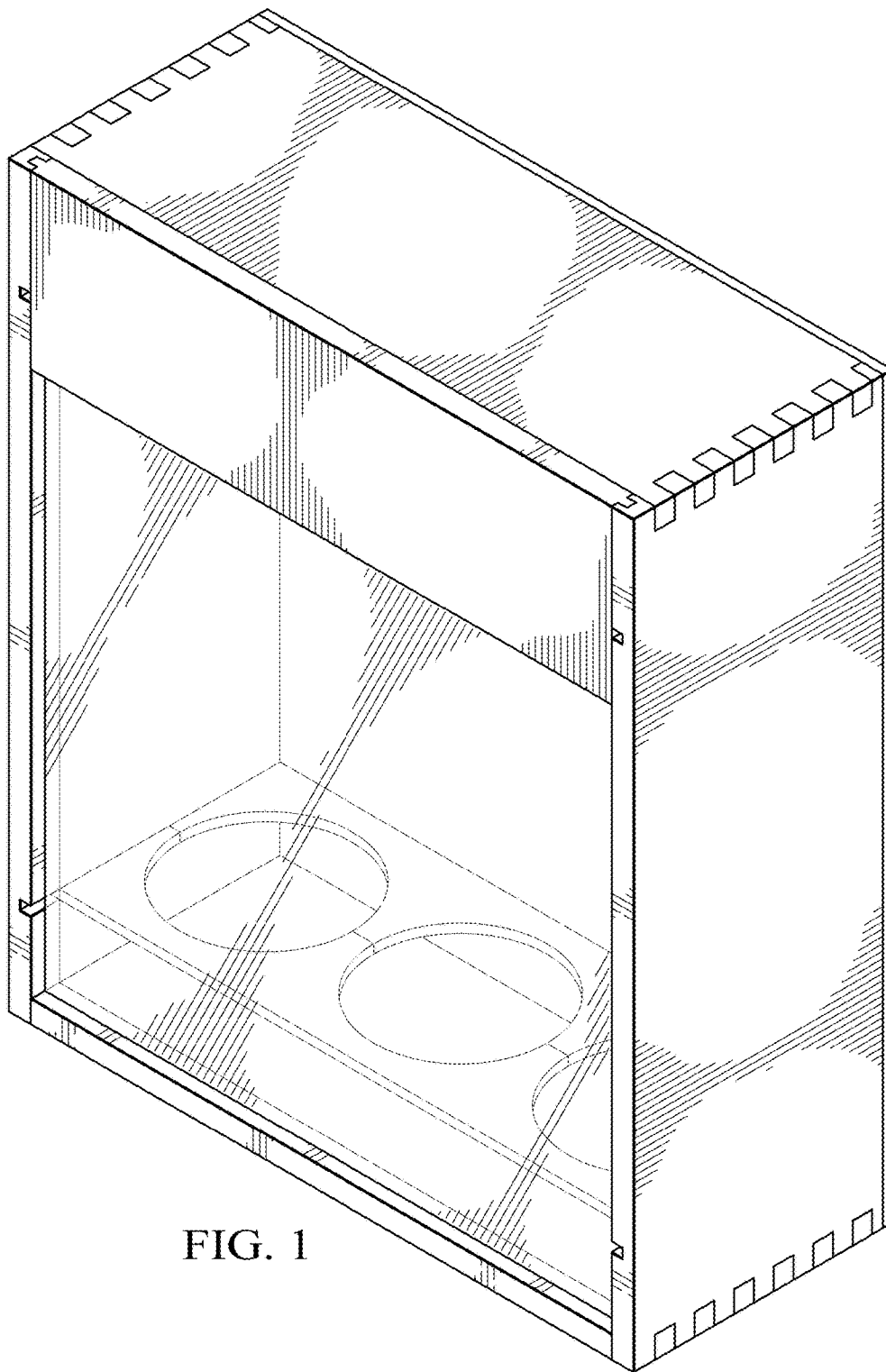

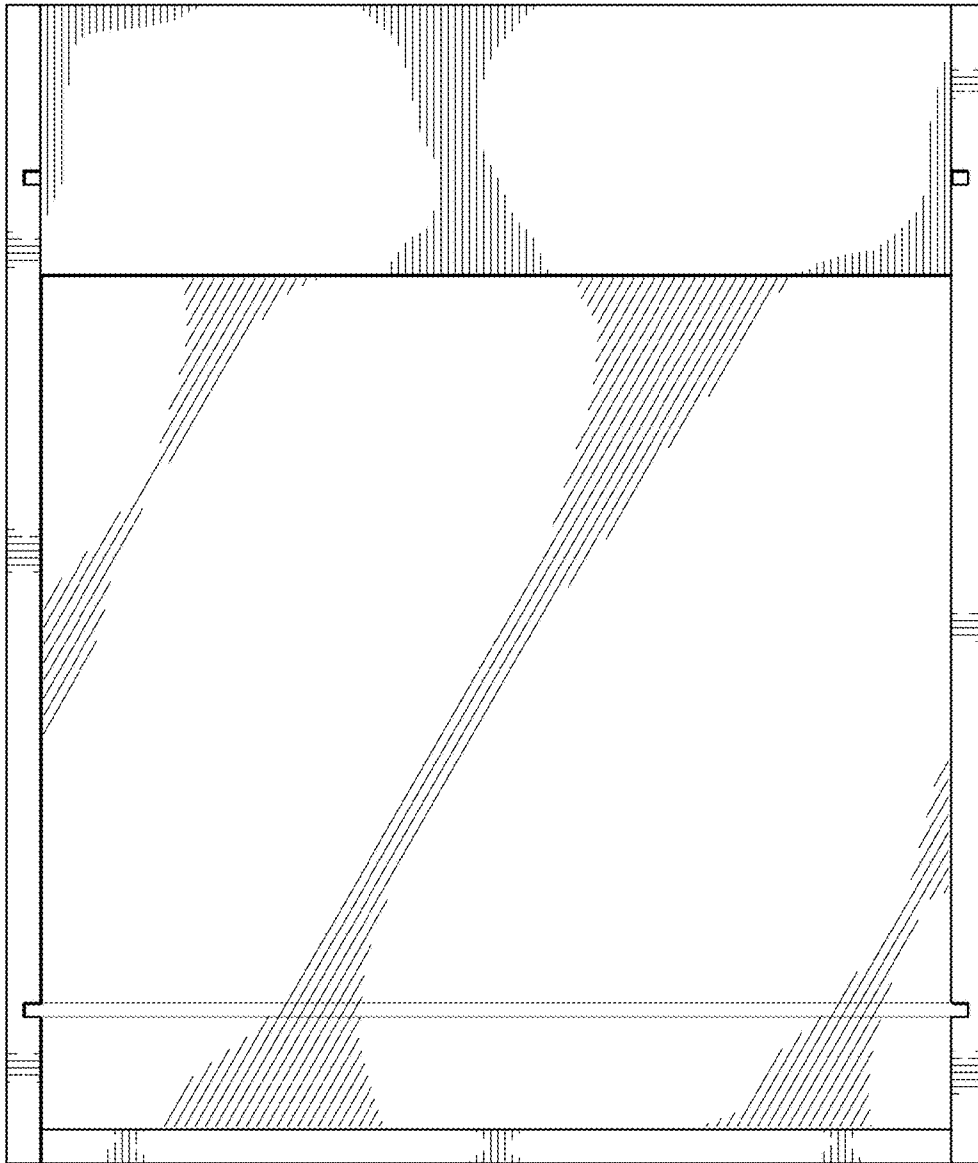

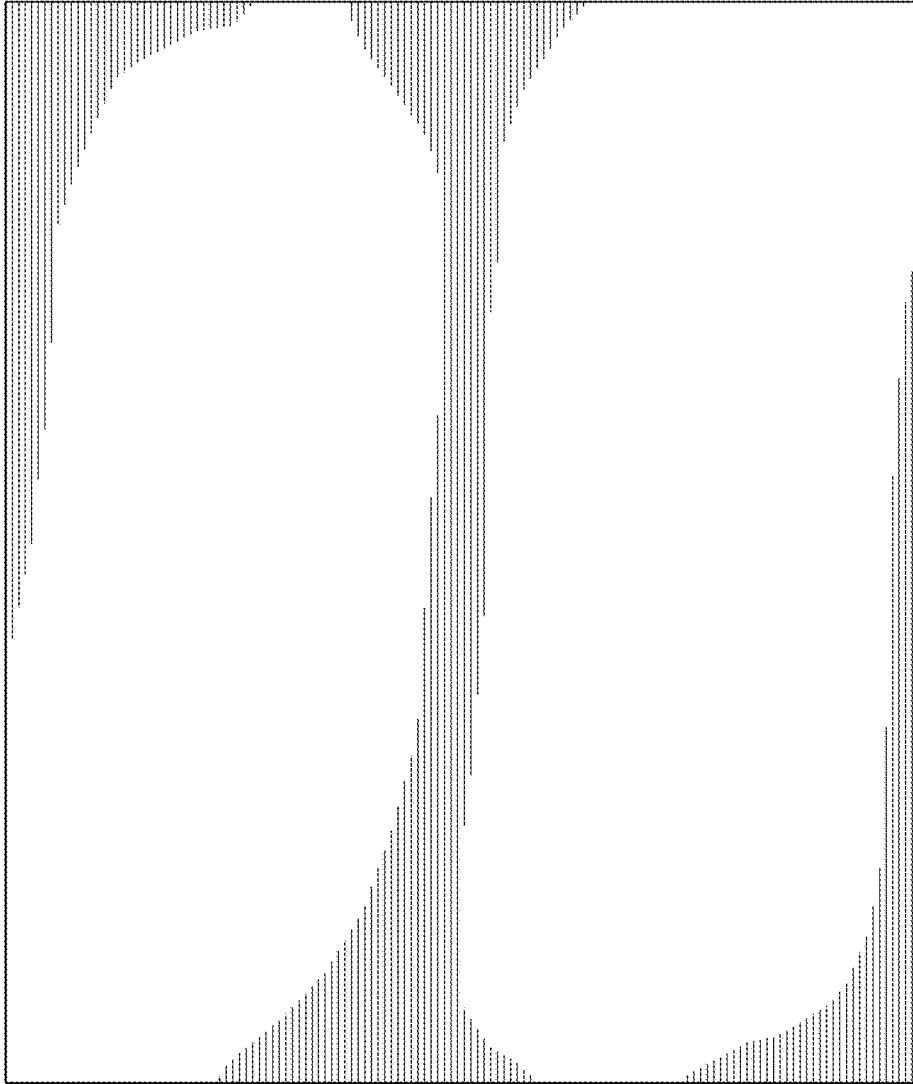

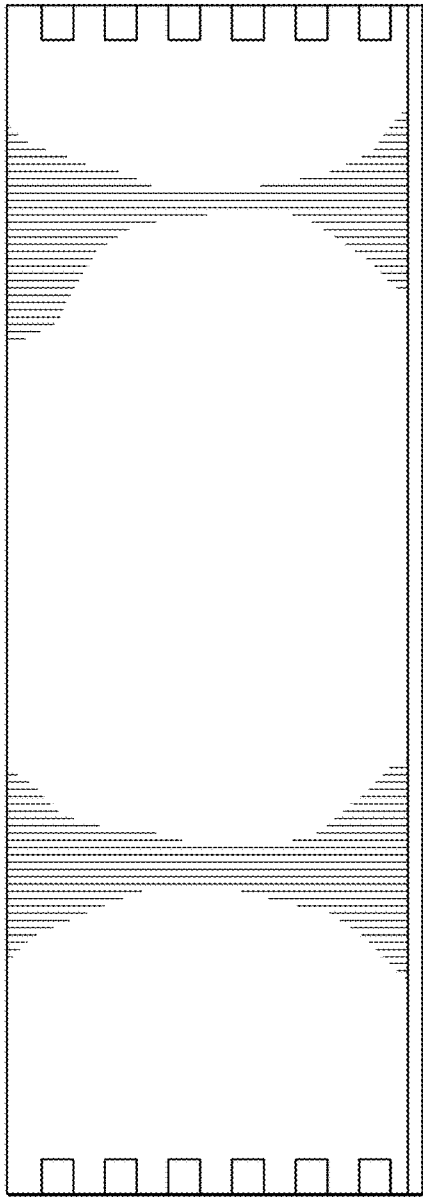

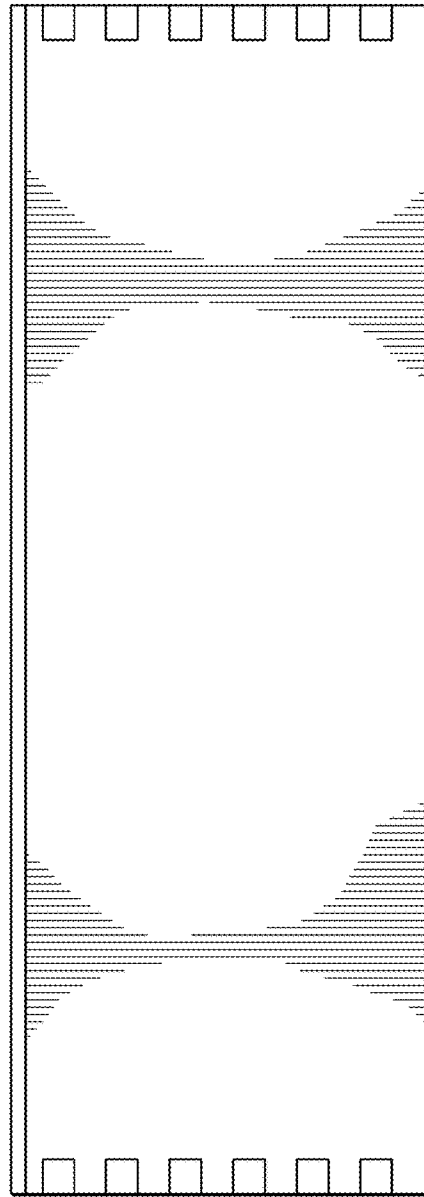

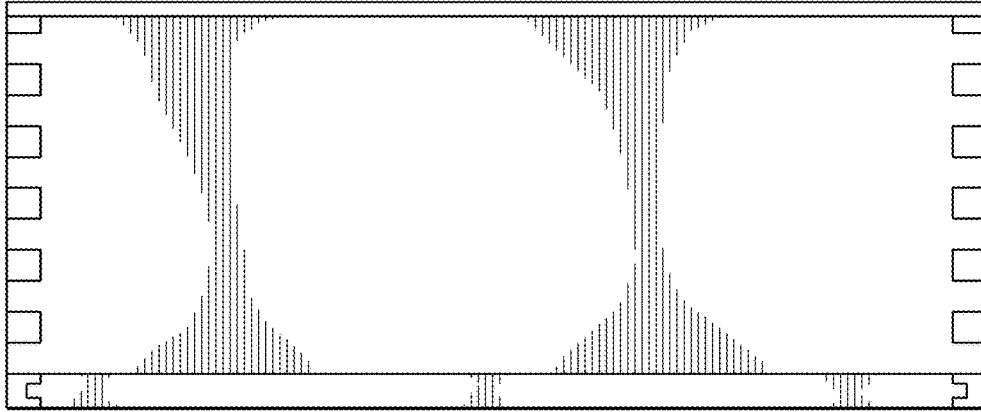

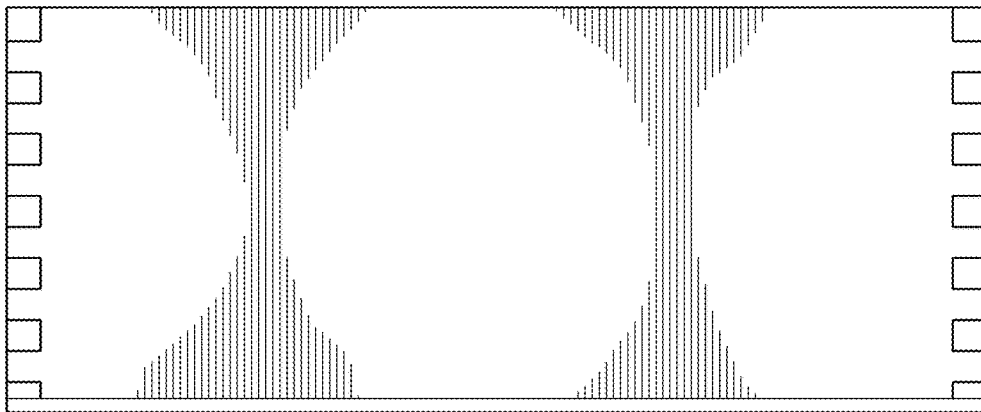

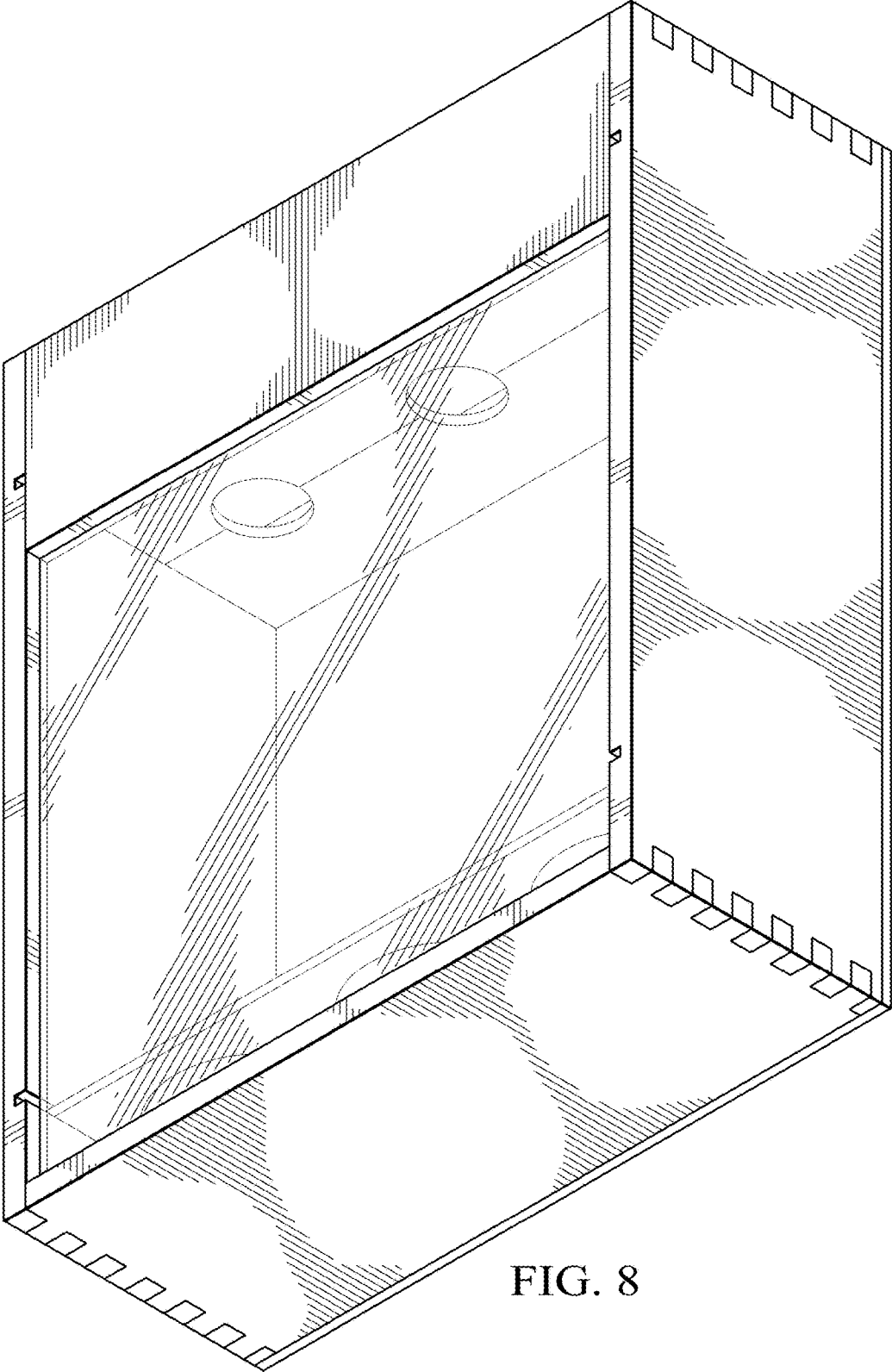

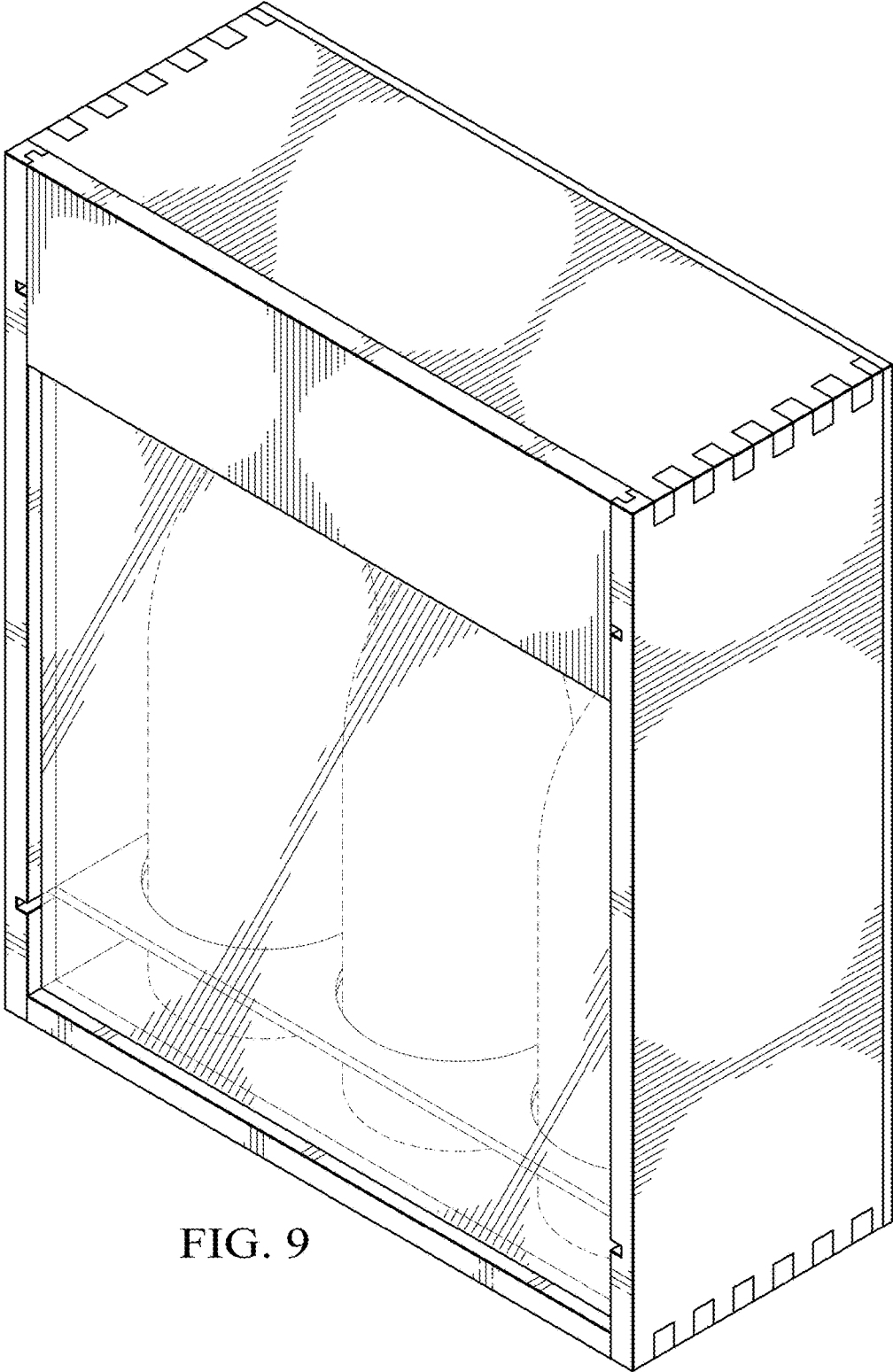

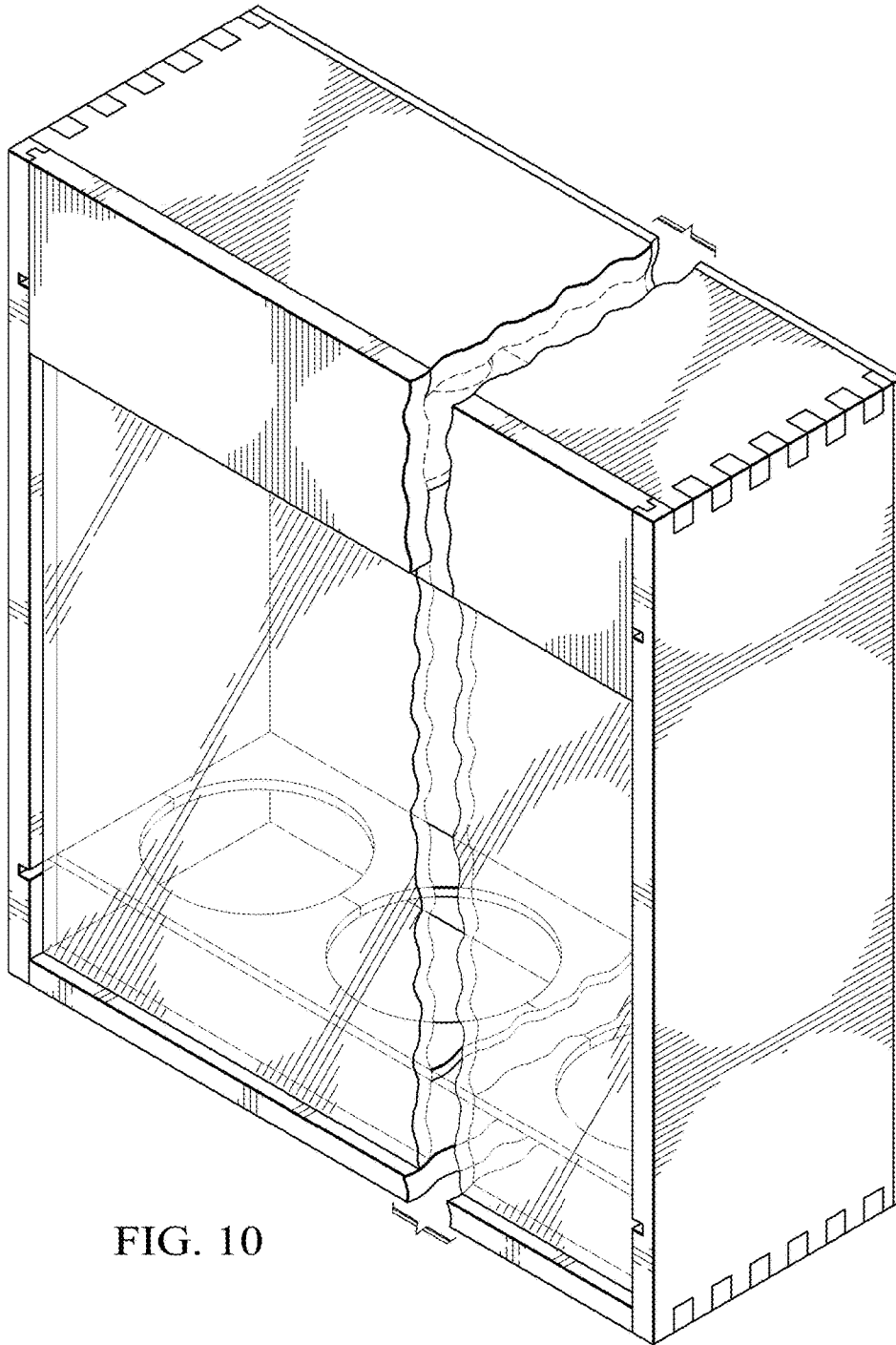

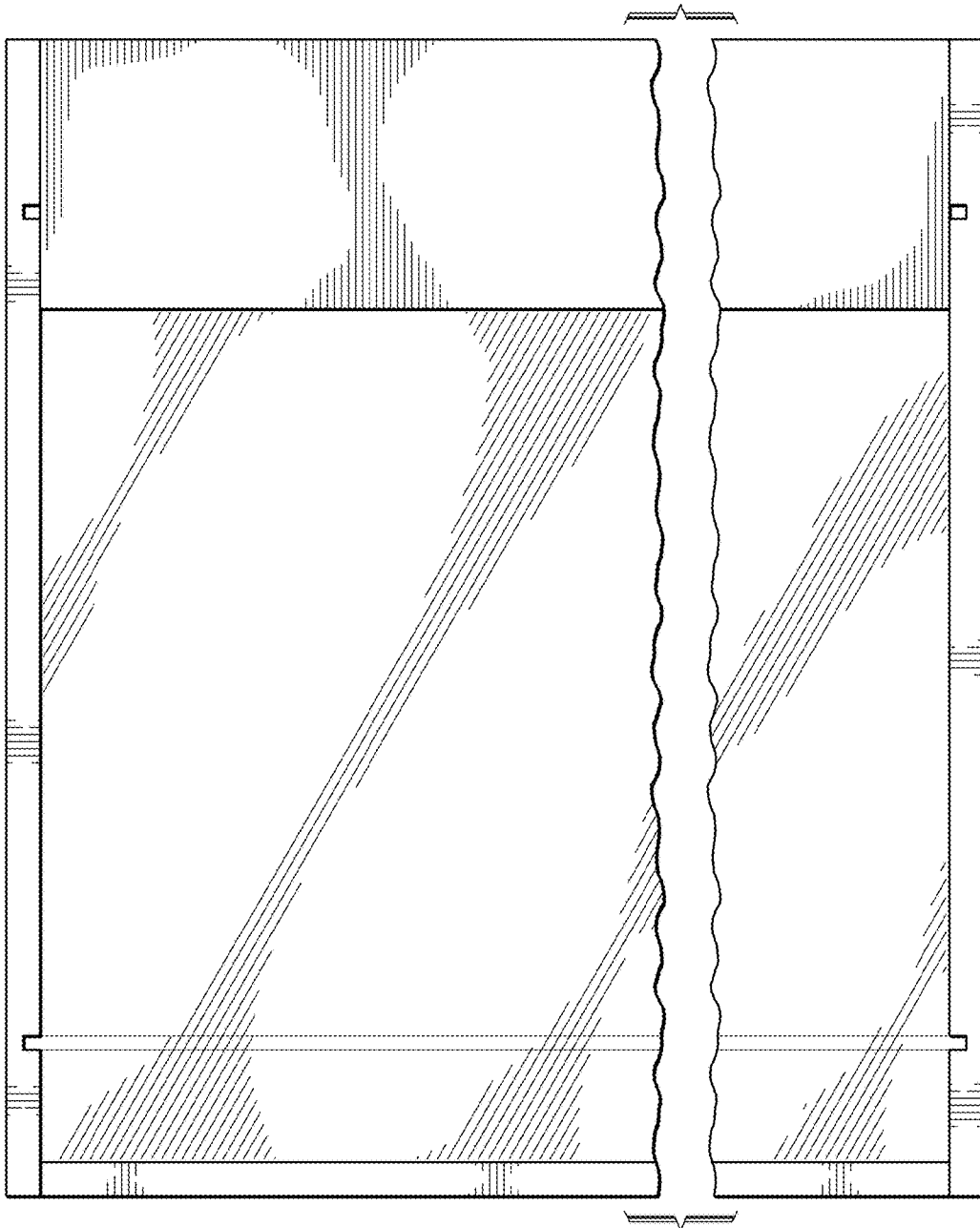

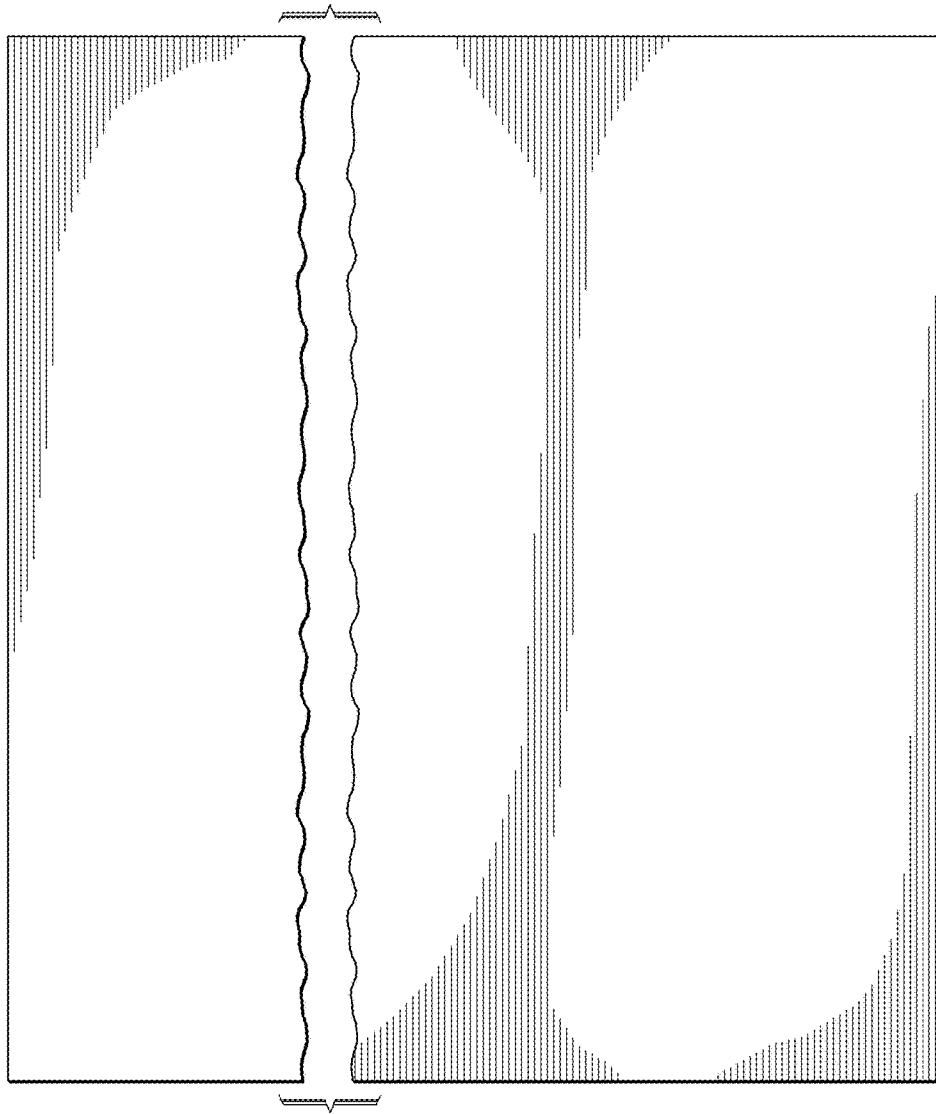

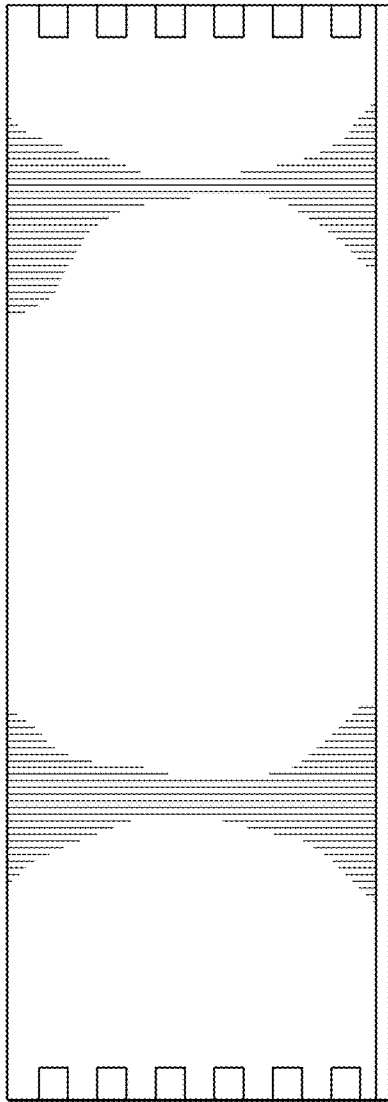

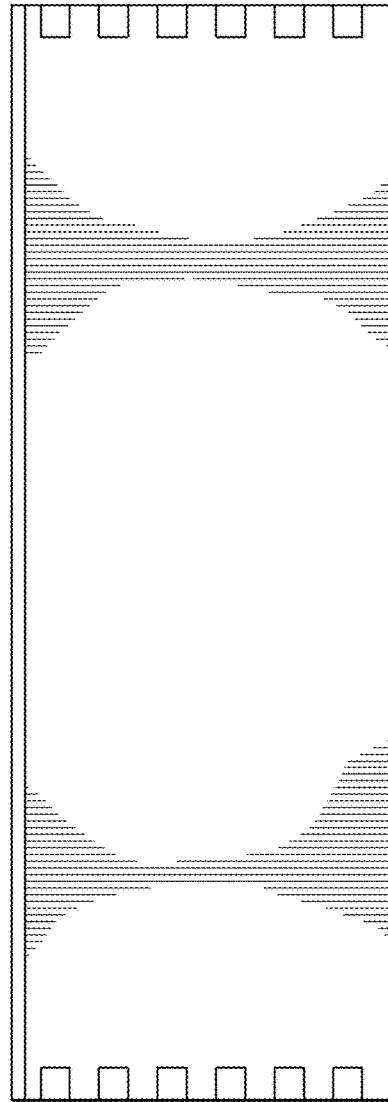

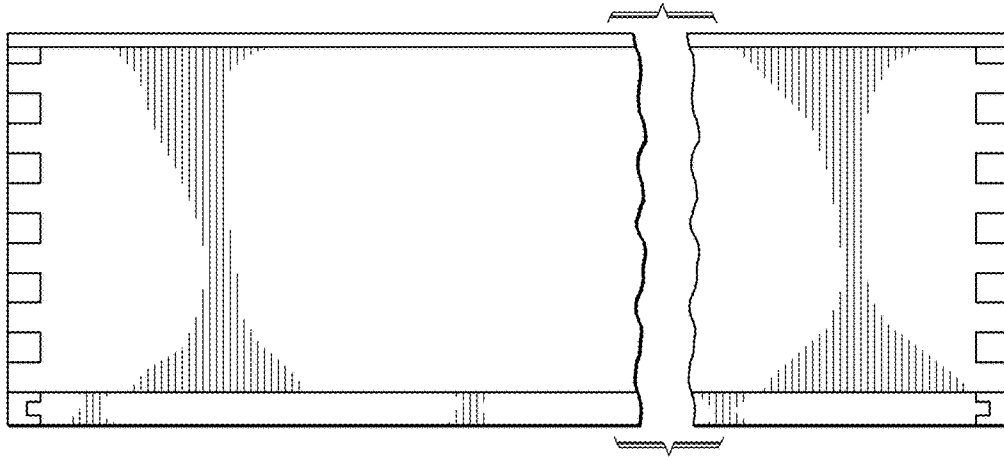

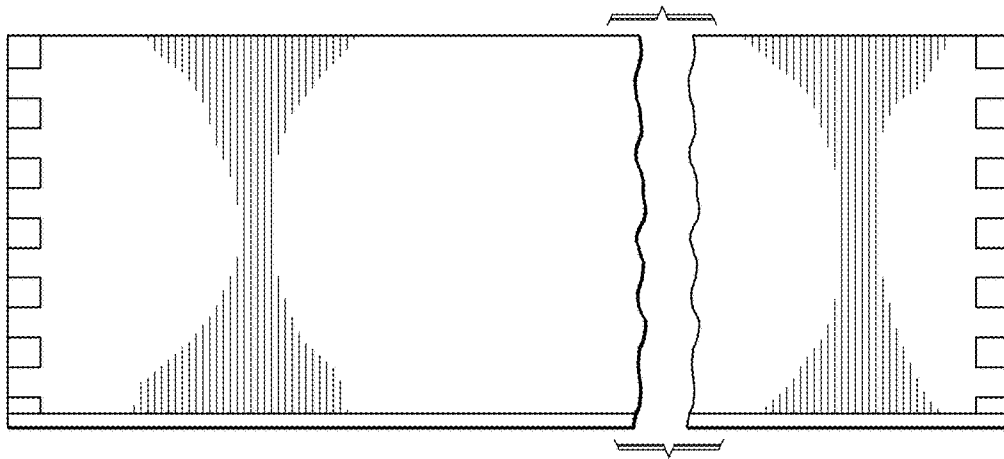

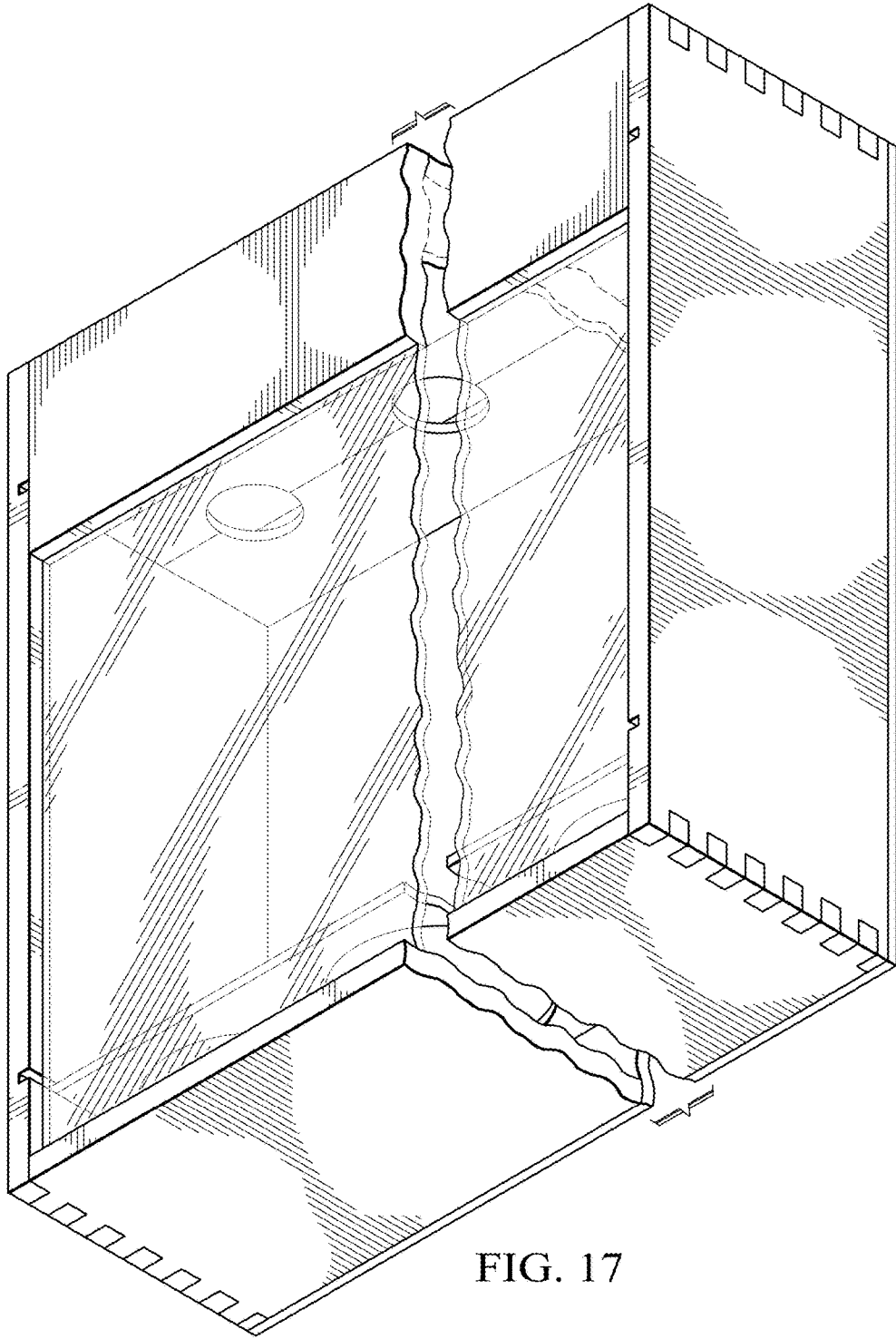

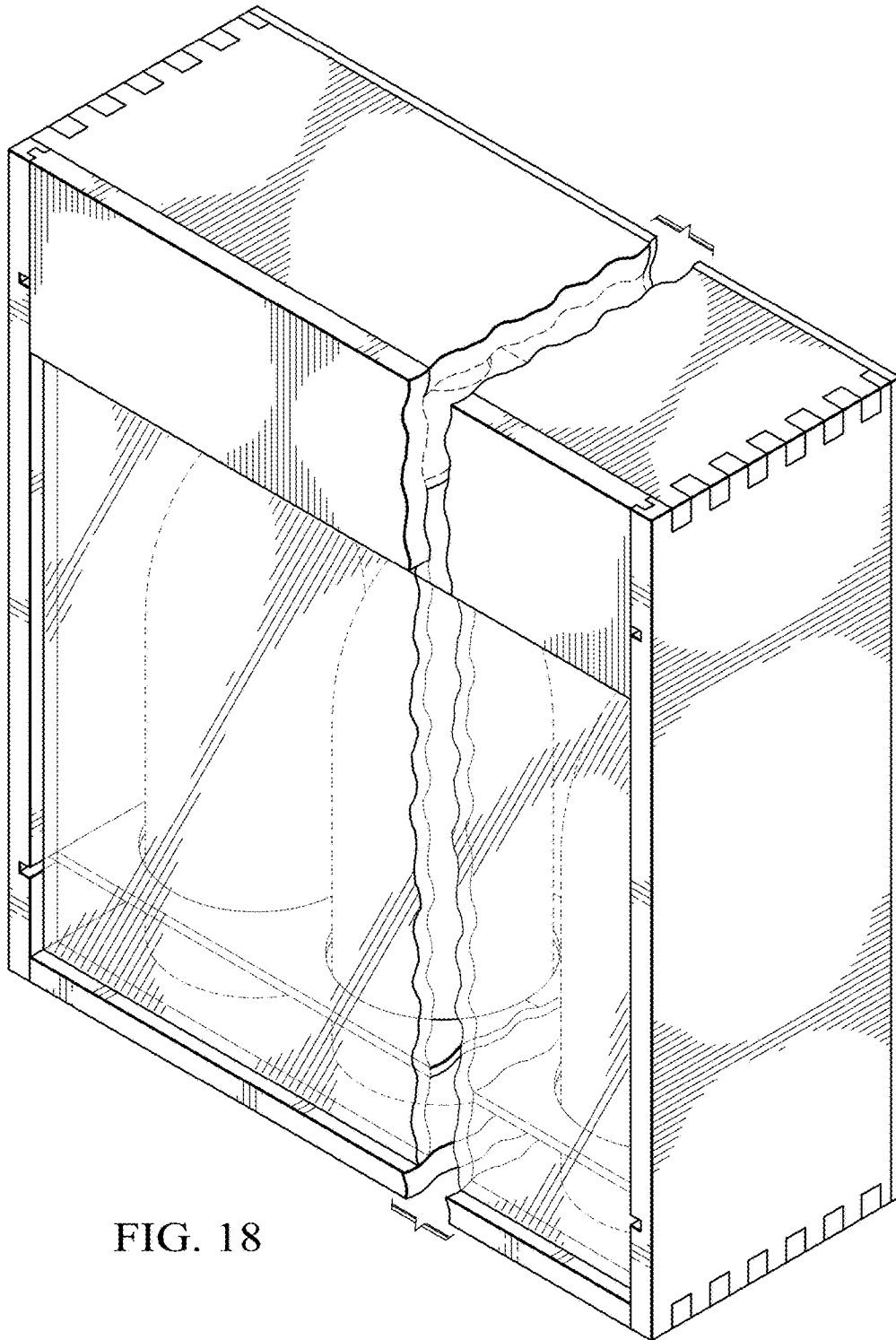
