DESCRIPTION

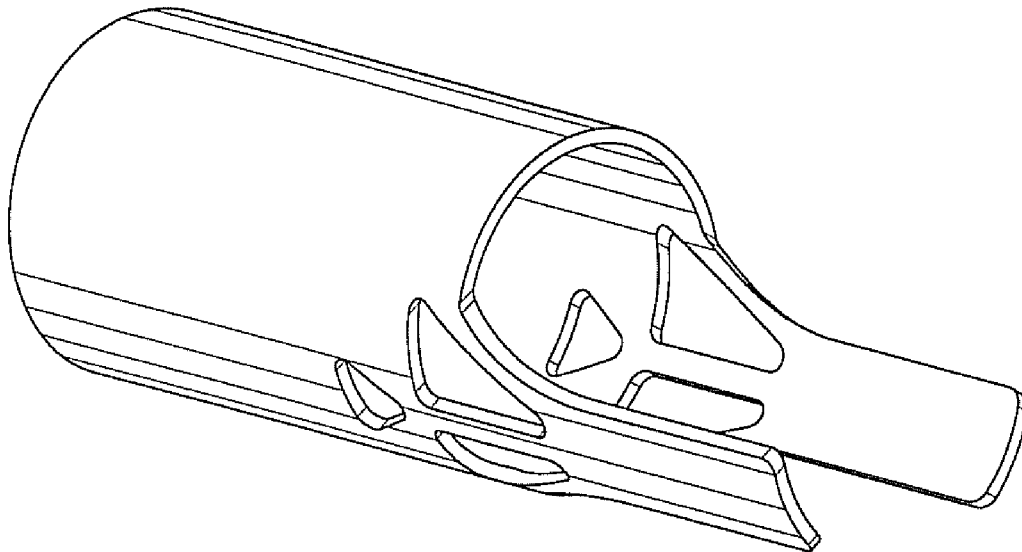
FIG. 1 is a perspective view of my design for a prosthetic tissue valve;

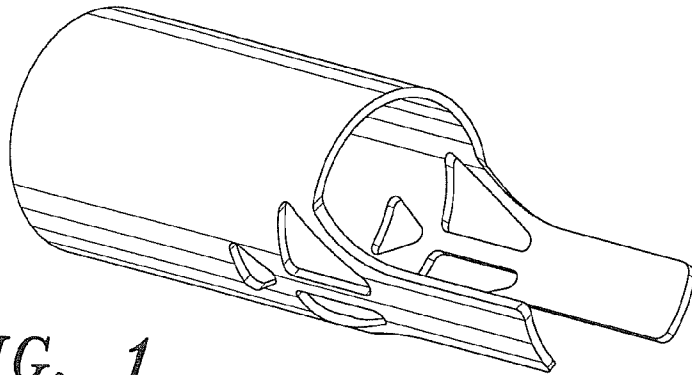

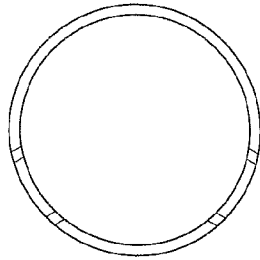

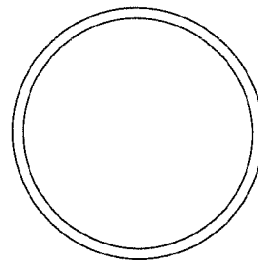

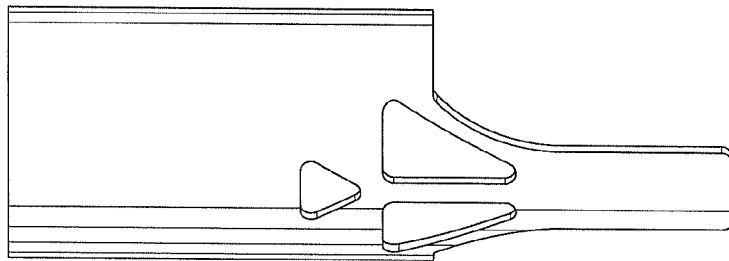

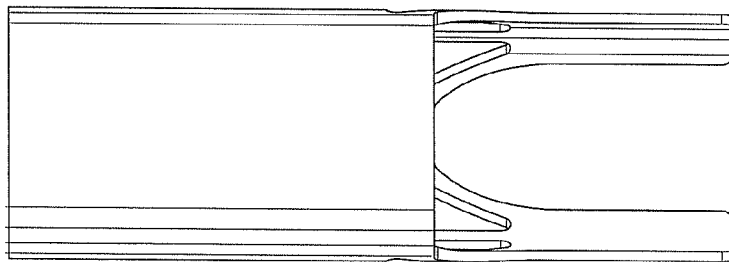
