FIG. 1 is a front view of a finger nail trimmer showing the new design;


FIG. 2 is a back view of the finger nail trimmer shown in FIG. 1;


FIG. 3 is a left side view of the finger nail trimmer shown in FIG. 1, wherein the right side view is a mirror image thereof;

FIG. 4 is a top view of the finger nail trimmer shown in FIG. 1; and,


FIG. 5 is bottom view of the finger nail trimmer shown in FIG. 1.




