DESCRIPTION

FIG. 1 is a top, front, and right side perspective view of the bottle of the claimed design;

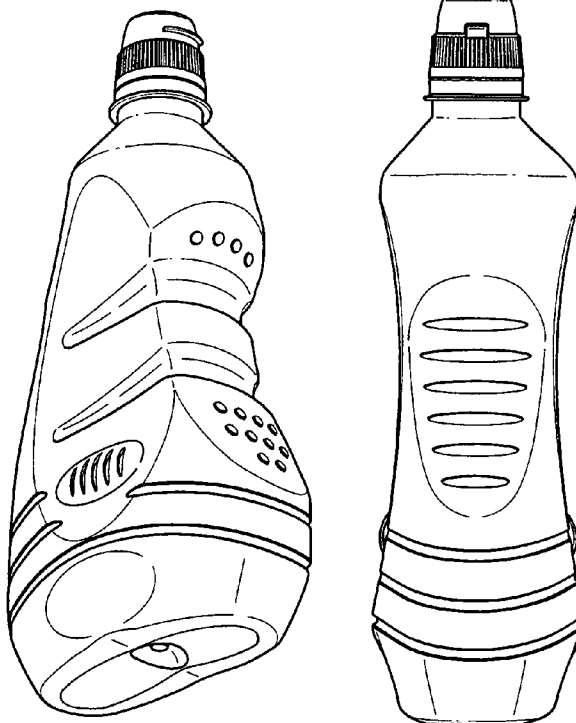

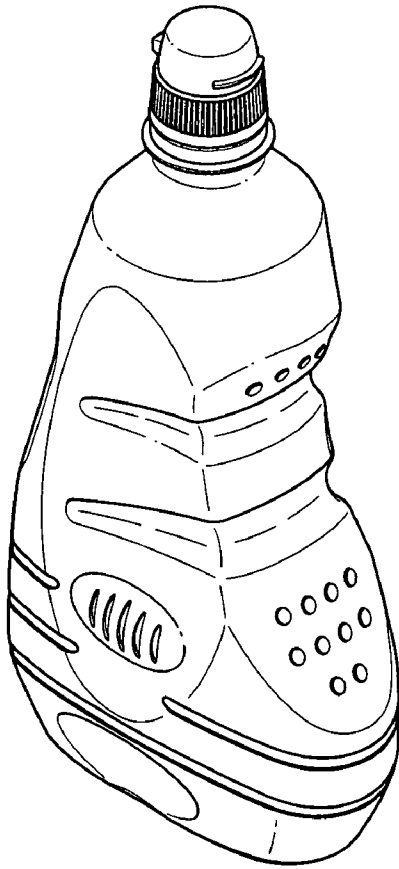
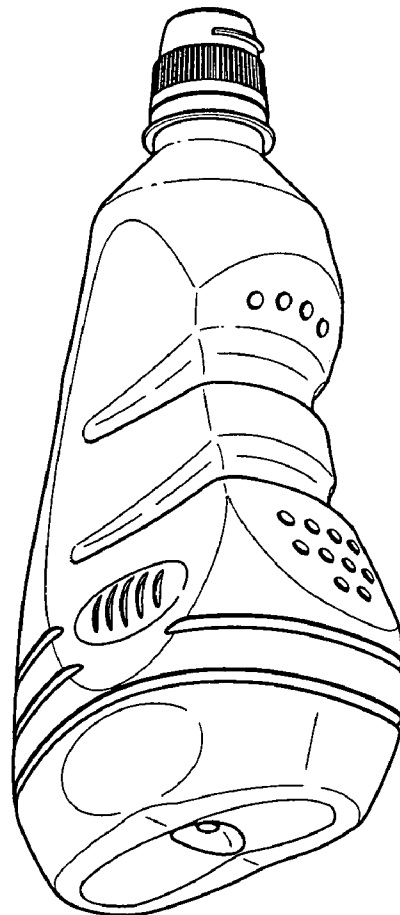

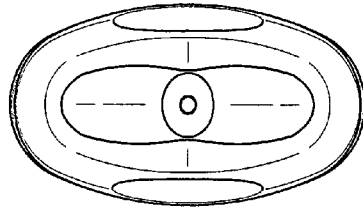

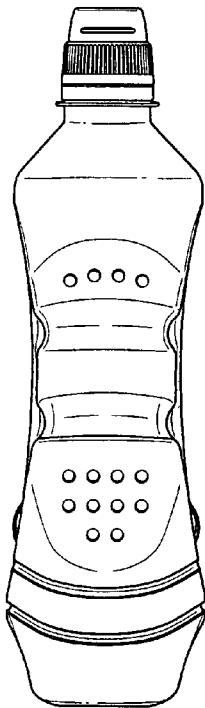

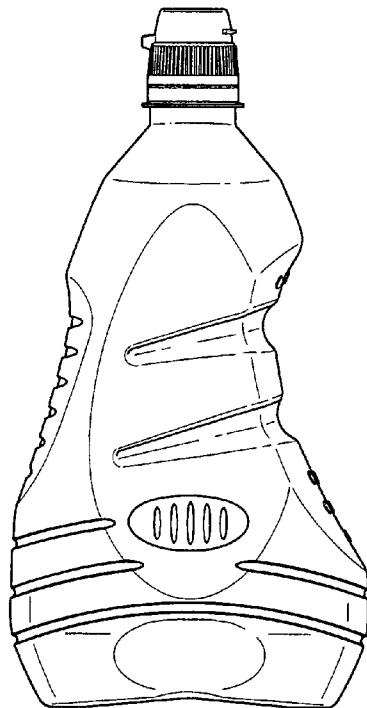

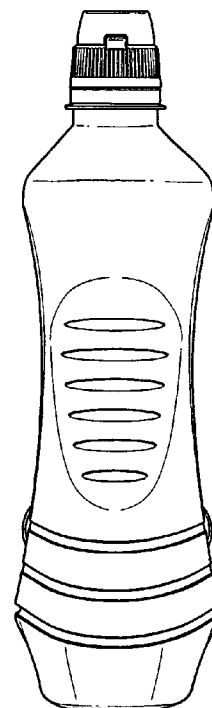

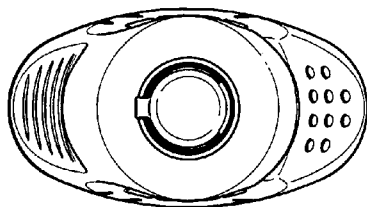
