The ornamental design for a combination ceiling fan and light fixture, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view from below of the combination ceiling fan and light fixture in accordance with my design. FIG. 2 is a front elevation view of the combination ceiling fan and light fixture in accordance with my design;

FIG. 3 is a side elevation view of the combination ceiling fan and light fixture in accordance with my design;

FIG. 4 is an enlarged side elevation view of the combination ceiling fan and light fixture in accordance with my design; FIG. 5 is an enlarged front elevation of the combination ceiling fan and light fixture in accordance with my design; FIG. 6 is an enlarged bottom plan view of the combination ceiling fan and light fixture in accordance with my design; FIG. 7 is an enlarged top plan view of the combination ceiling fan and light fixture in accordance with my design;


FIG. 8 is a bottom plan view of the combination ceiling fan and light fixture in accordance with my design; and,

FIG. 9 is a top plan view of the combination ceiling fan and light fixture in accordance with my design.

The front and rear elevations are identical except for the position of the blades.













