

CLAIM

The ornamental design for a [set of control knobs] combination of upright and handrail supports, as shown and described.

DESCRIPTION

[FIG. 1 is a front perspective view of a set of control knobs in which environment comprising a treadmill is disclaimed;]

[FIG. 2 is a back perspective view thereof;]

[FIG. 3 is a front view thereof;]

[FIG. 4 is a back view thereof;]

[FIG. 5 is a left-side view thereof;]

[FIG. 6 is a right-side view thereof;]

[FIG. 7 is a top view thereof;]

[FIG. 8 is a bottom view thereof;]

[FIG. 9 is an enlarged front perspective view of one of the control knobs with the disclaimed environment removed for clarity of disclosure. The claimed design includes the mirror image of the control knob depicted that is not shown;]

[FIG. 12 is an enlarged bottom view thereof;]









































