(57) **CLAIM**

The ornamental design for a display screen with an animated graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a display screen with animated graphical user interface, showing a first image the new design;

FIG. 2 is a second image thereof;

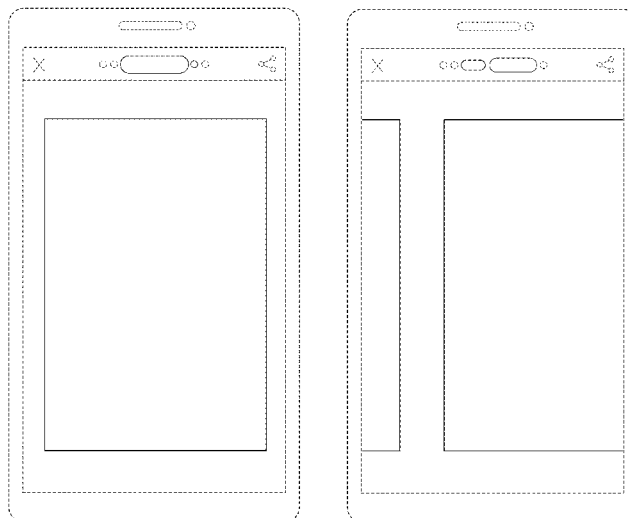
FIG. 3 is a third image thereof;

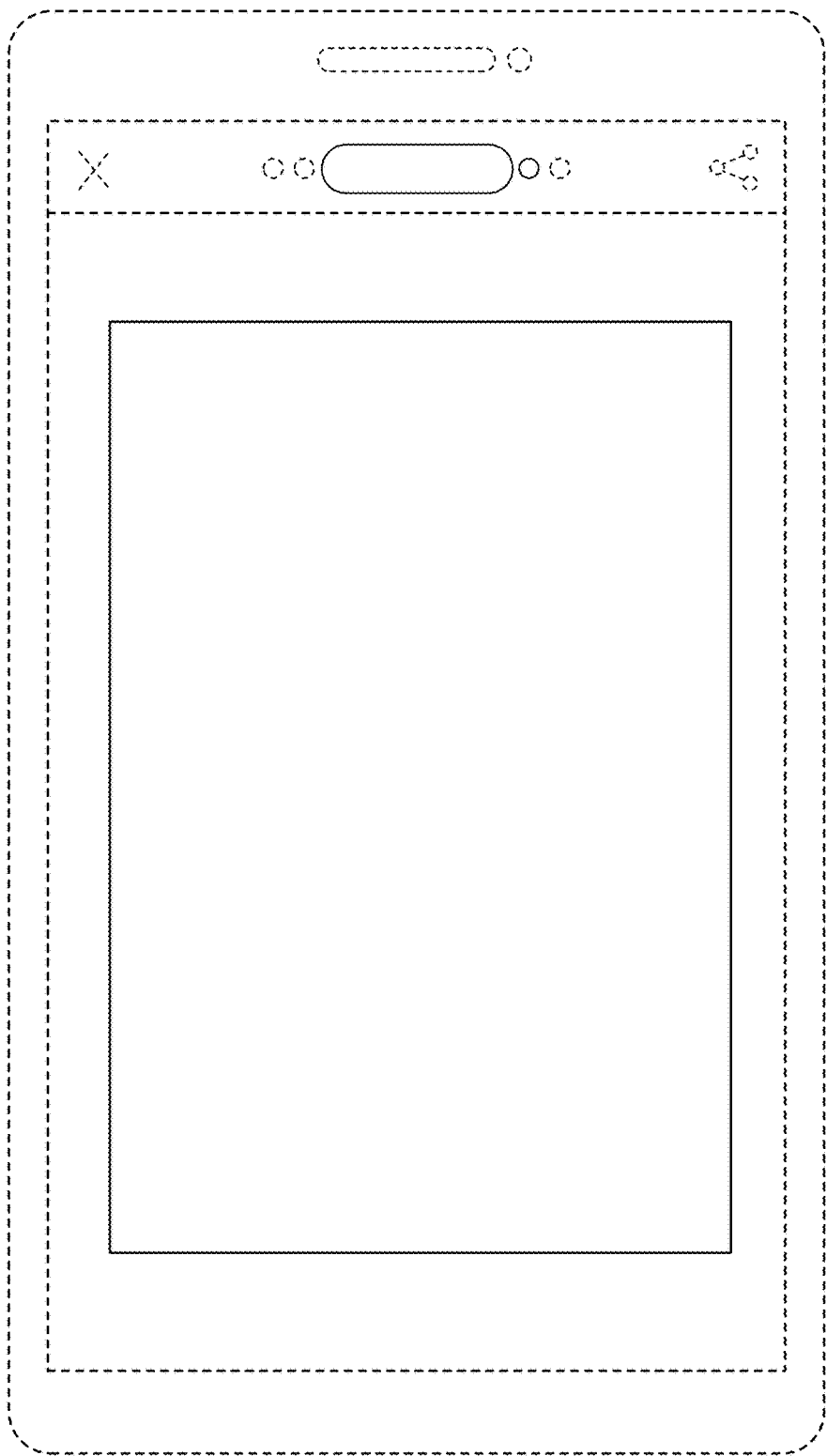

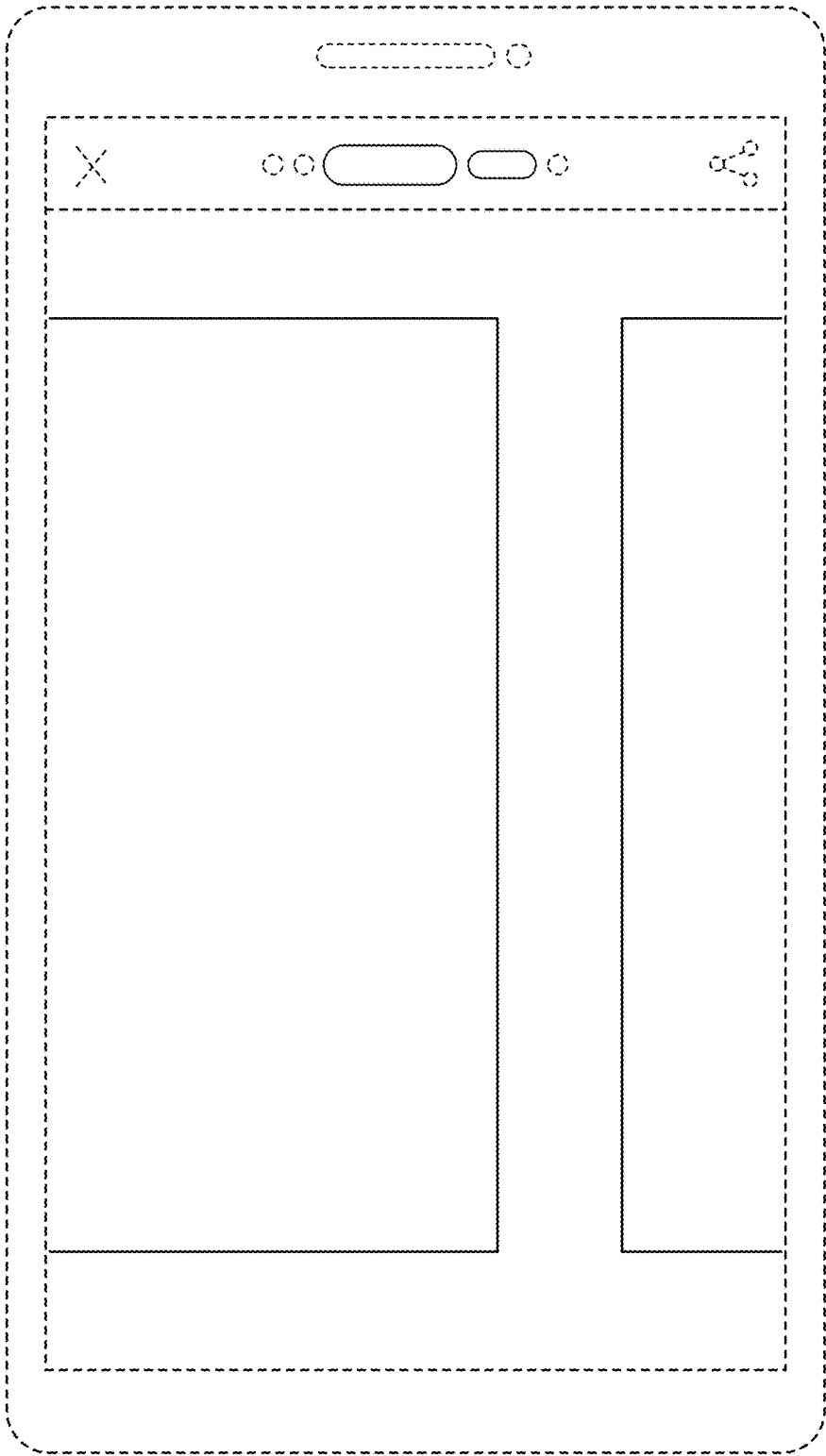

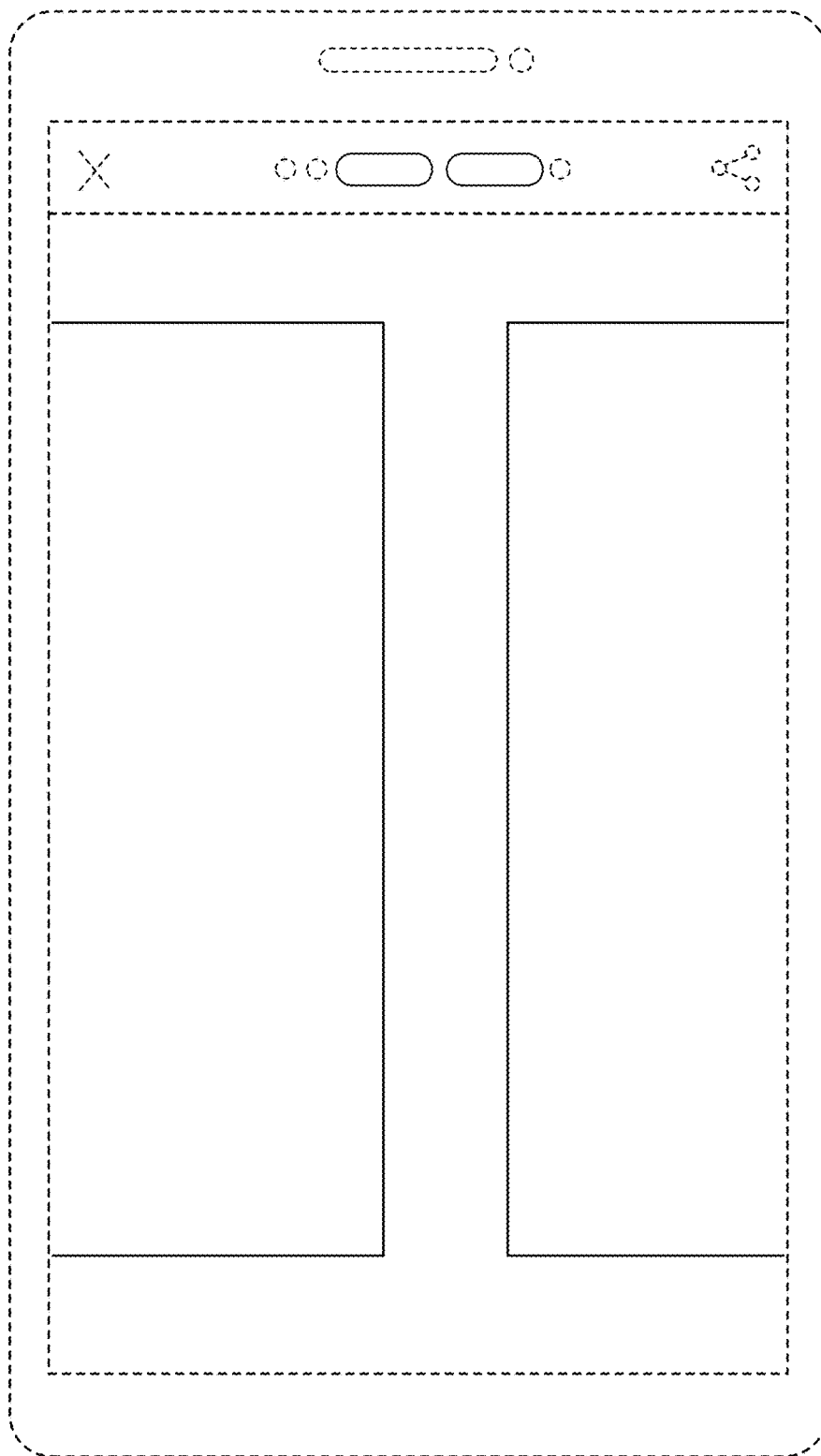

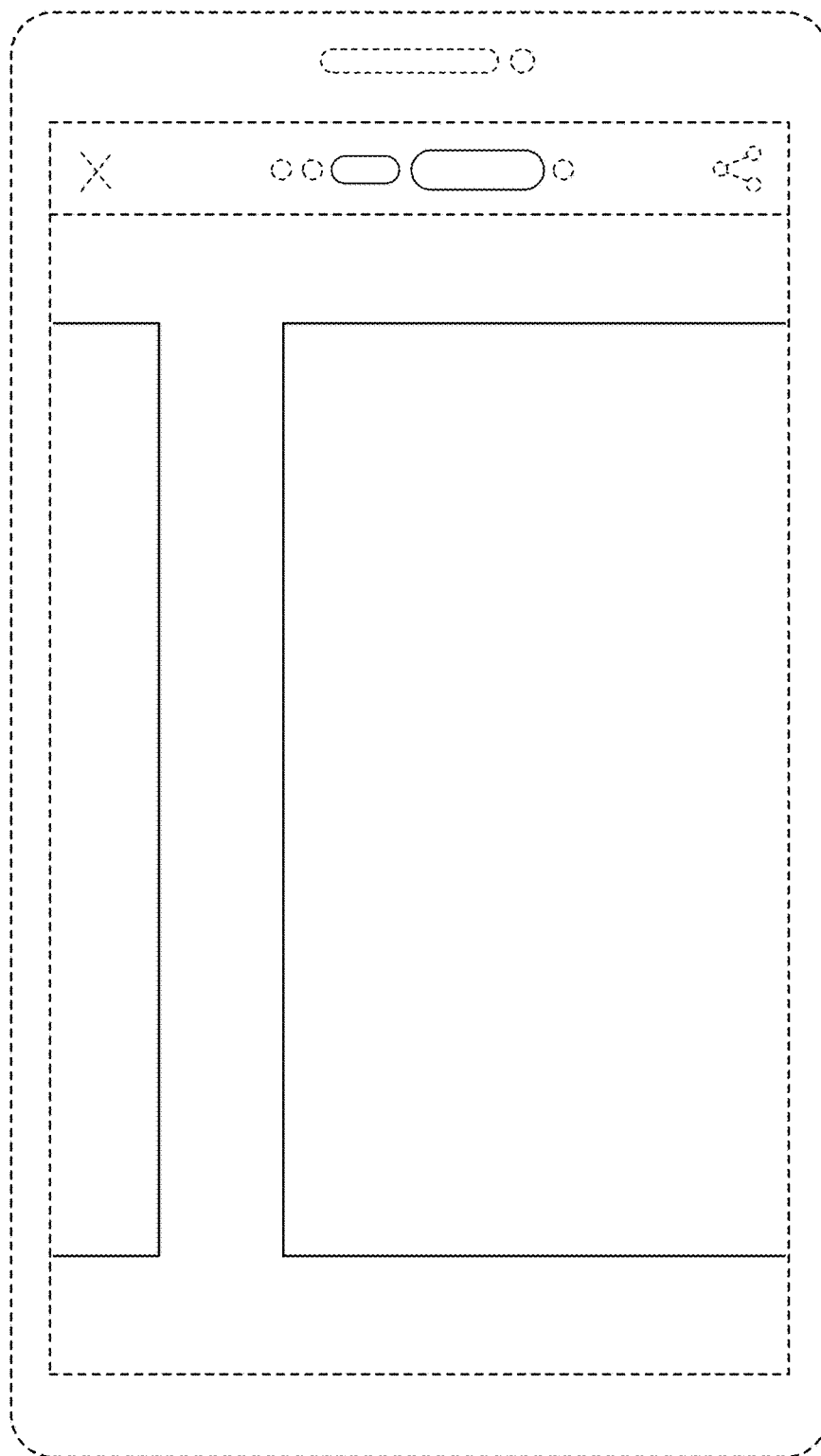

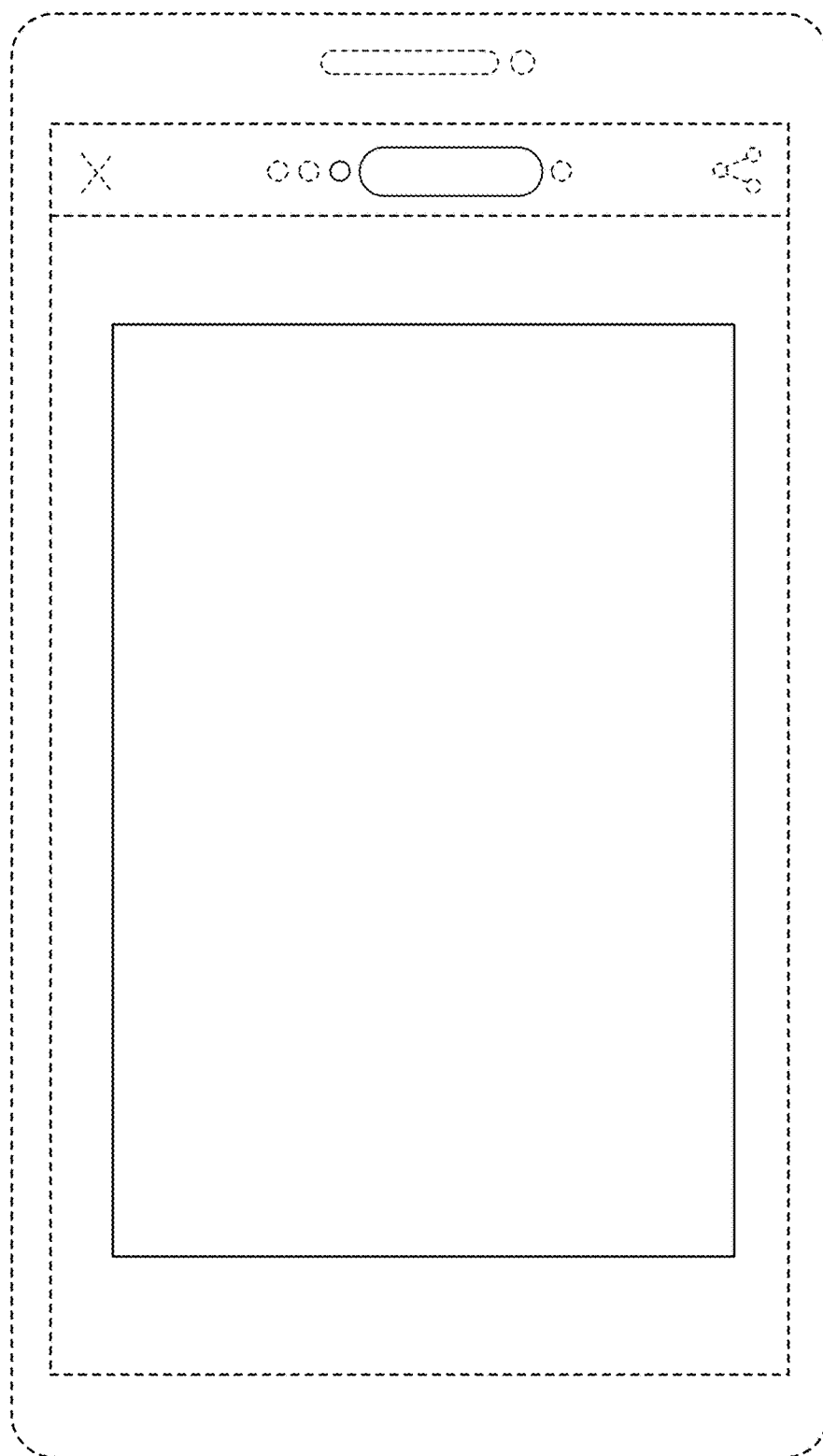
