
(57) **CLAIM**

We claim the ornamental design for a flavor shot pump, as shown.

DESCRIPTION

FIG. 1 is a top front left side perspective view of the first embodiment of a flavor shot pump showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a top plan view thereof; and, FIG. 6 is a top front left side perspective view of the second embodiment thereof.












