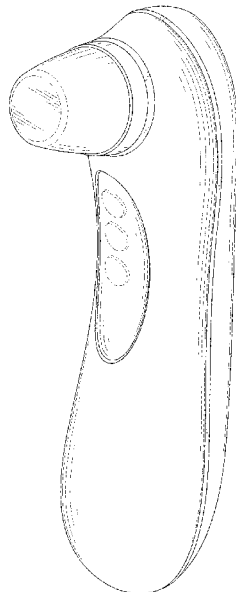
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a first perspective view of facial blemish removing device showing my new design;

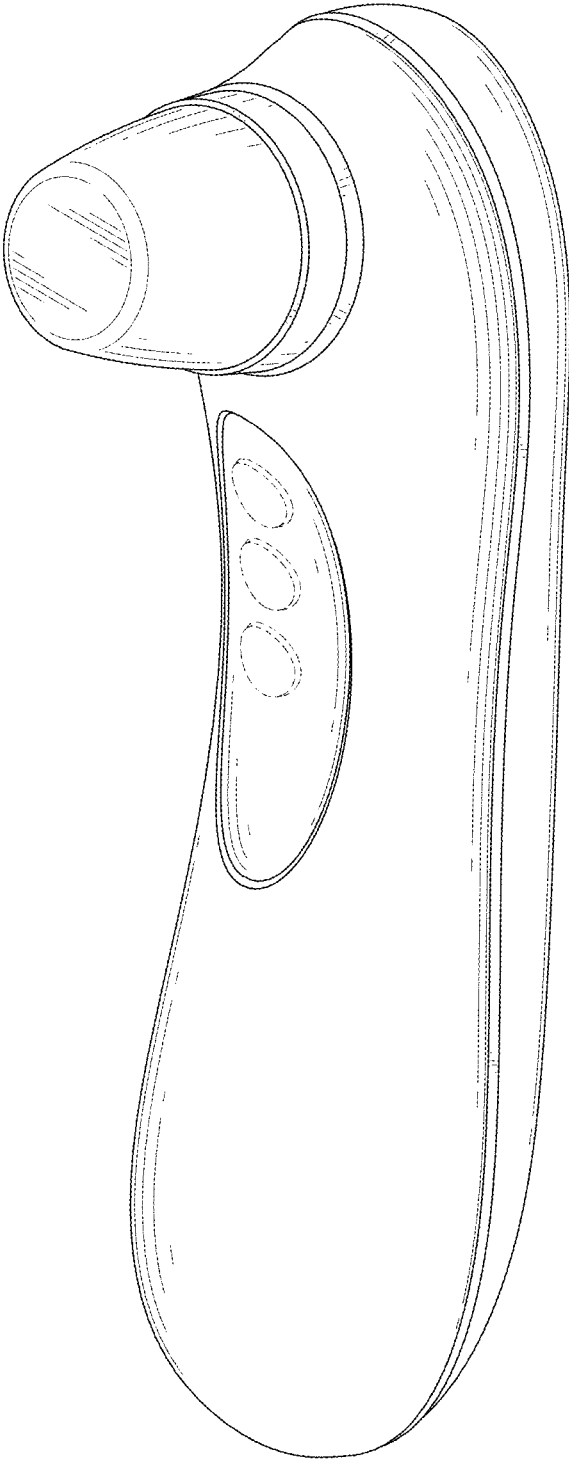

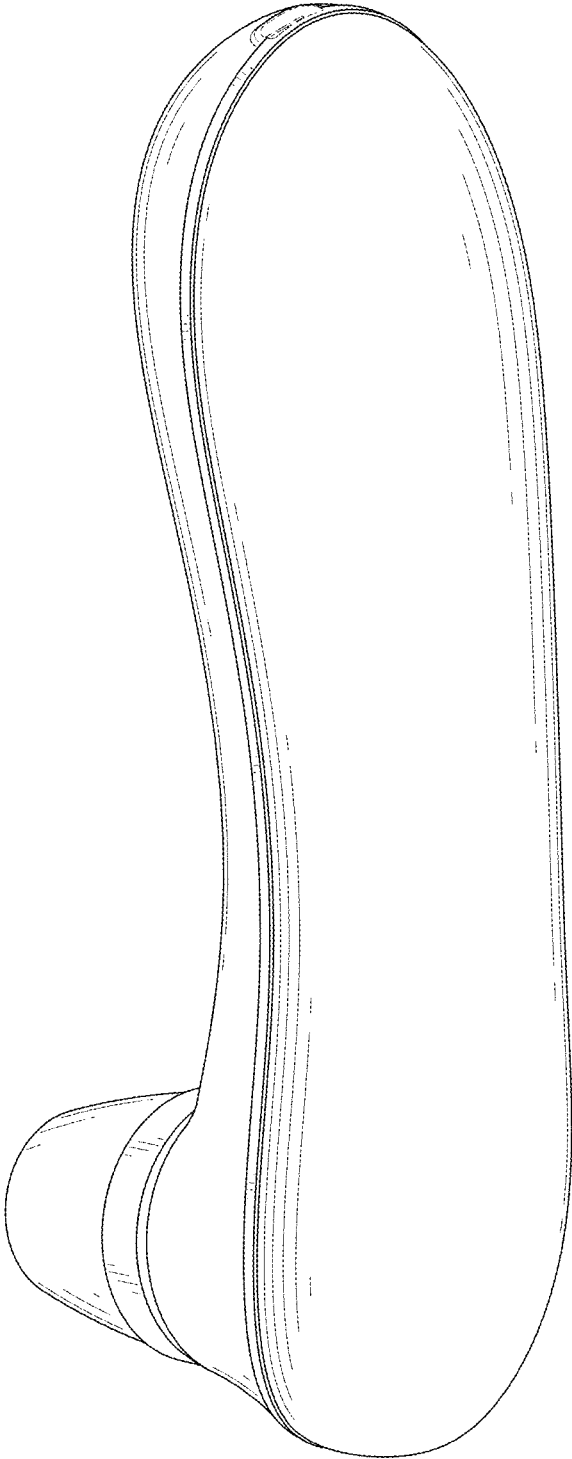

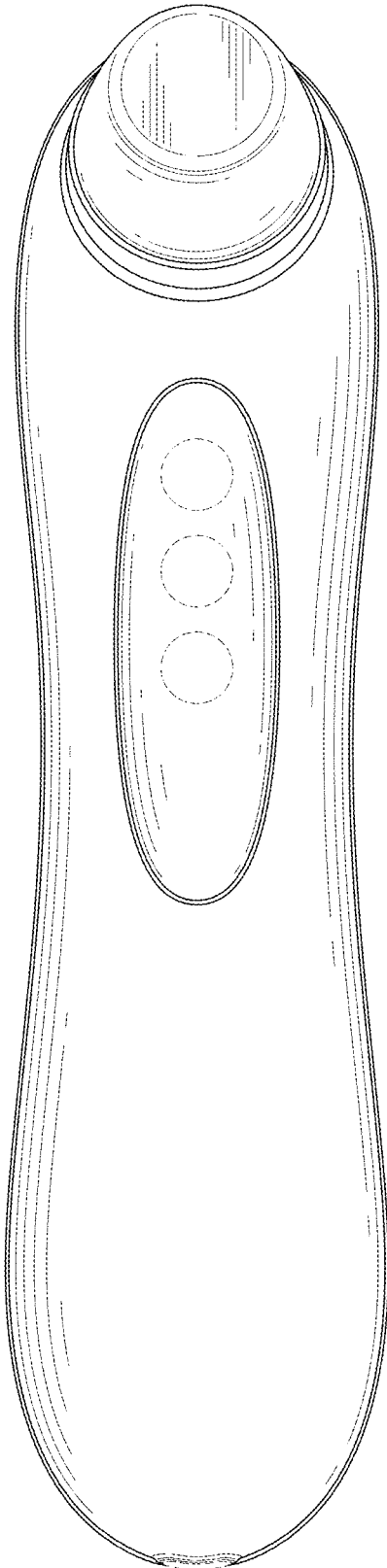

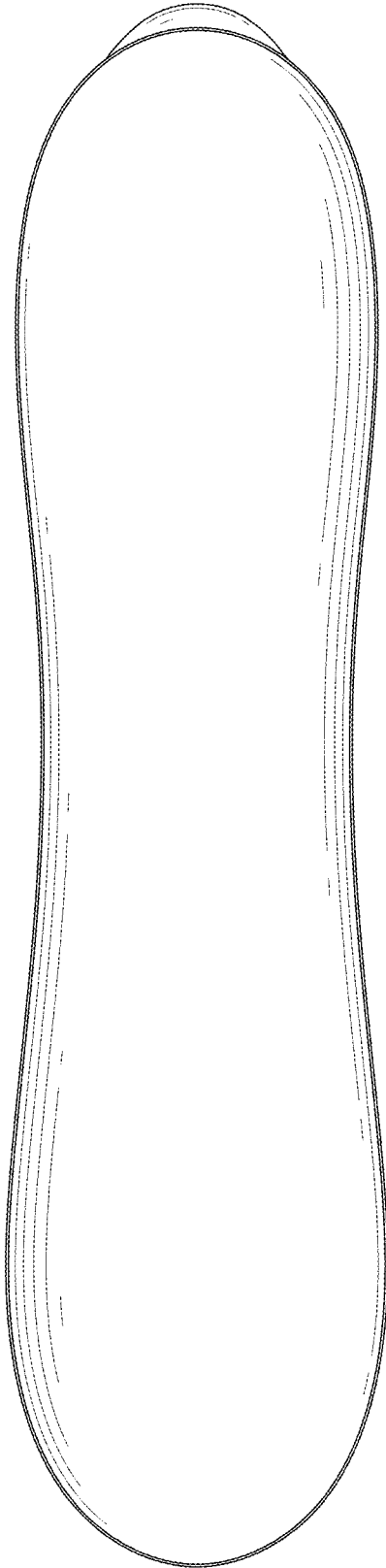

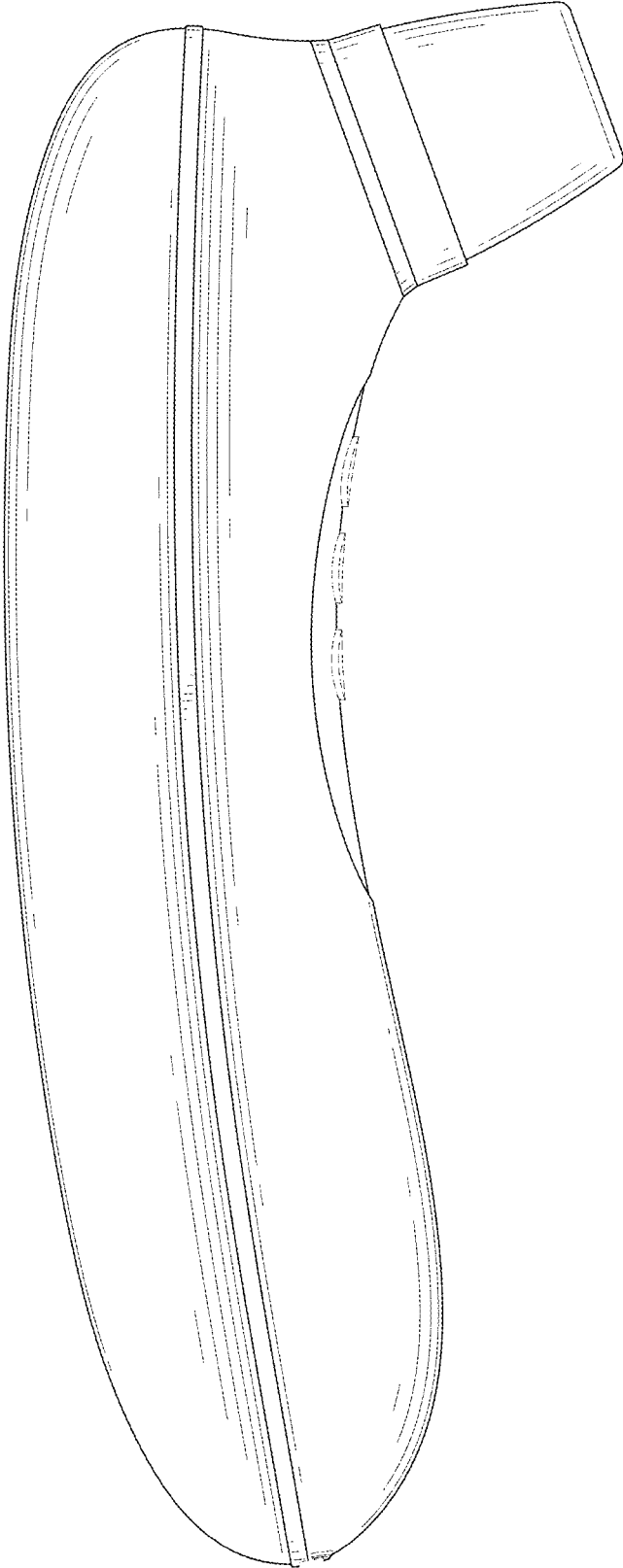

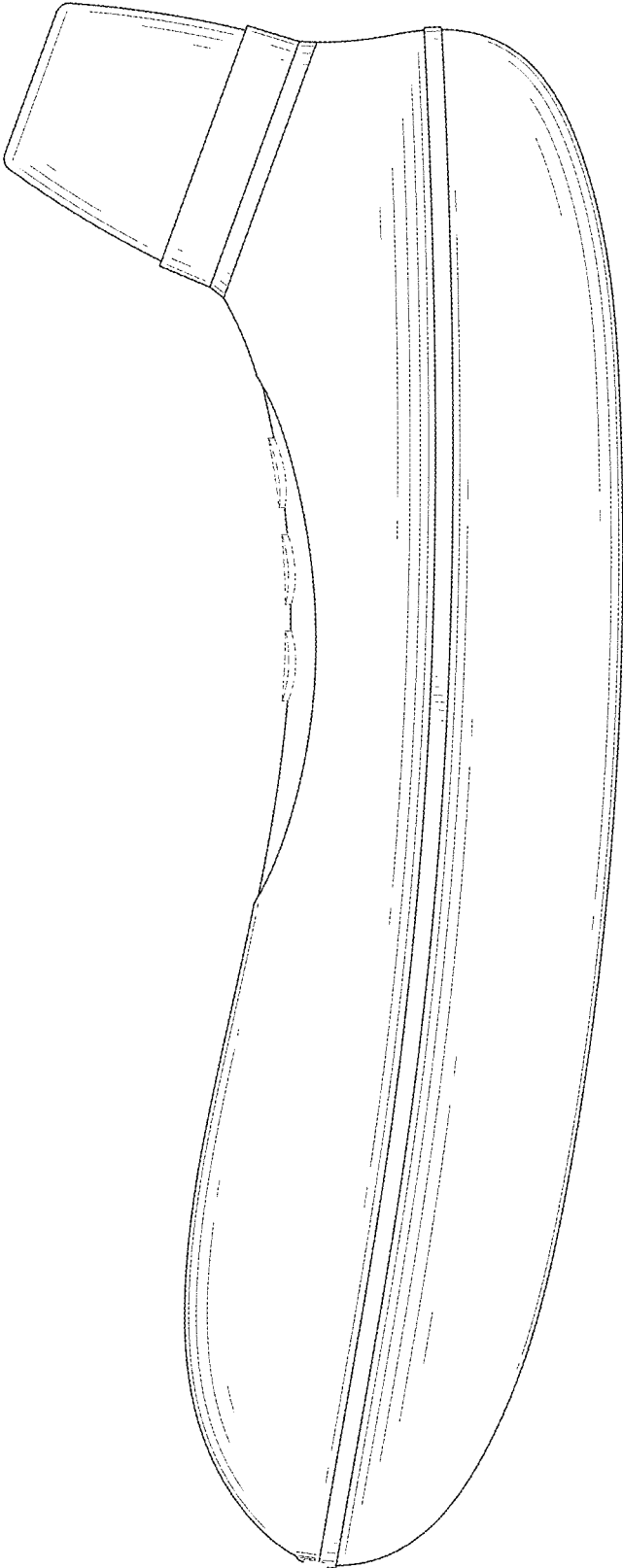

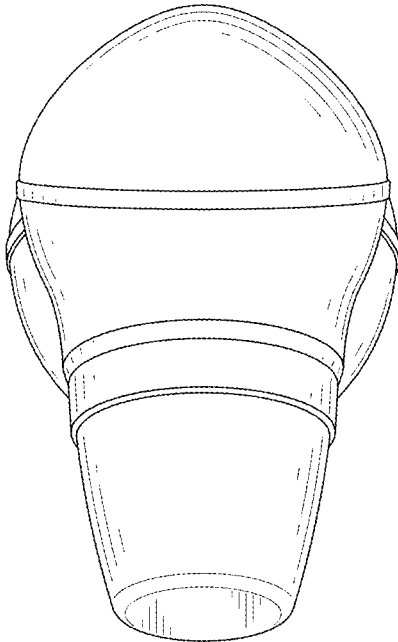

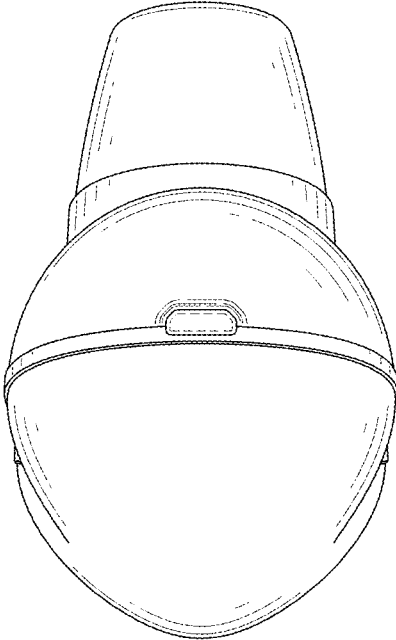

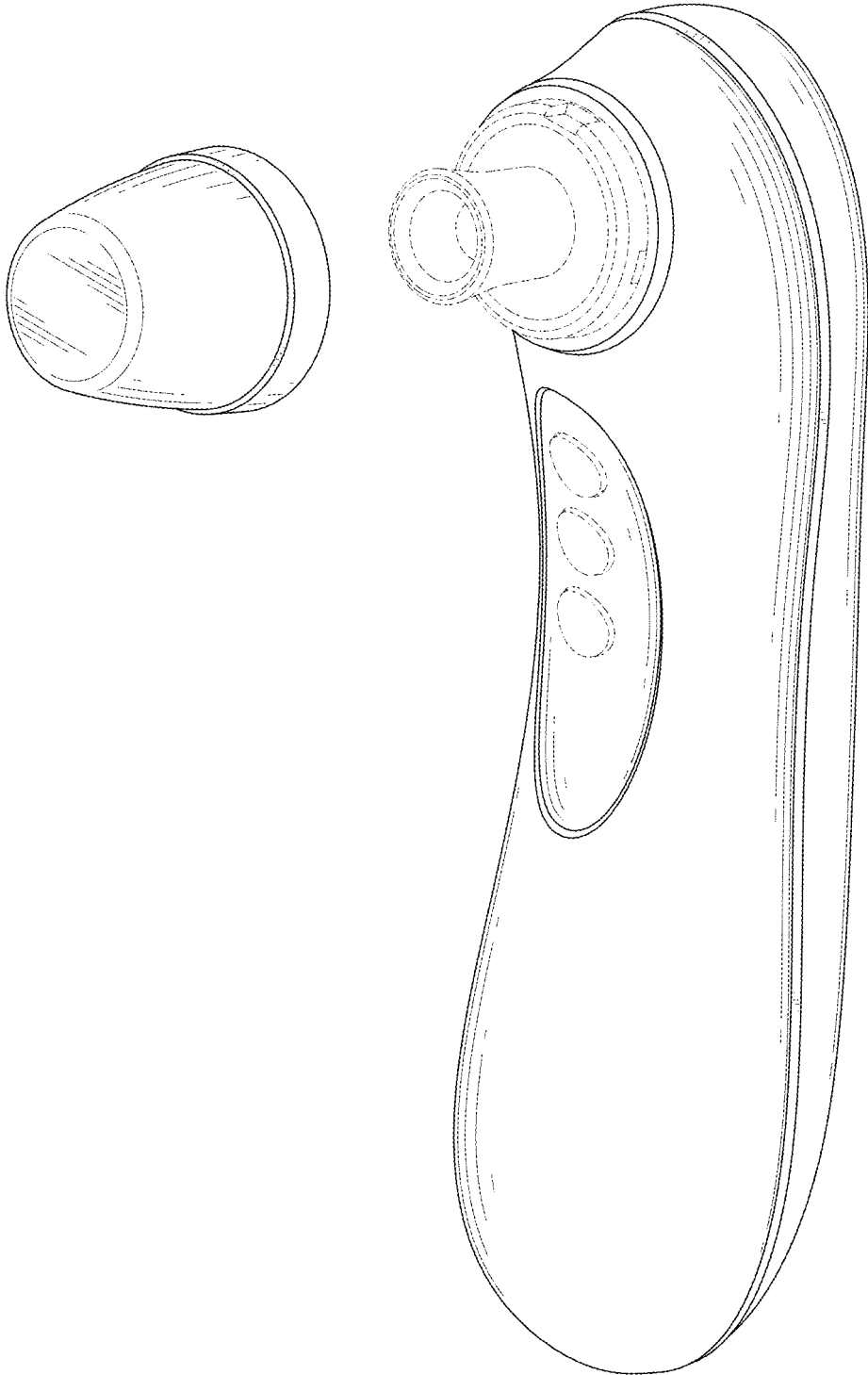
