FIG. 3 is a right side view of the newsrack shown in FIG. 1.

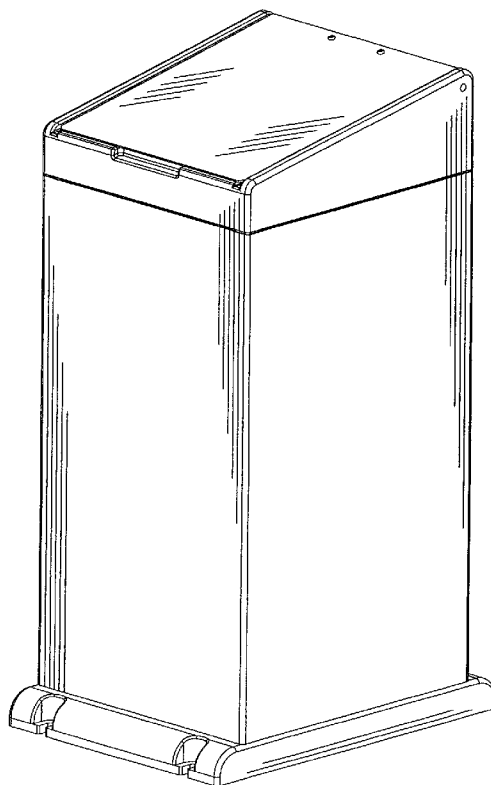
FIG. 4 is a rear view of the newsrack shown in FIG. 1.

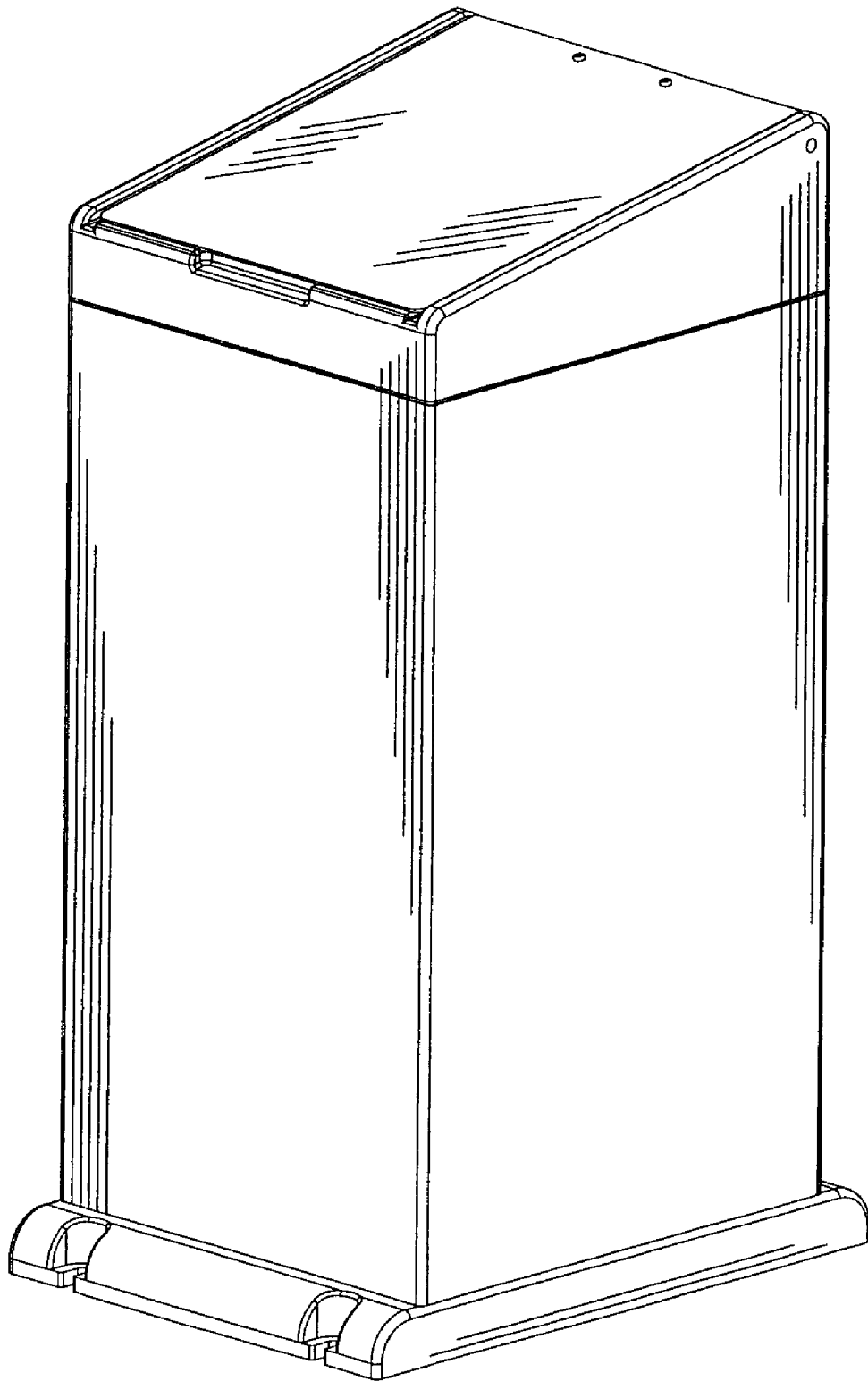

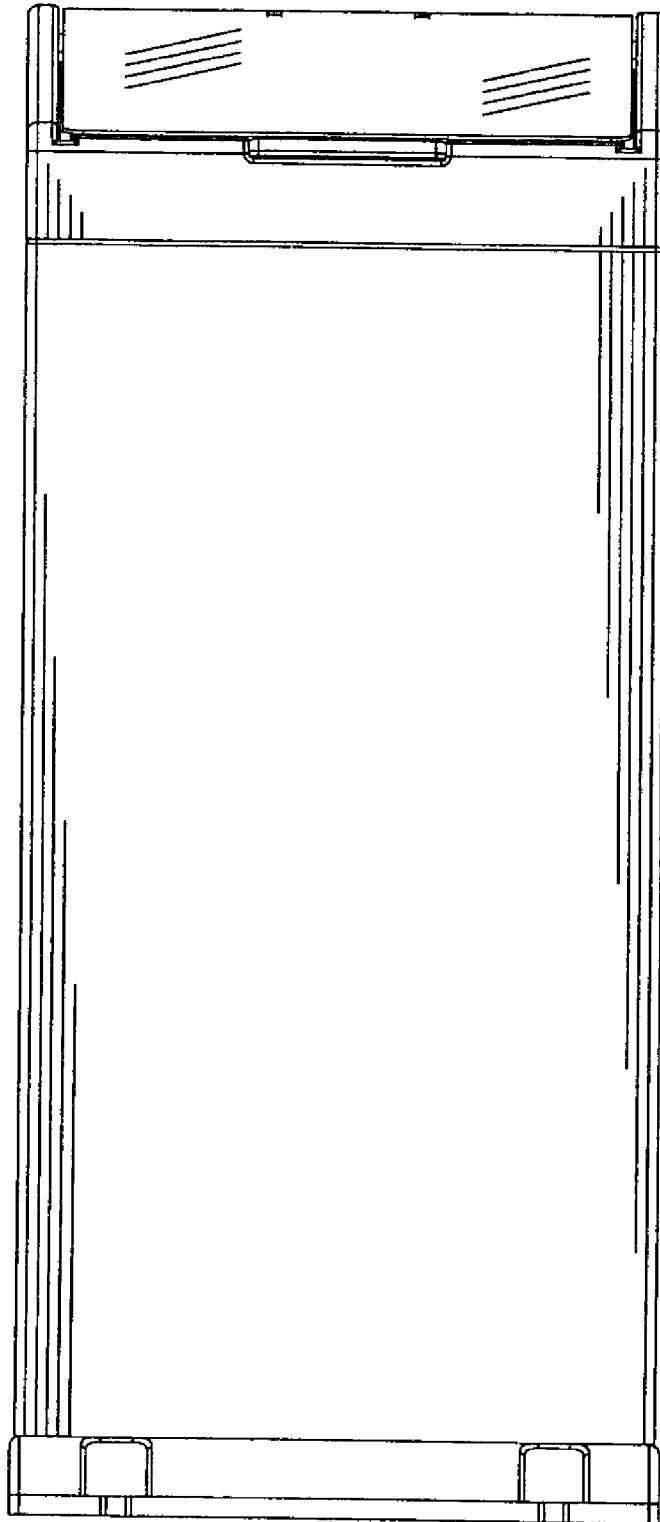

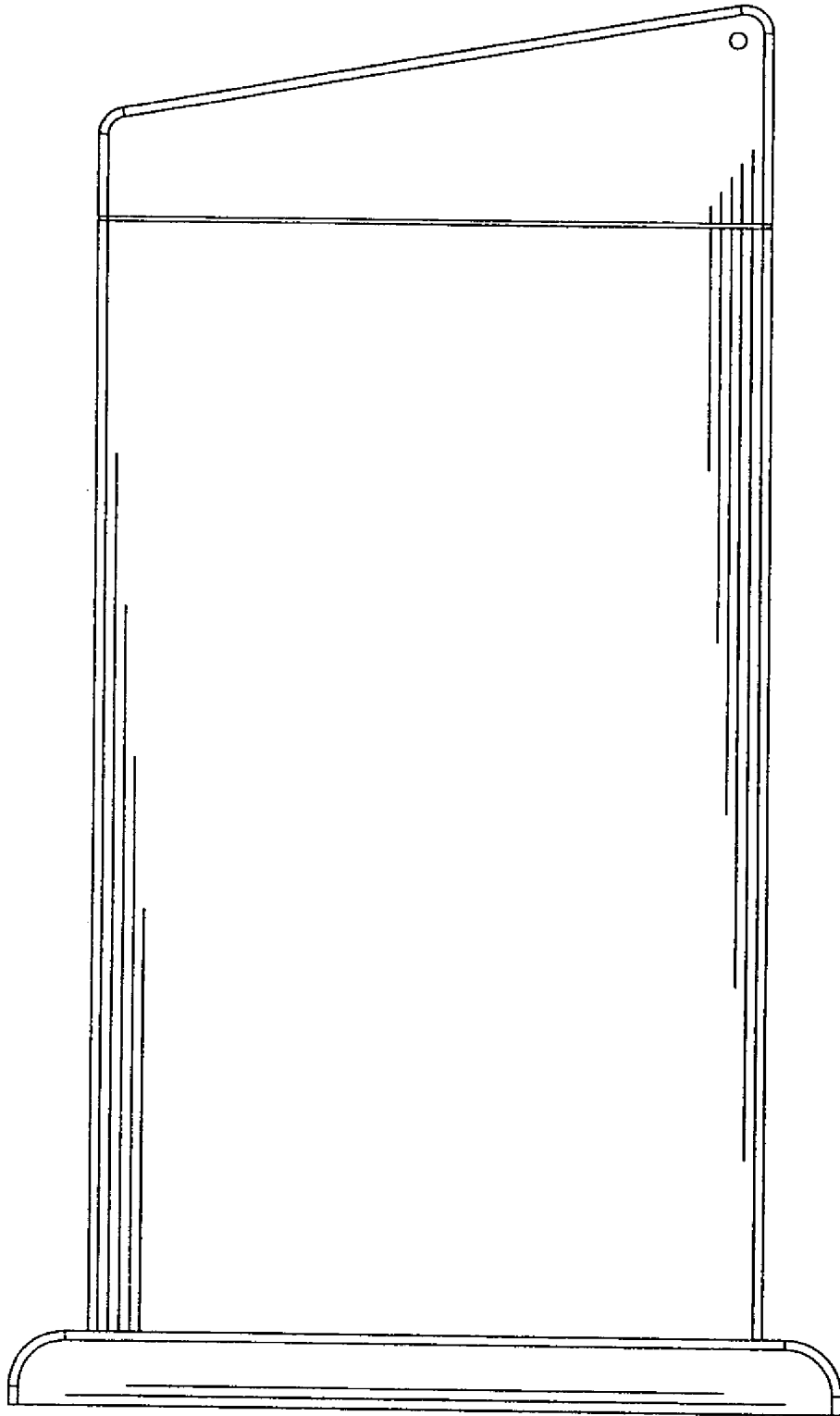

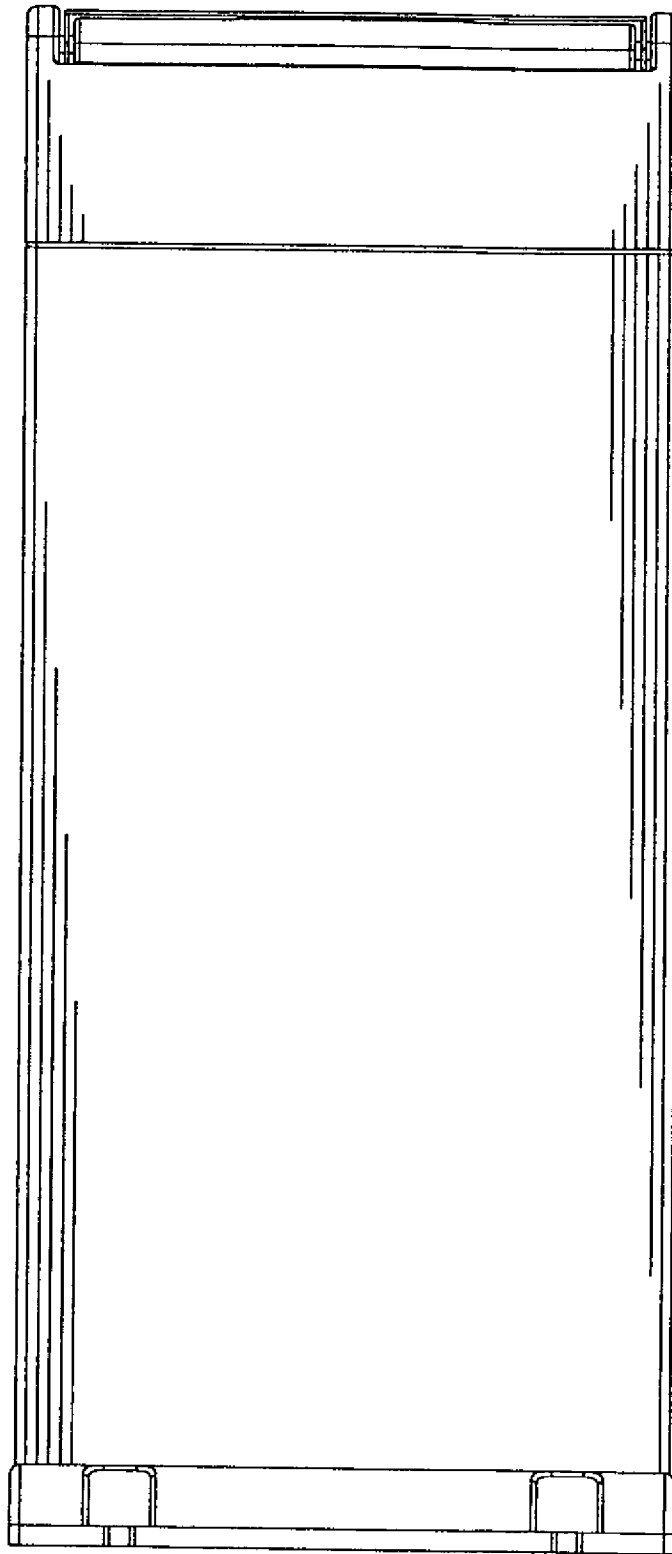

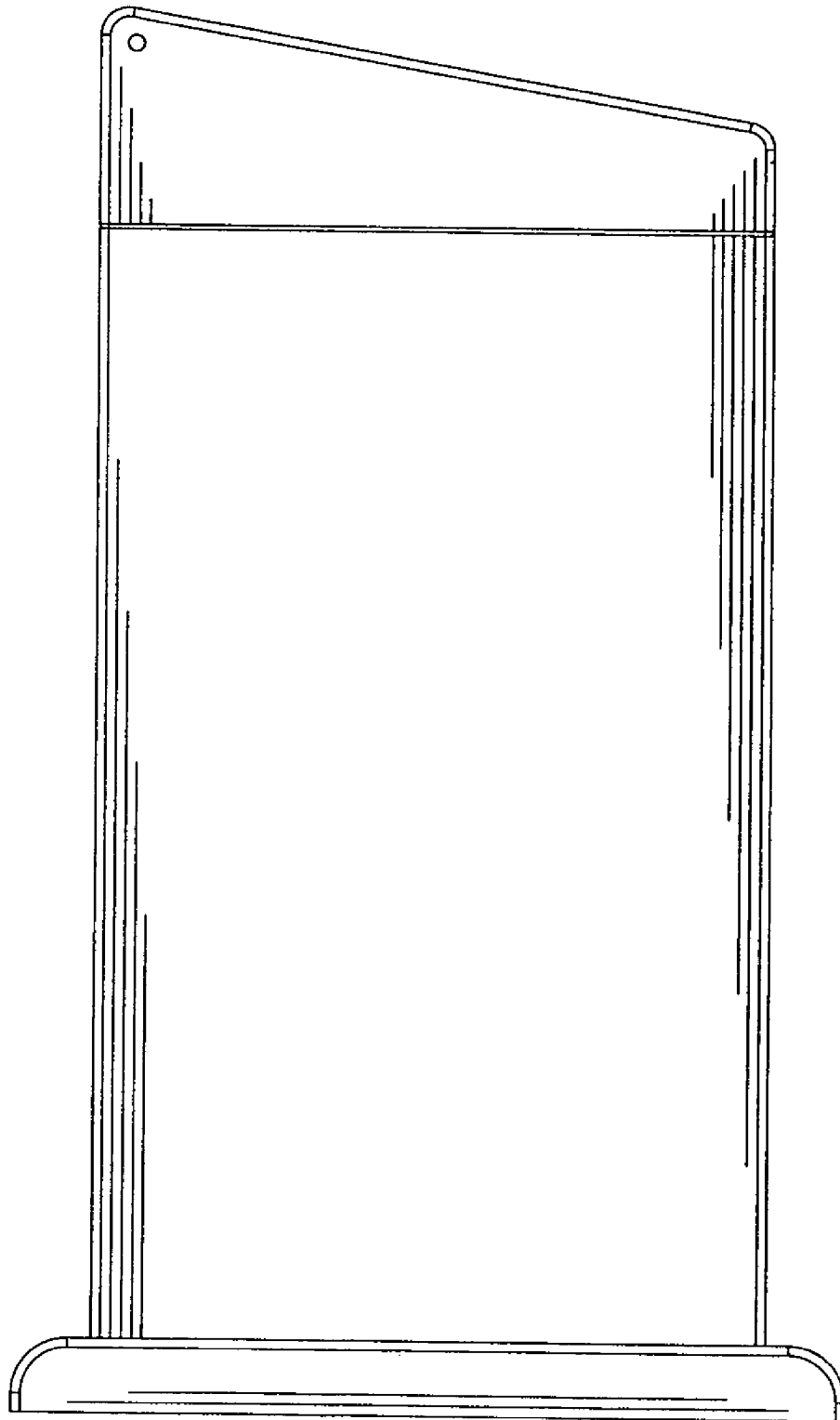

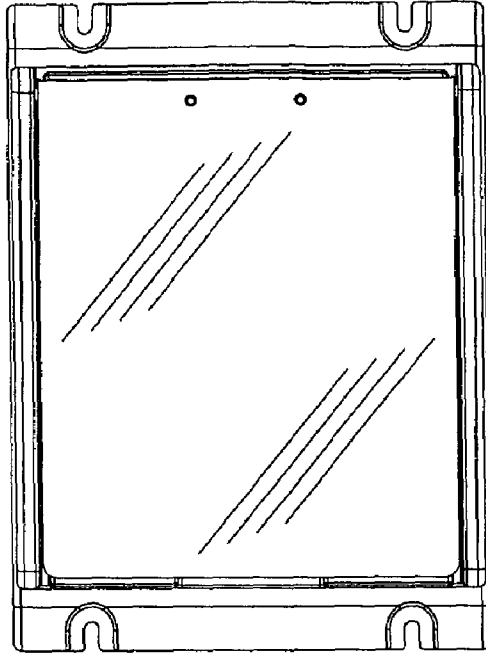

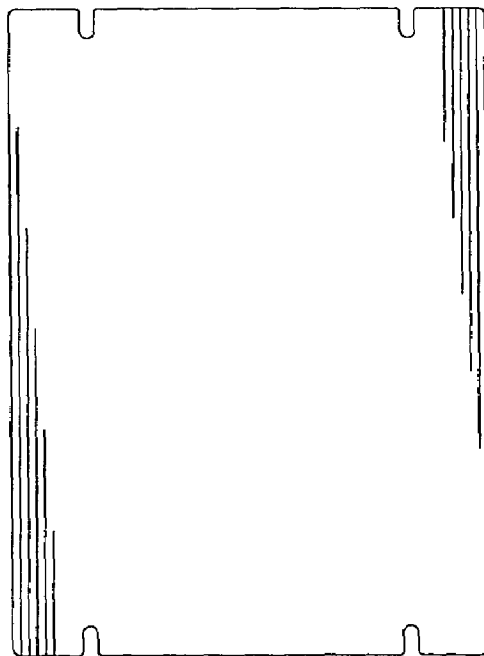
