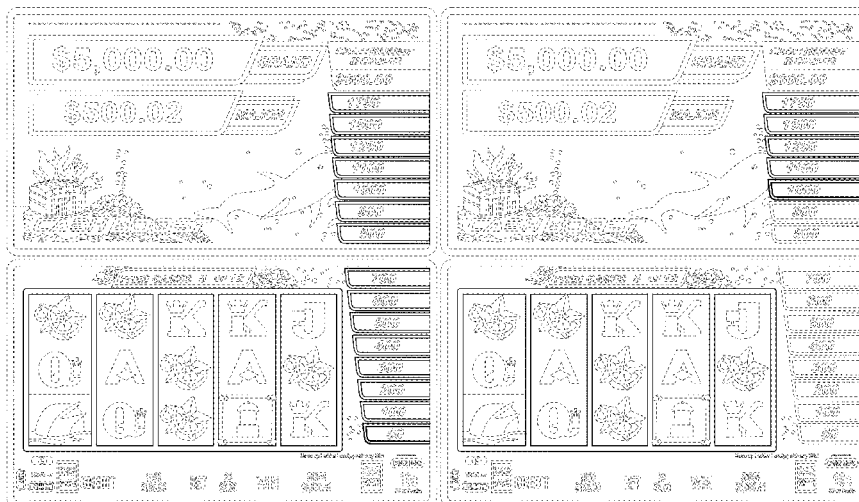
**OTHER PUBLICATIONS**

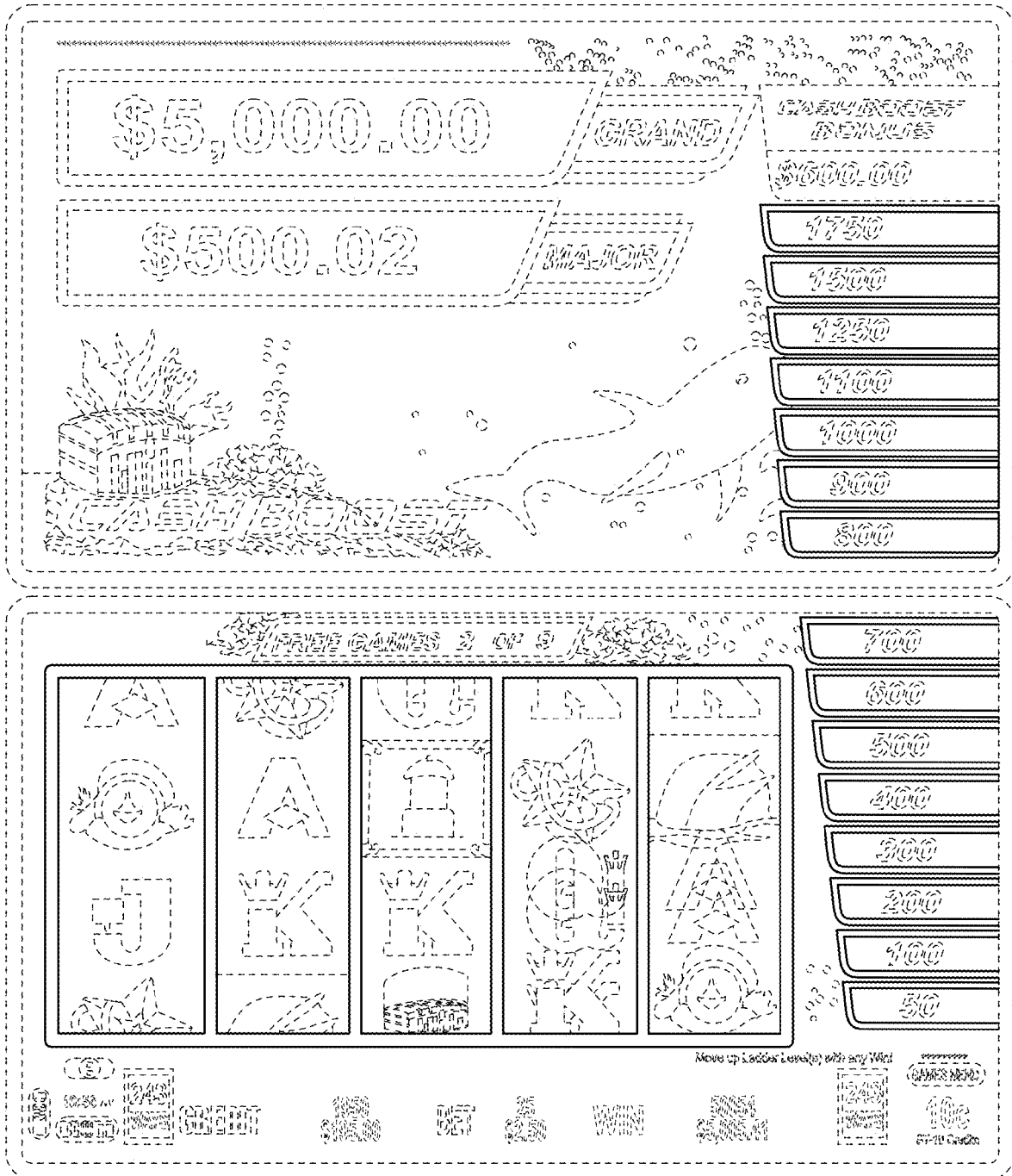
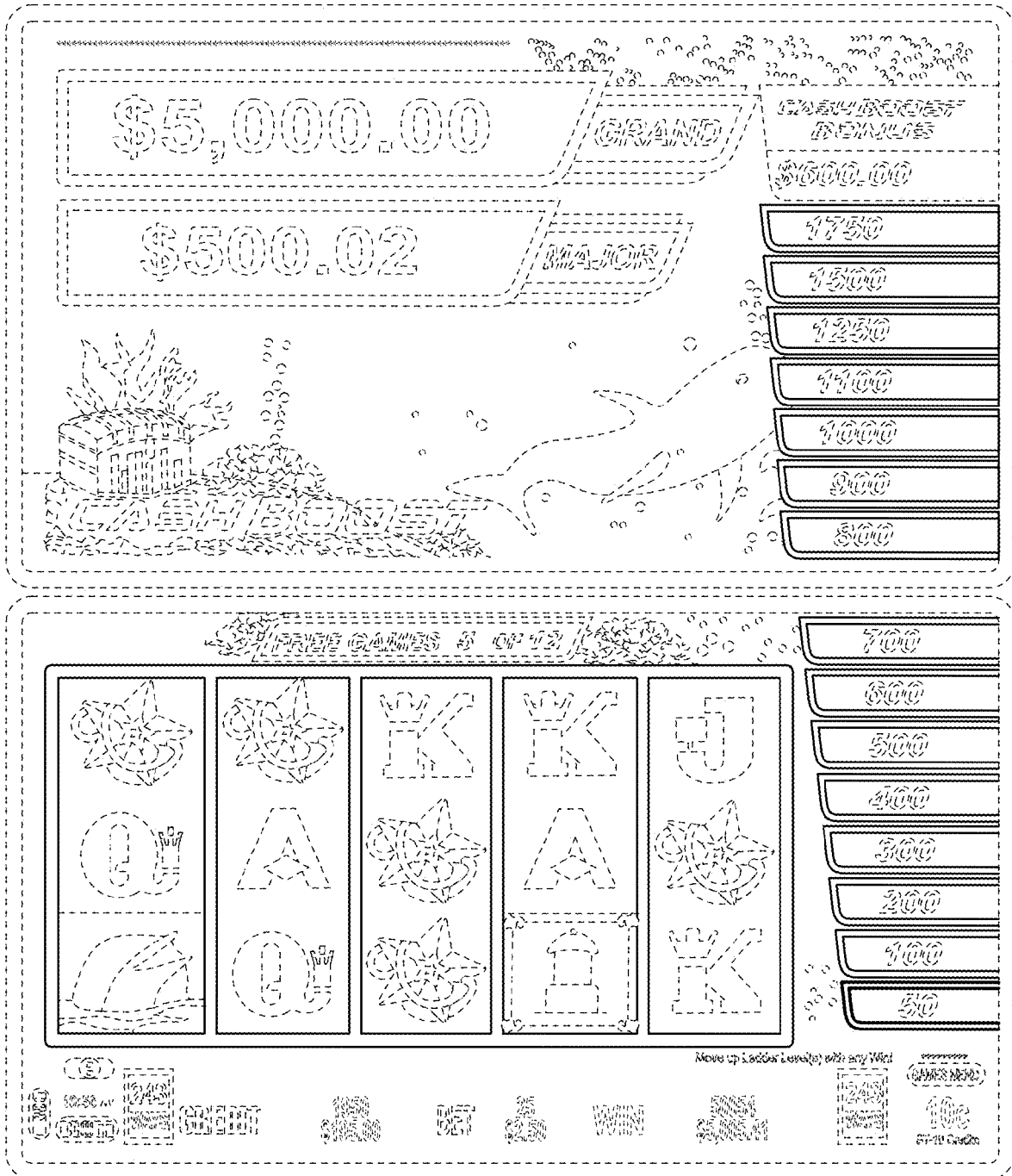

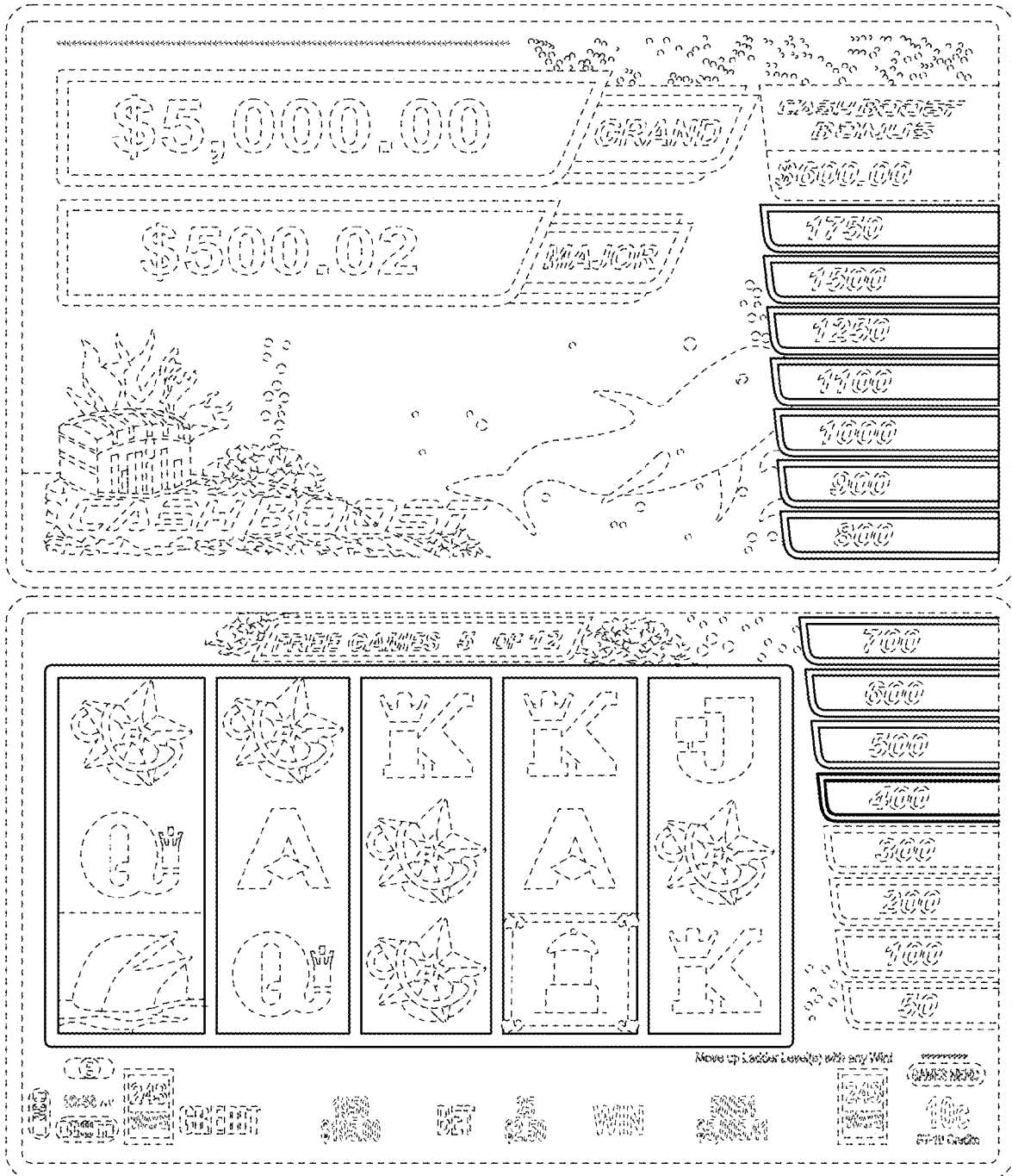

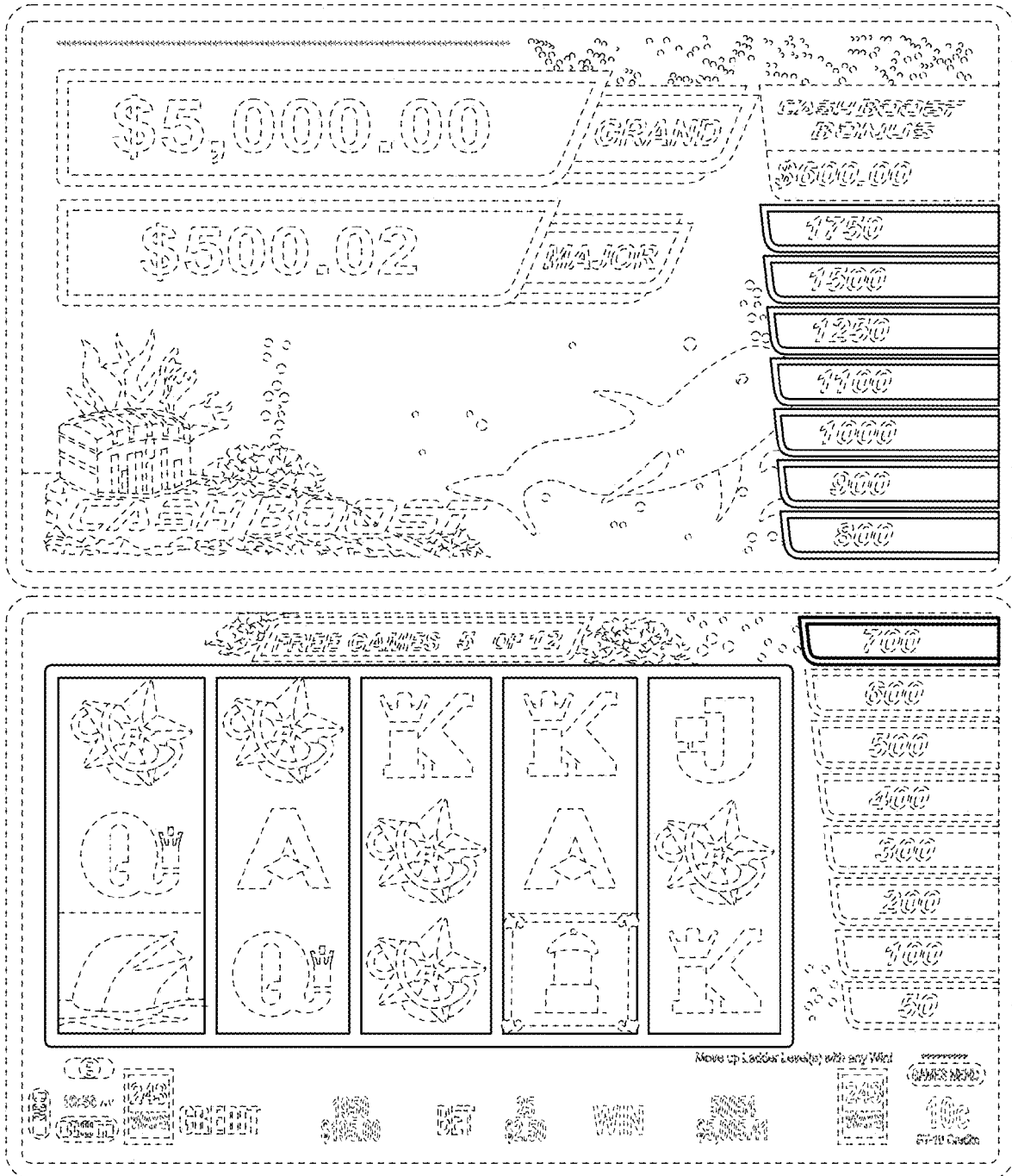

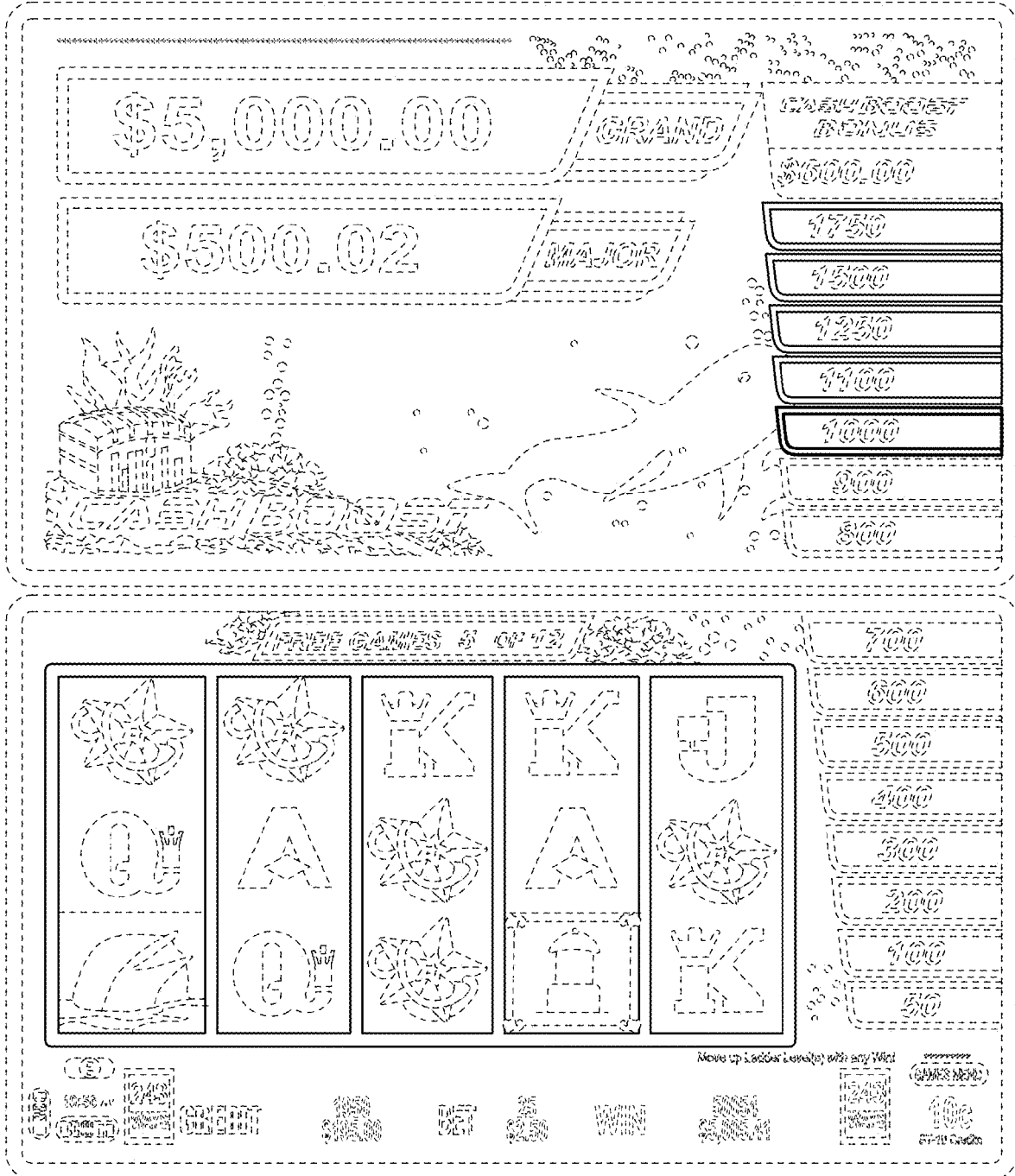

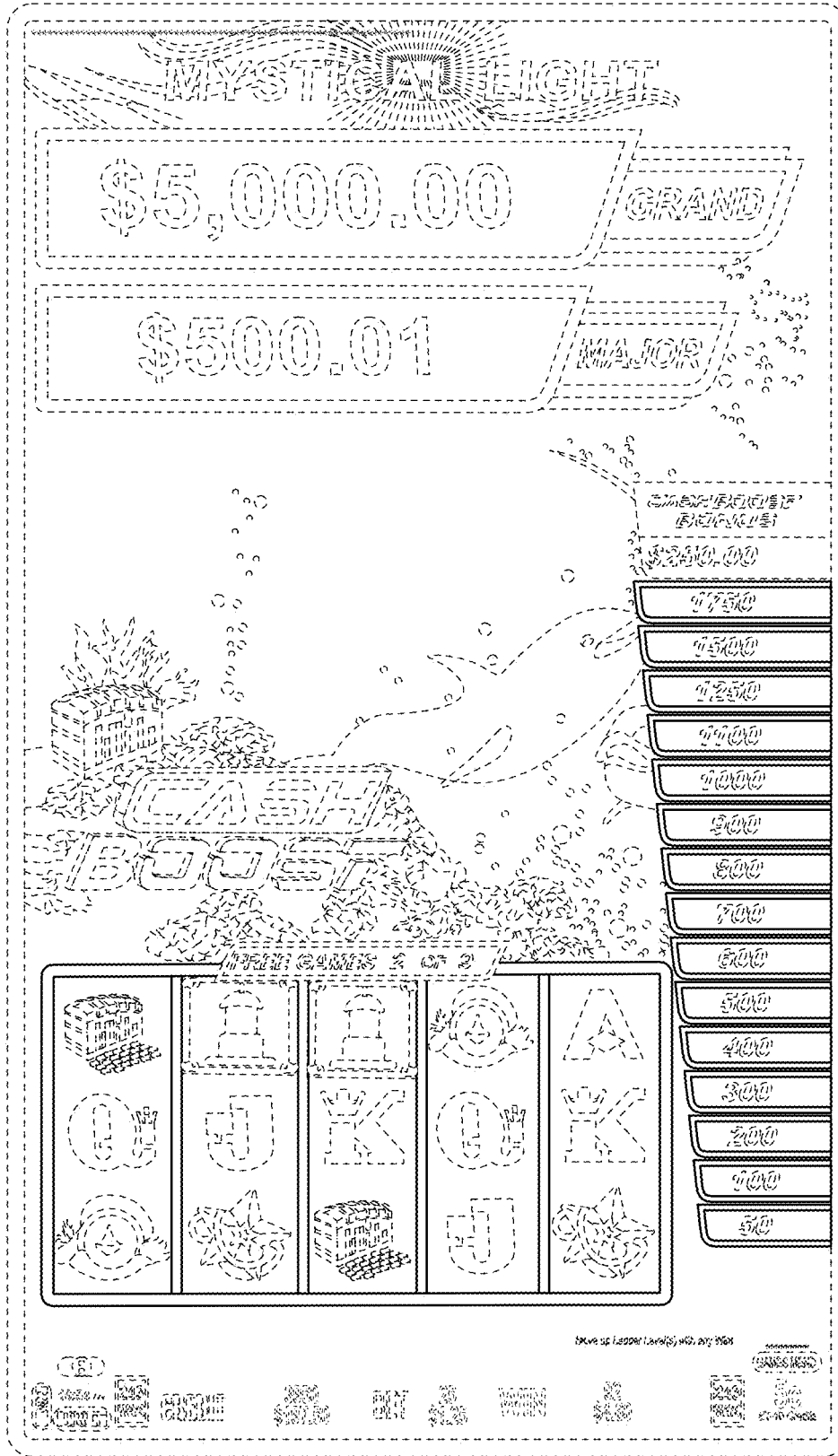

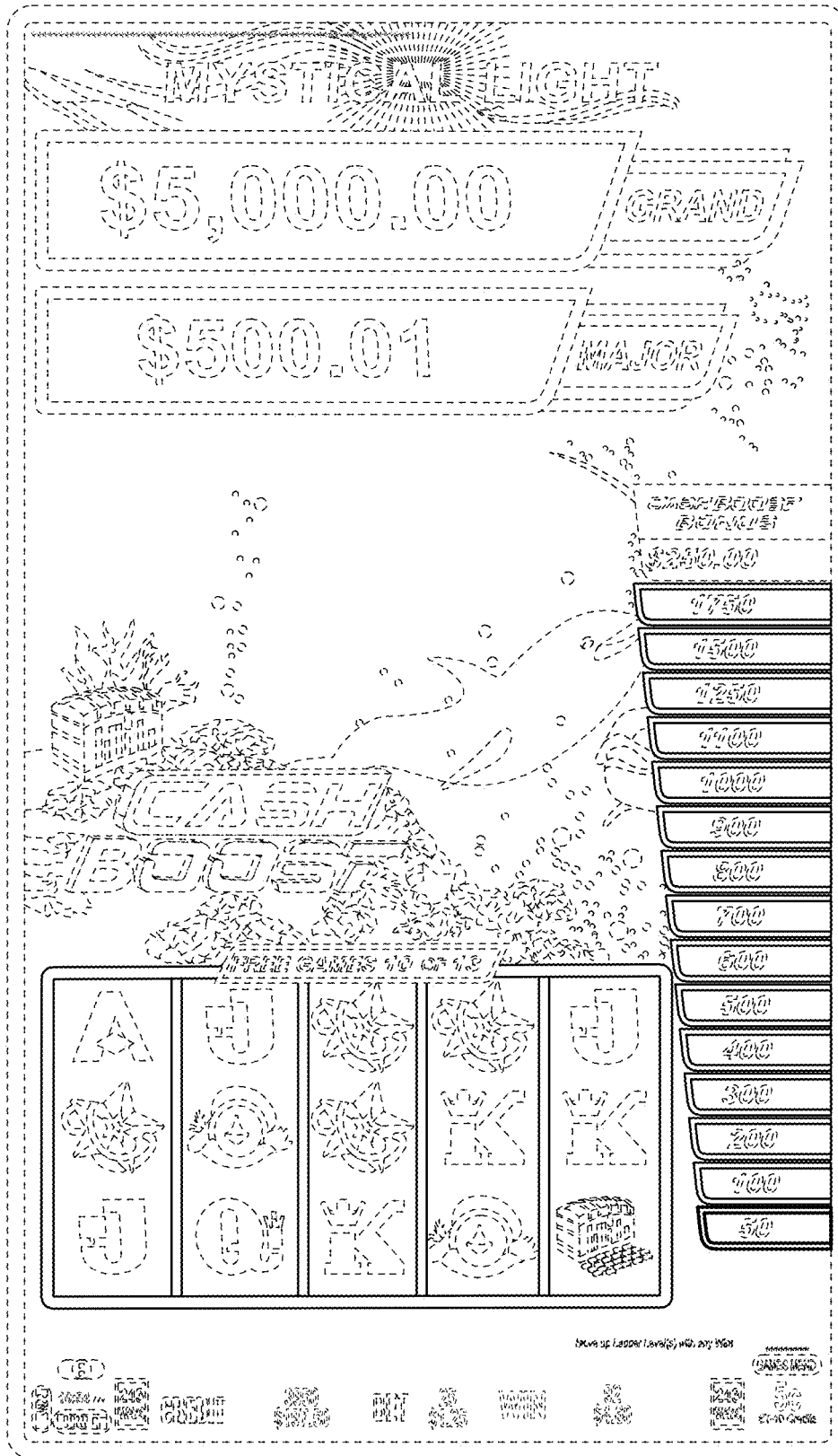

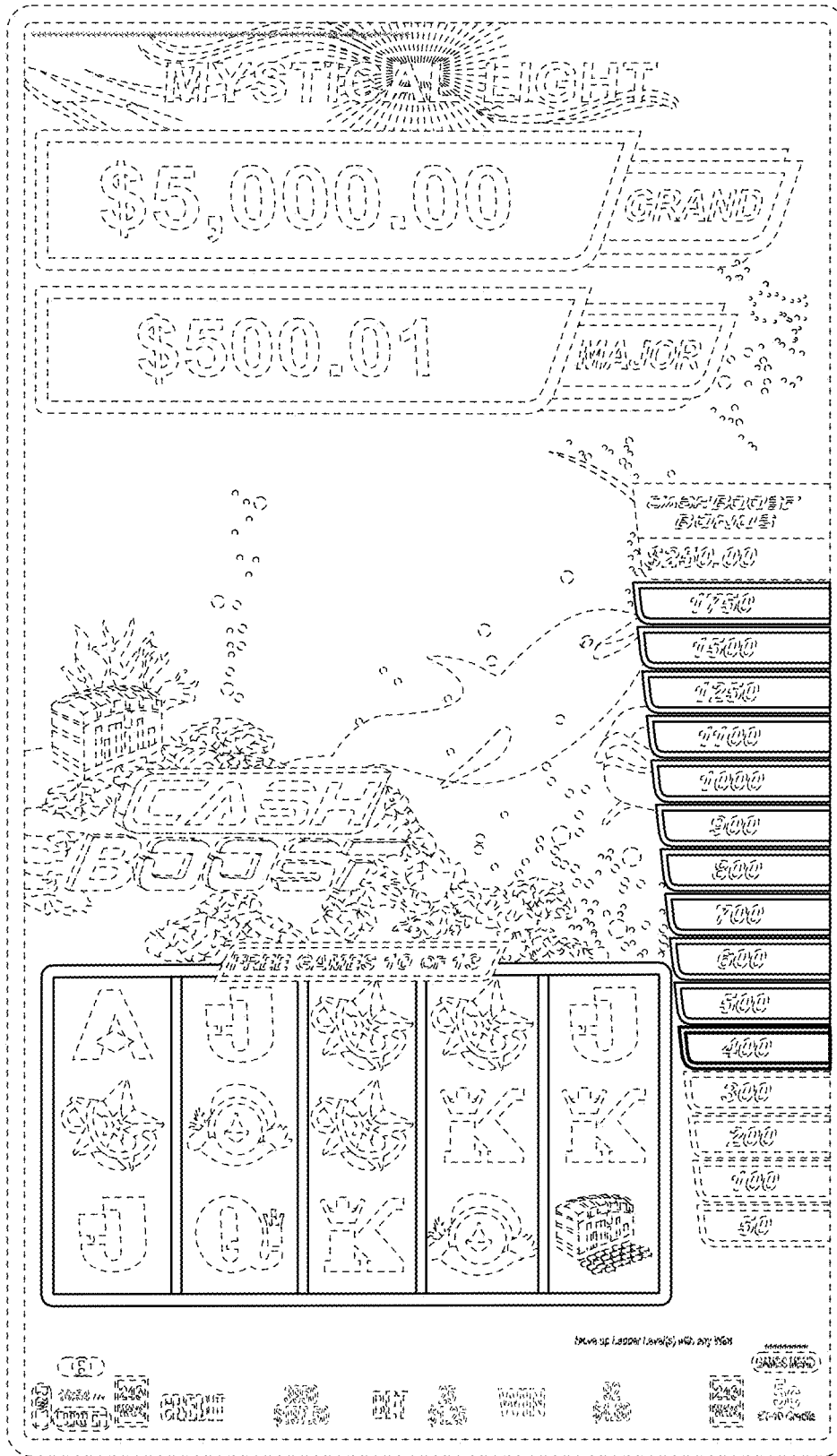

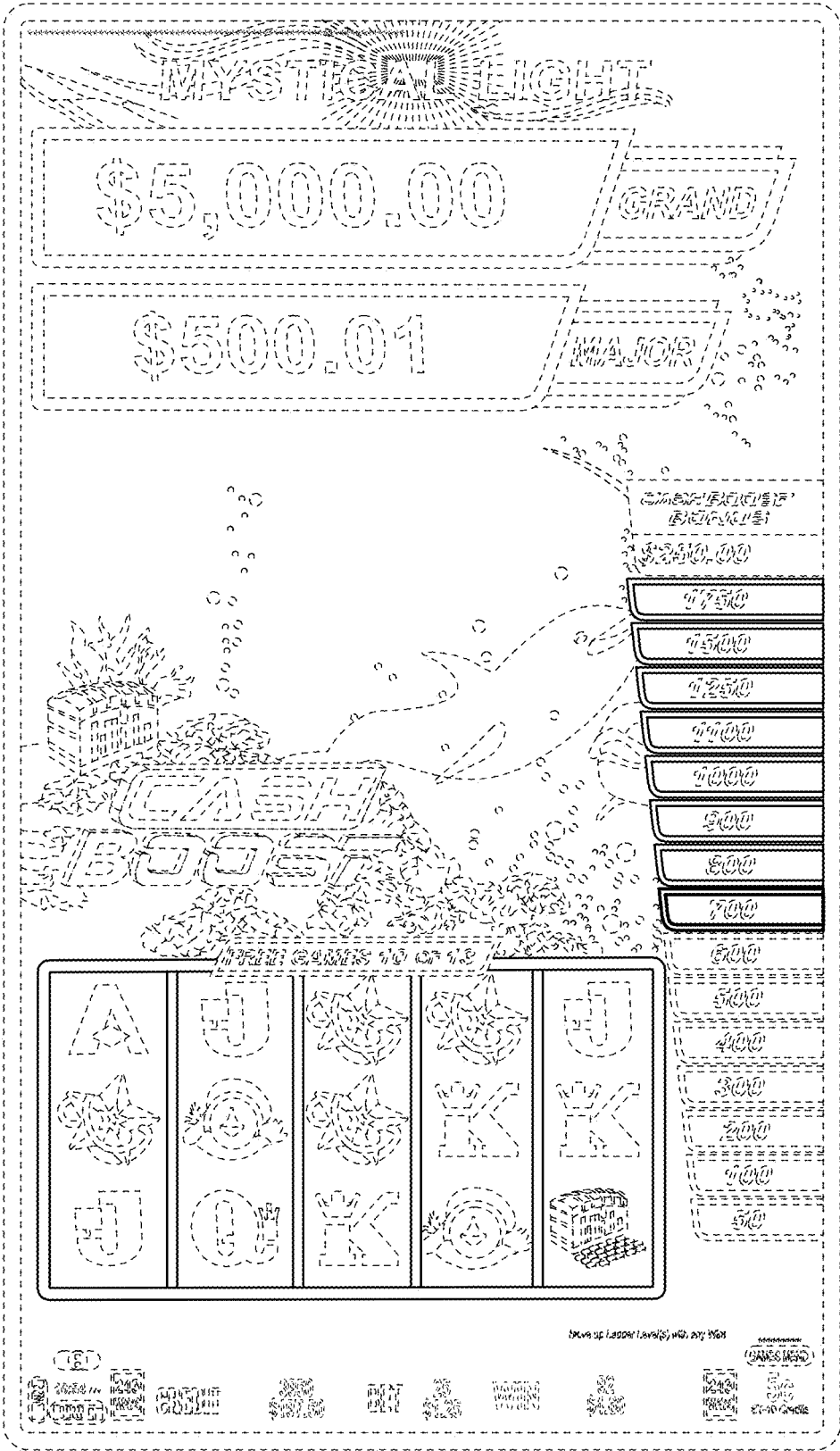

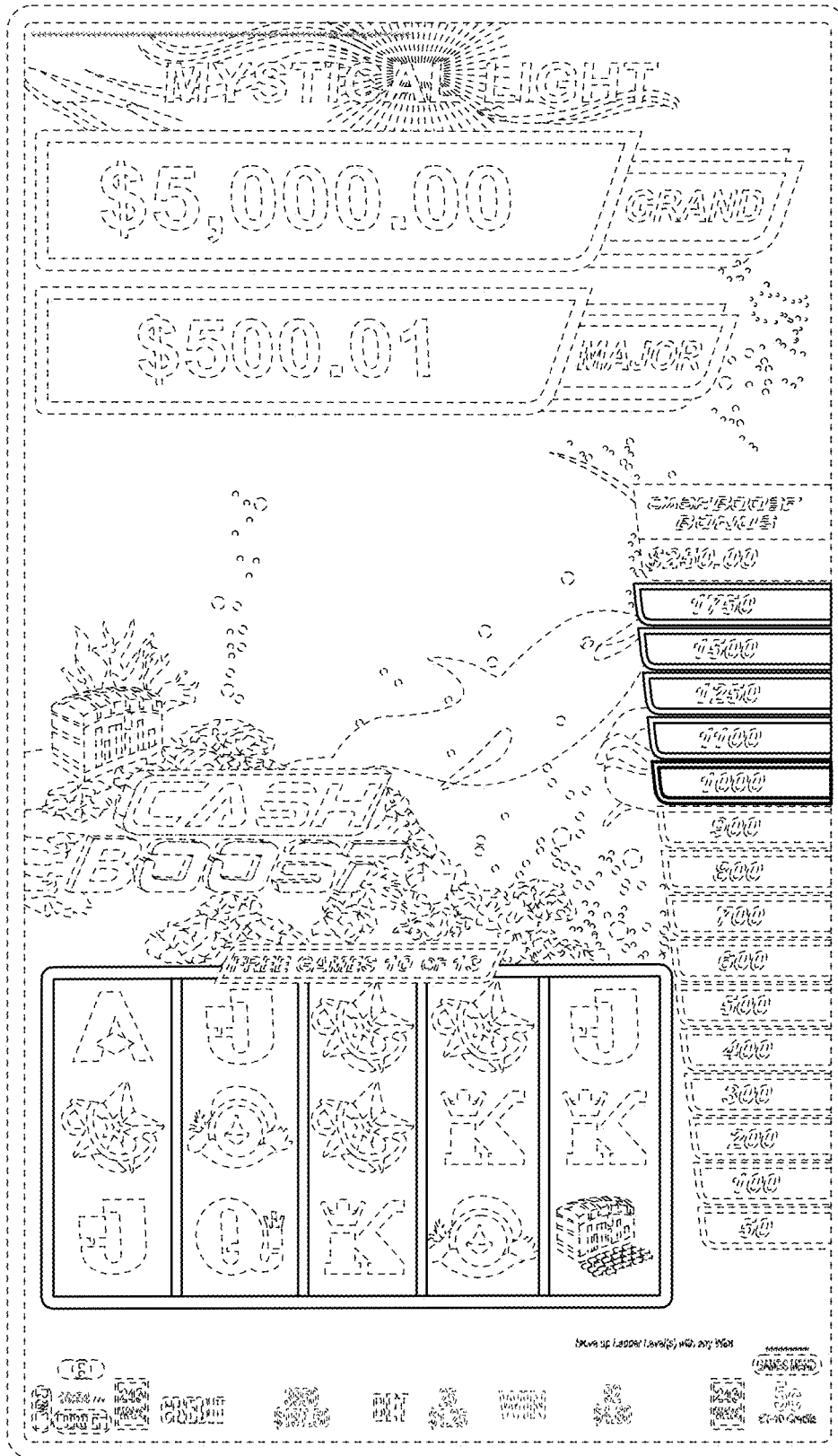
