of the claimed design.

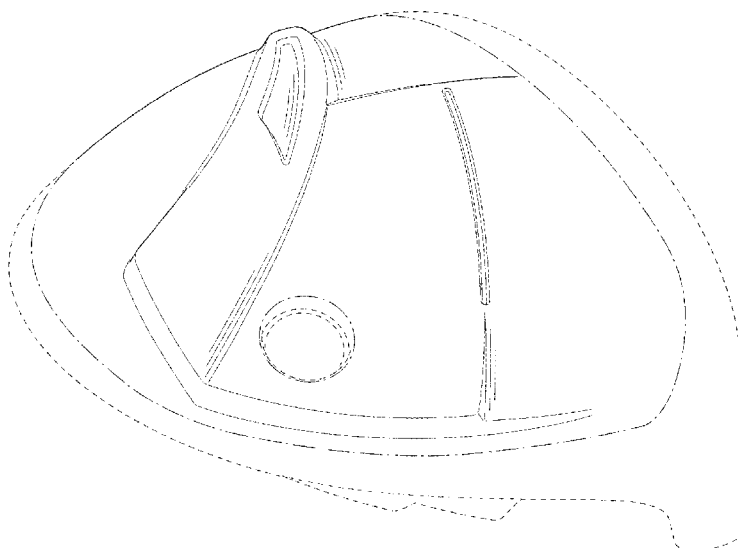
The dot-dash lines show a boundary between the claimed

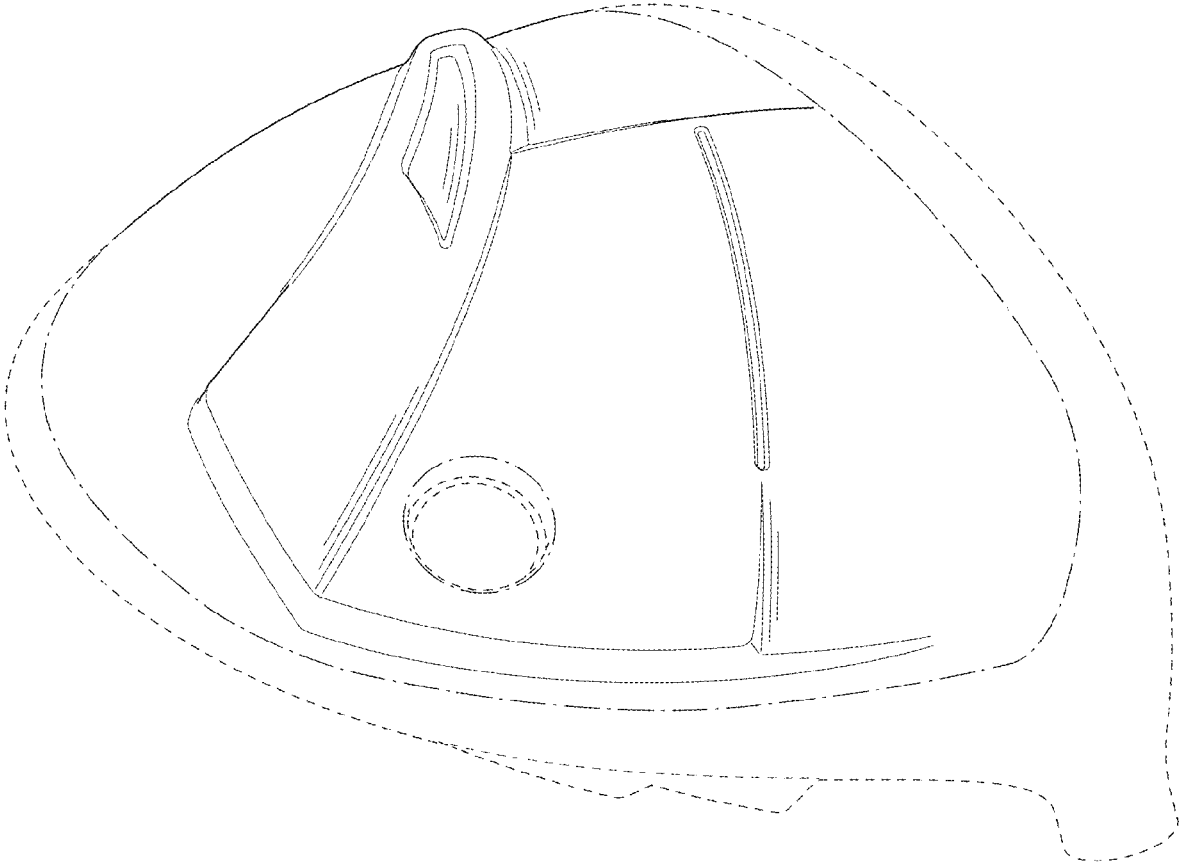

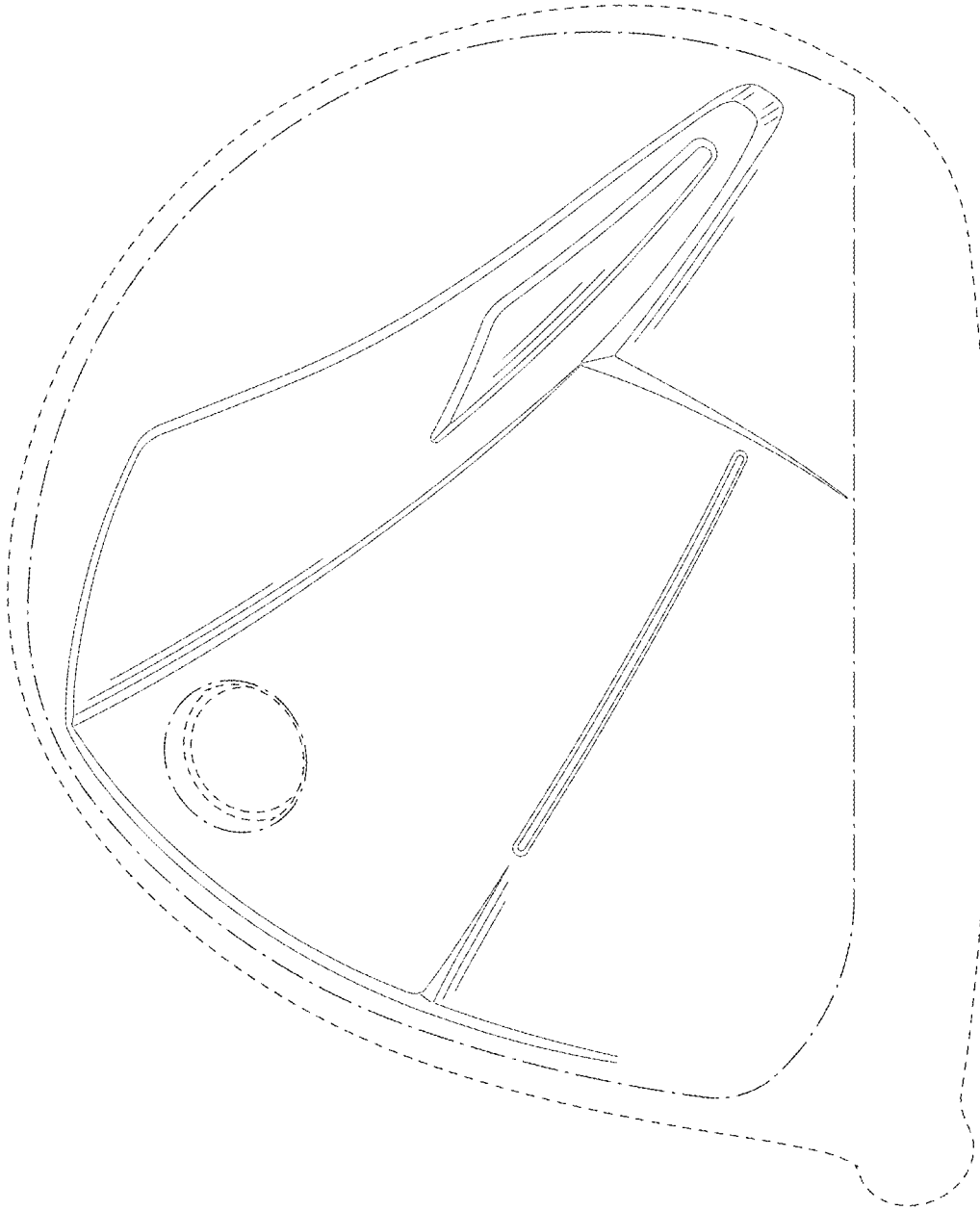

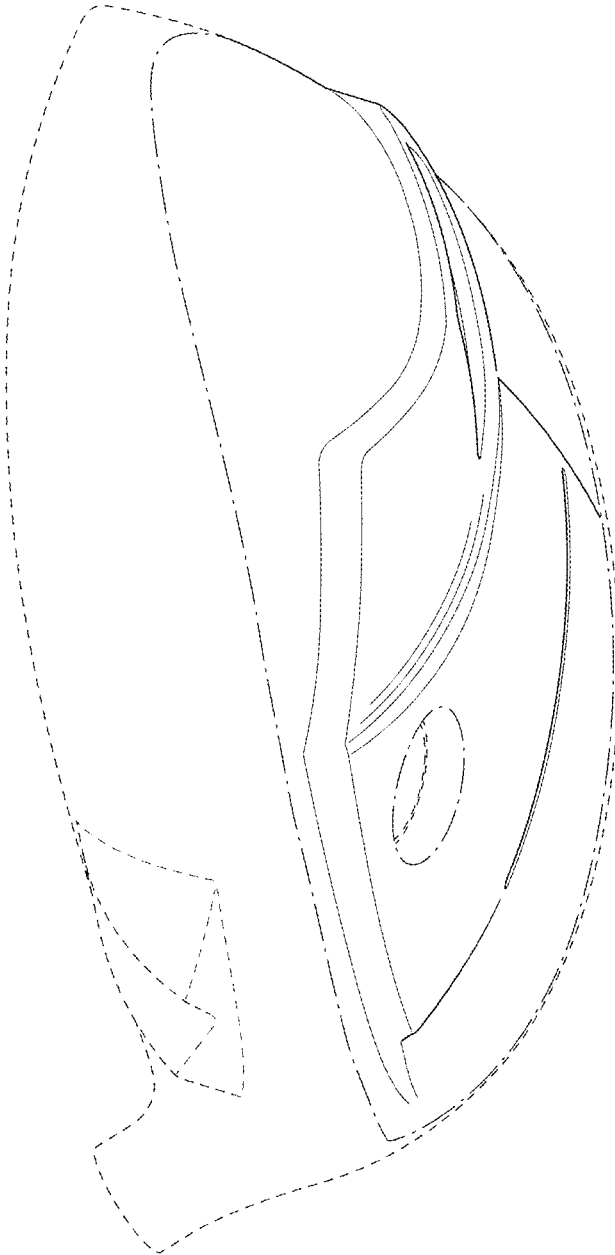

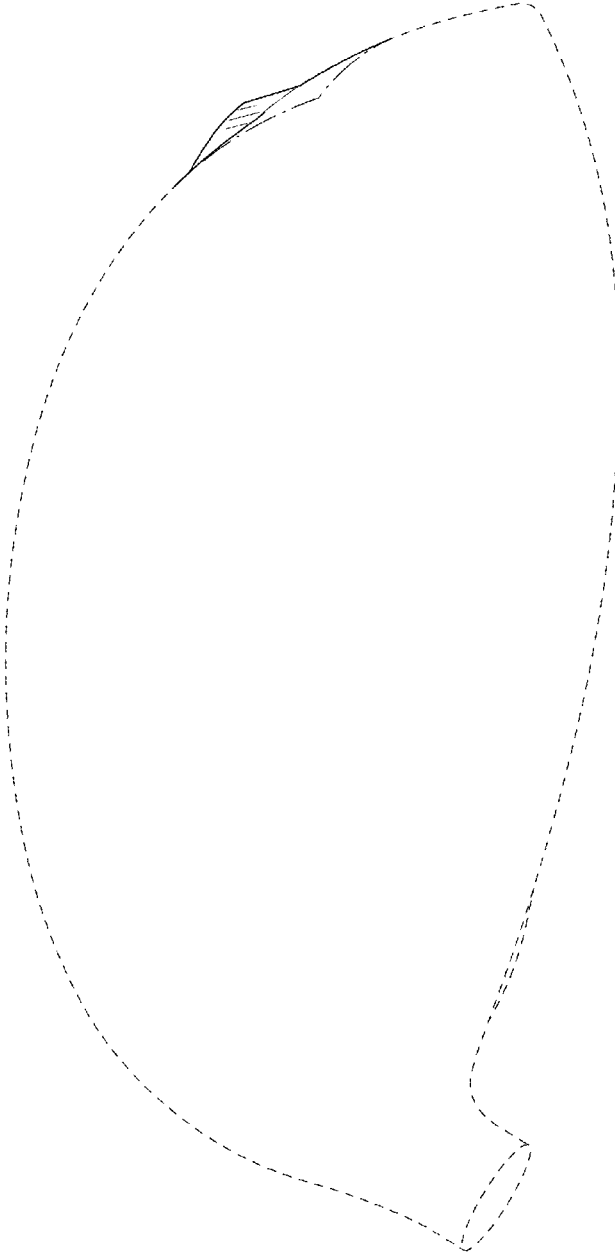

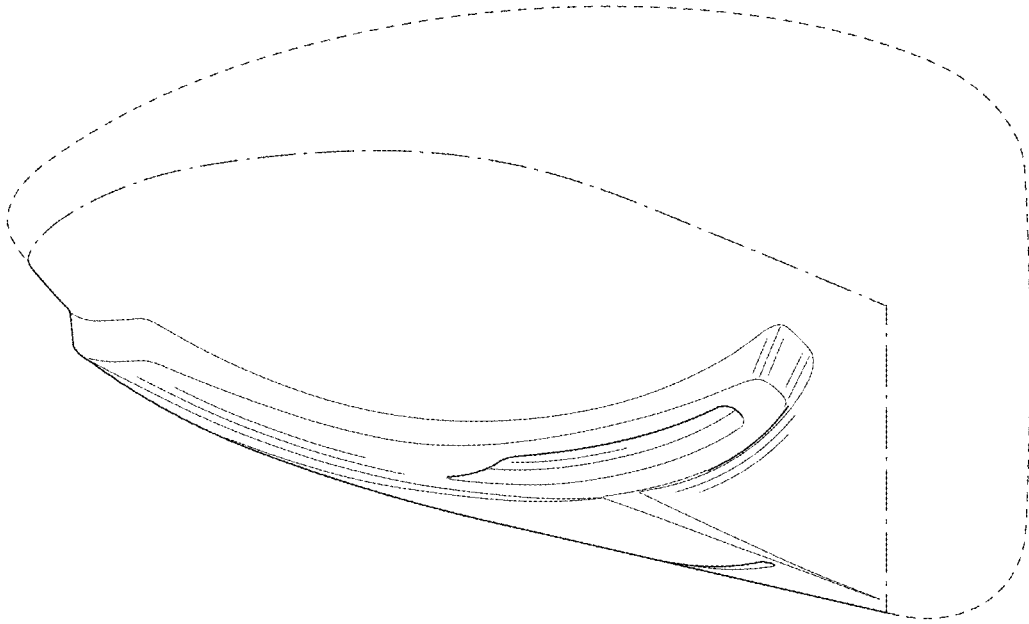

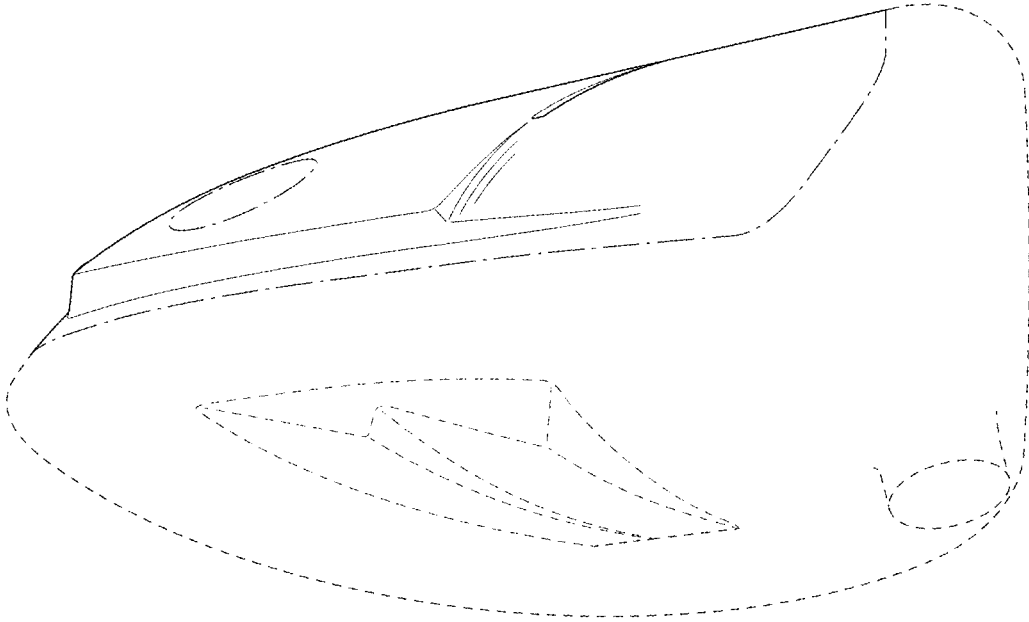
