(57) **CLAIM**

The ornamental design for a display screen or portion thereof with graphical user interface, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a display screen or portion thereof with graphical user interface, showing my new design; and, FIG. 2 is a front view thereof, in which a mobile terminal in broken line is provided to illustrate an example environment. The outermost broken line in FIG. 1 illustrates the display screen in which the claimed design is embodied. Alternatively, the outermost broken line in FIG. 1 illustrates the portion of the display screen in which the claimed design is embodied. The broken line showing of the display screen or portion thereof in FIG. 1 and the broken line showing of the mobile terminal in FIG. 2 illustrates the environment of the claimed design and forms no part thereof. The remaining broken lines in FIGS. 1 and 2 illustrate portions of the Graphical User Interface that form no part of the claimed design.

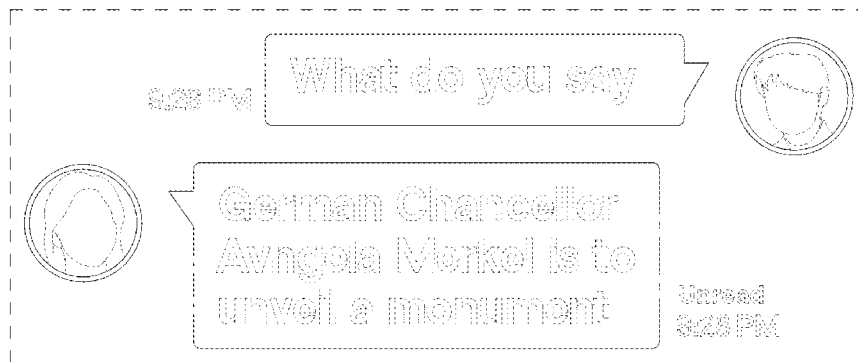

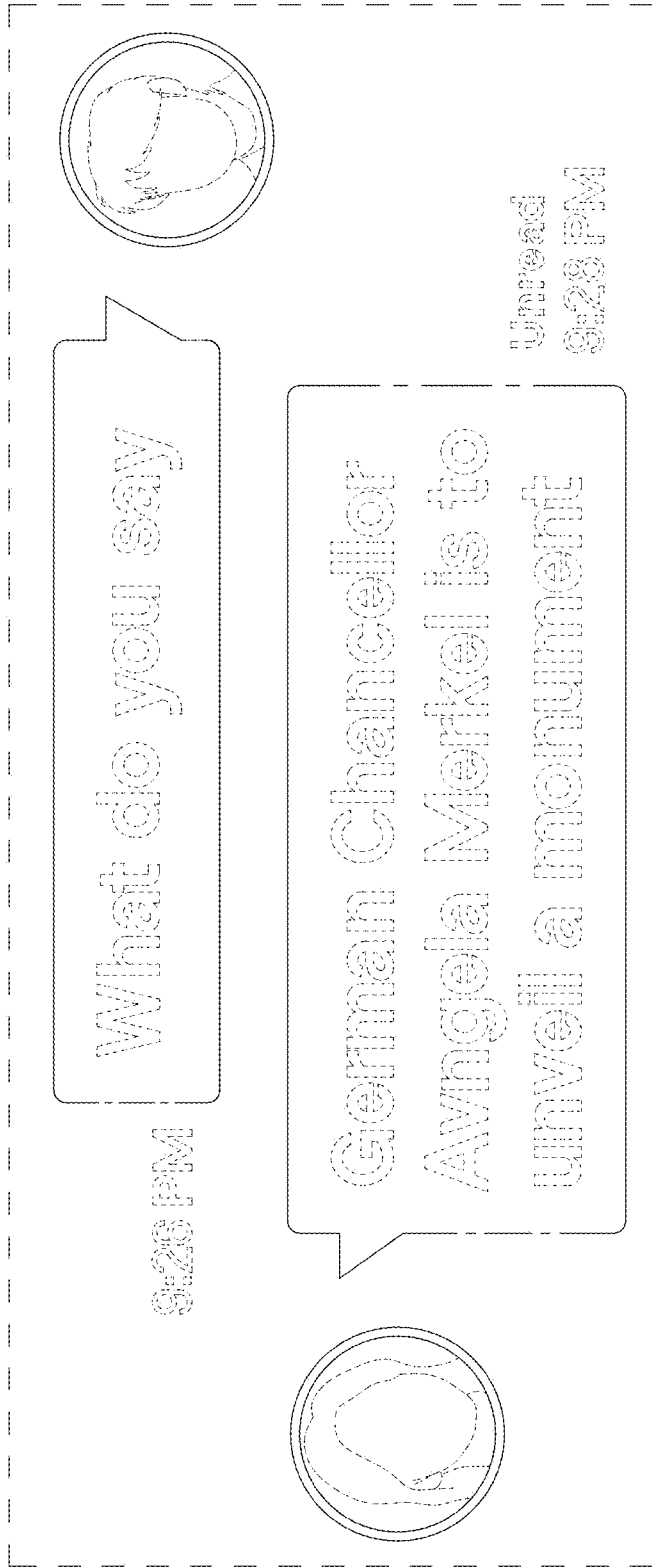
