(57) **CLAIM**

The ornamental design for a case for multiple electronic cigarettes, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a case for multiple electronic cigarettes showing the new design, shown with the lid in a closed position;

FIG. 2 is a front view of the case for multiple electronic cigarettes shown with the lid in a closed position;

FIG. 3 is a rear view of the case for multiple electronic cigarettes shown with the lid in a closed position;

FIG. 4 is a left side view of the case for multiple electronic cigarettes shown with the lid in a closed position;



FIG. 5 is a right side view of the case for multiple electronic cigarettes shown with the lid in a closed position;










