DESCRIPTION

FIG. 1 is a perspective view of a horse shoe showing my Design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;



FIG. 4 is a left-side elevational view thereof, the right-side view being a mirror image of the left side; and,










