
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top view of manual valve actuator with cam and mounting bracket showing the new design;
 FIG. 2 is a front view of the manual valve actuator with cam and mounting bracket of FIG. 1;
 FIG. 3 is a bottom view of the manual valve actuator with cam and mounting bracket of FIG. 1;
 FIG. 4 is a back view of the manual valve actuator with cam and mounting bracket of FIG. 1;
 FIG. 5 is a right side view of the manual valve actuator with cam and mounting bracket of FIG. 1; and,












