DESCRIPTION

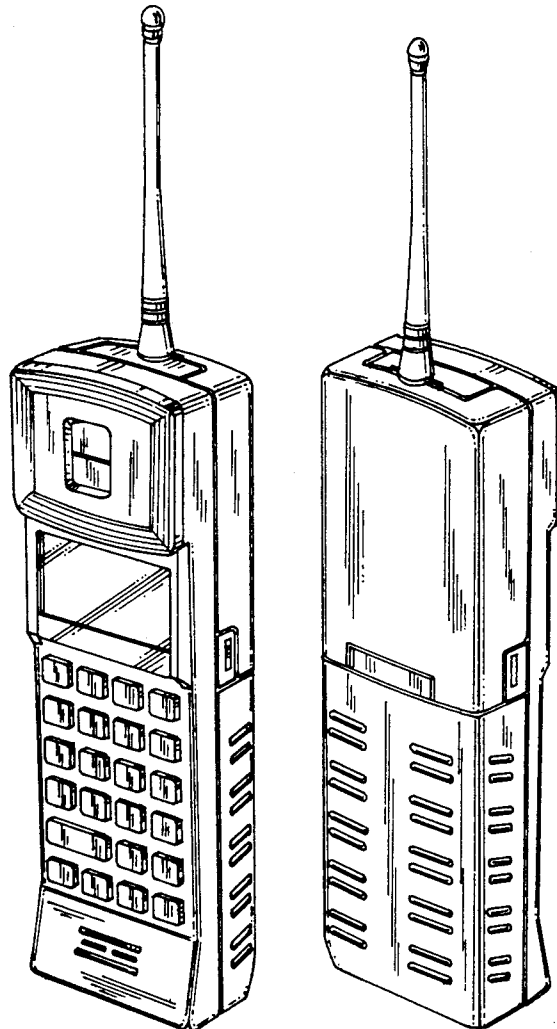
FIG. 1 is a top, front and right side perspective view of a radiotelephone showing my new design;

FIGS. 7 and 8 are respectively top and bottom plan views thereof.



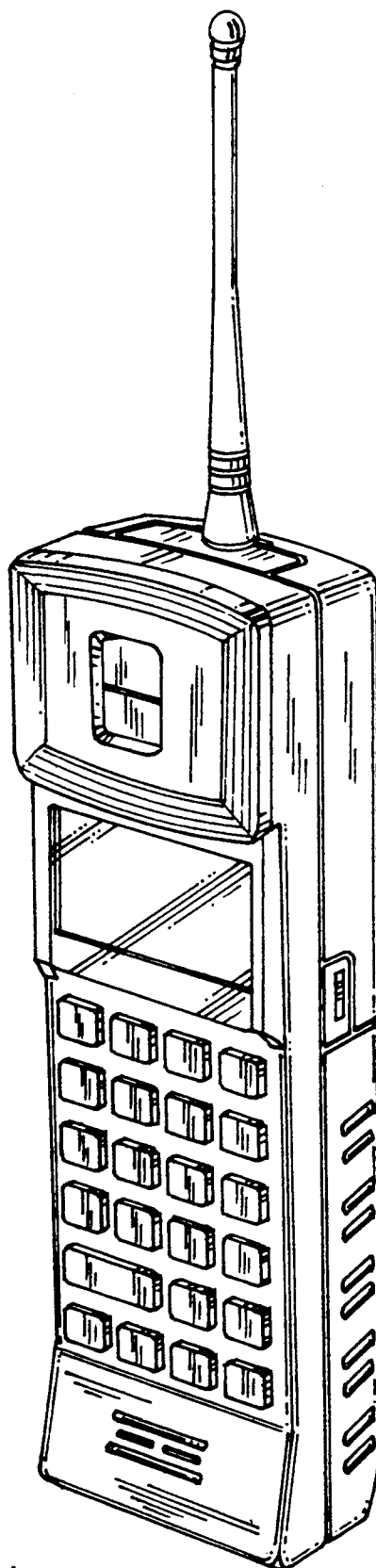

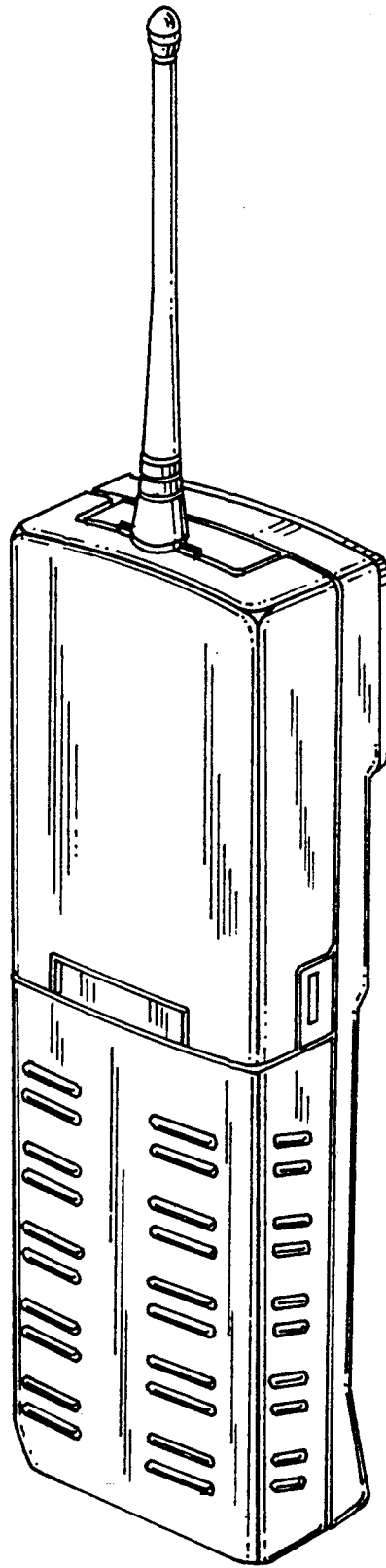

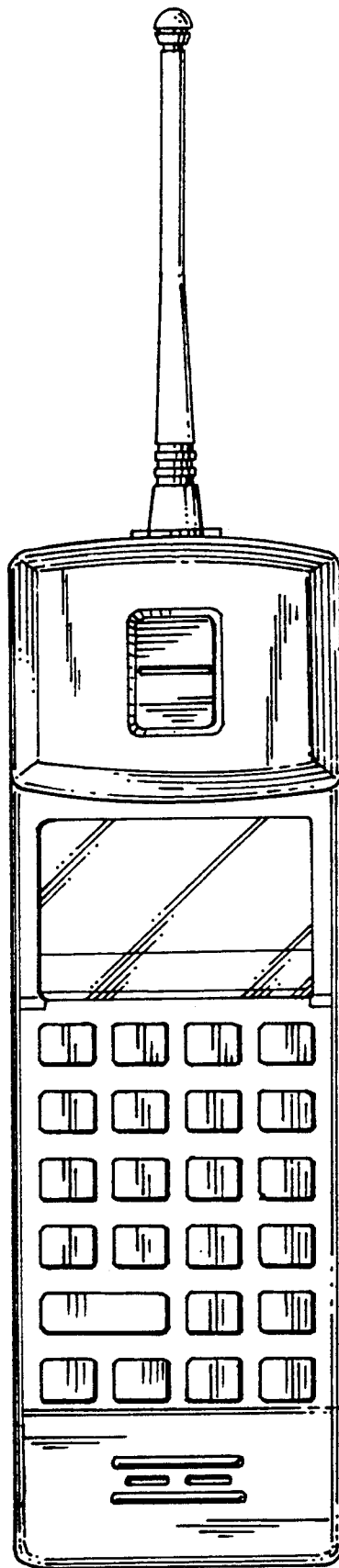

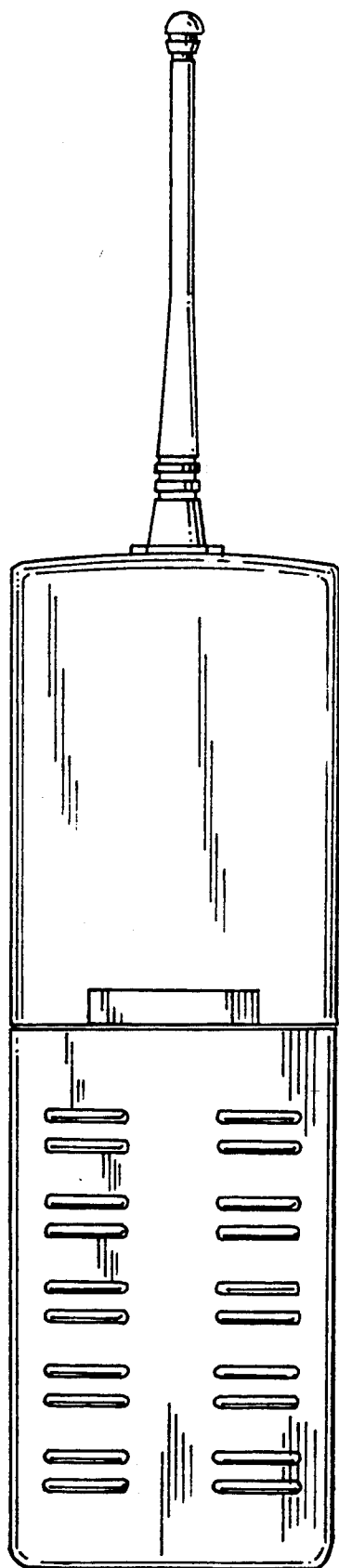

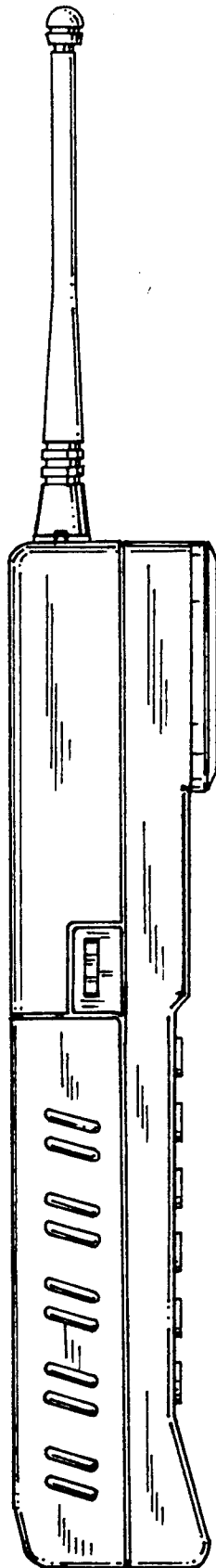

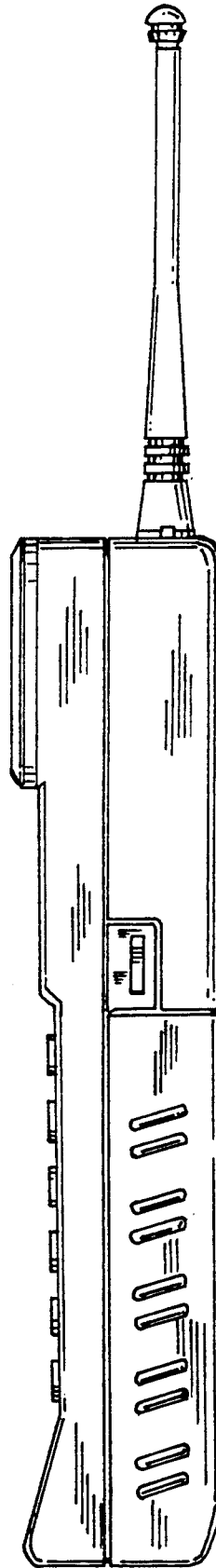

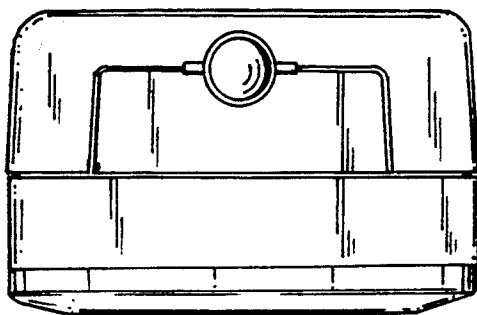

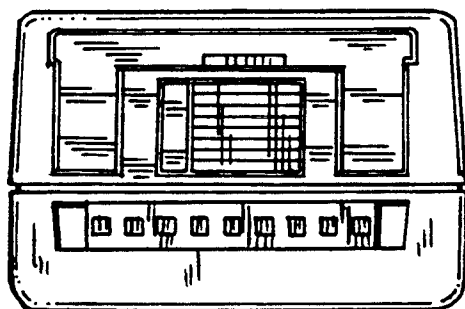
