(57) **CLAIM**

I claim, the ornamental design for a ultra metal ring, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a ultra metal ring, showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof; and,
FIG. 8 is a cross-sectional view taken along the lines VIII-VIII of FIG. 2.

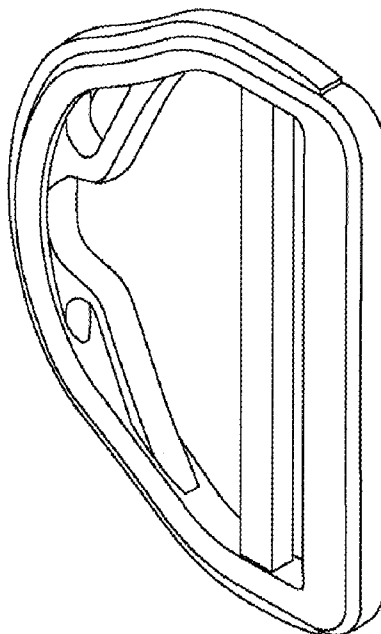

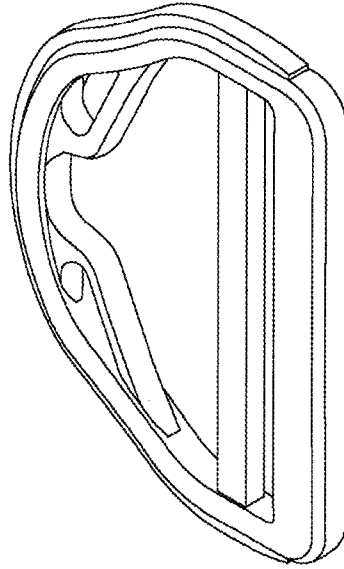

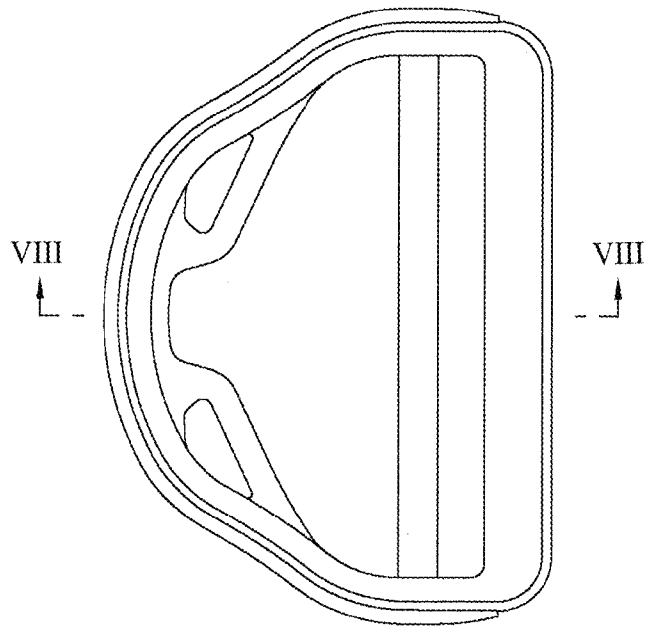

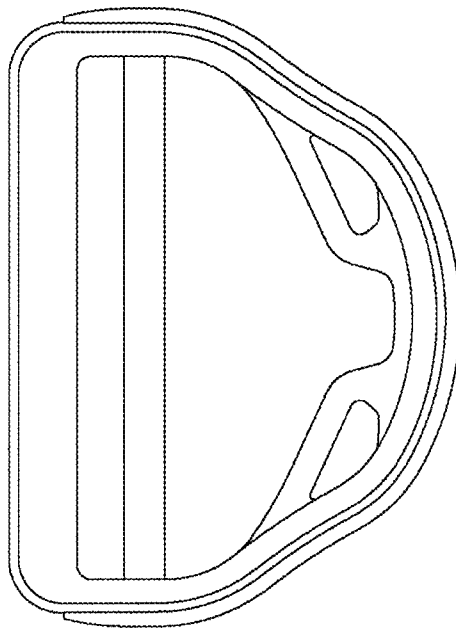

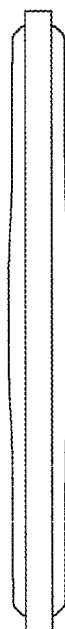

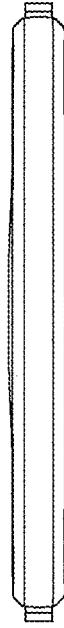

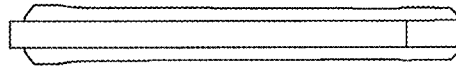

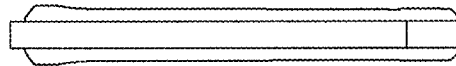
