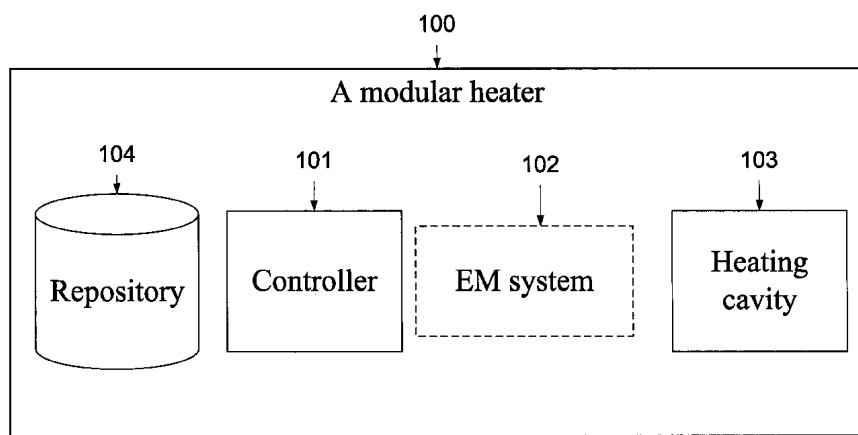

(57) **Abstract:** A system for heating one or more objects. The system comprises a first housing comprising a power unit configured for generating radio frequency (EM) radiation, one or more second housings comprising a heating unit having a cavity for positioning one or more objects, and one or more EM radiation conducting elements configured for conducting the EM radiation from the power unit to the cavity for heating the one or more objects. The first housing and one or more of the second housings are physically separated from one another.
