
(57) **CLAIM**

The ornamental design for a culture plate reader, as shown and described.

DESCRIPTION

FIG. 1 is a front, right, and top perspective view of a culture plate reader showing the tray in an open configuration; FIG. 2 is a front view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a right-side view thereof; FIG. 5 is a left-side view thereof; FIG. 6 is a top view thereof; FIG. 7 is a bottom view thereof; FIG. 8 is a front, right, and top perspective view of the culture plate reader showing the tray in a closed configuration; FIG. 9 is a front view thereof; FIG. 10 is a rear view thereof; FIG. 11 is a right-side view thereof; FIG. 12 is a left-side view thereof; FIG. 13 is a top view thereof; and, FIG. 14 is a bottom view thereof. The broken lines in the drawings depict portions of the culture plate reader that form no part of the claimed design.



























