The ornamental design for a light fixture, substantially as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a light fixture showing my new design, the rear elevation view being a mirror image thereof;

FIG. 2 is a top plan view thereof, shown at a reduced scale;



FIG. 3 is a right side elevation view thereof;










