
(57) **CLAIM**

The ornamental design for an extruded vinyl rub rail, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of an extruded vinyl rub rail embodying our new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is rear elevation view thereof;
FIG. 4 is a right side elevation view thereof, from which the left side elevation view is a mirror image;
FIG. 5 is a bottom plan view thereof; and,
FIG. 6 is a top plan view thereof.










