The ornamental design for a bottle and collar kit, as shown and described.

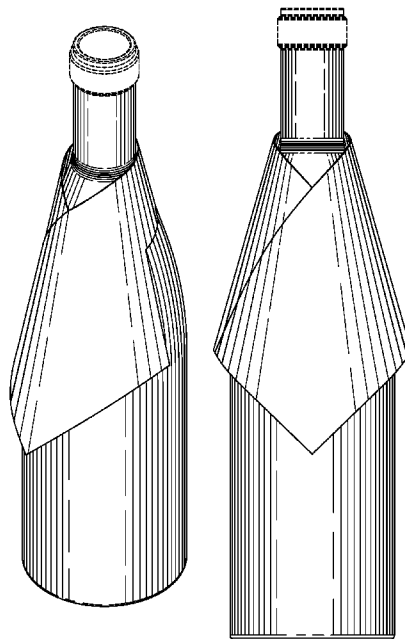
DESCRIPTION

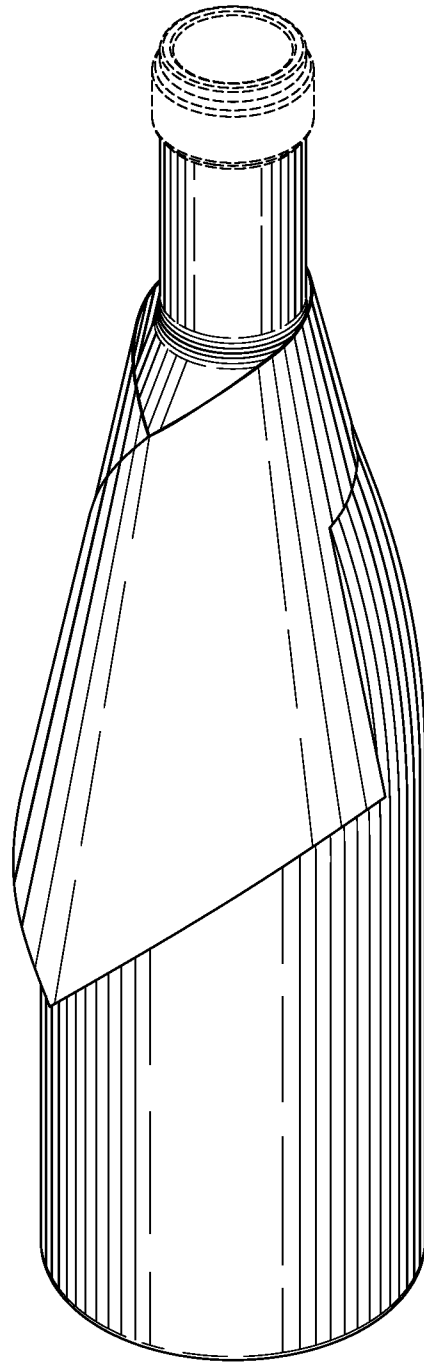

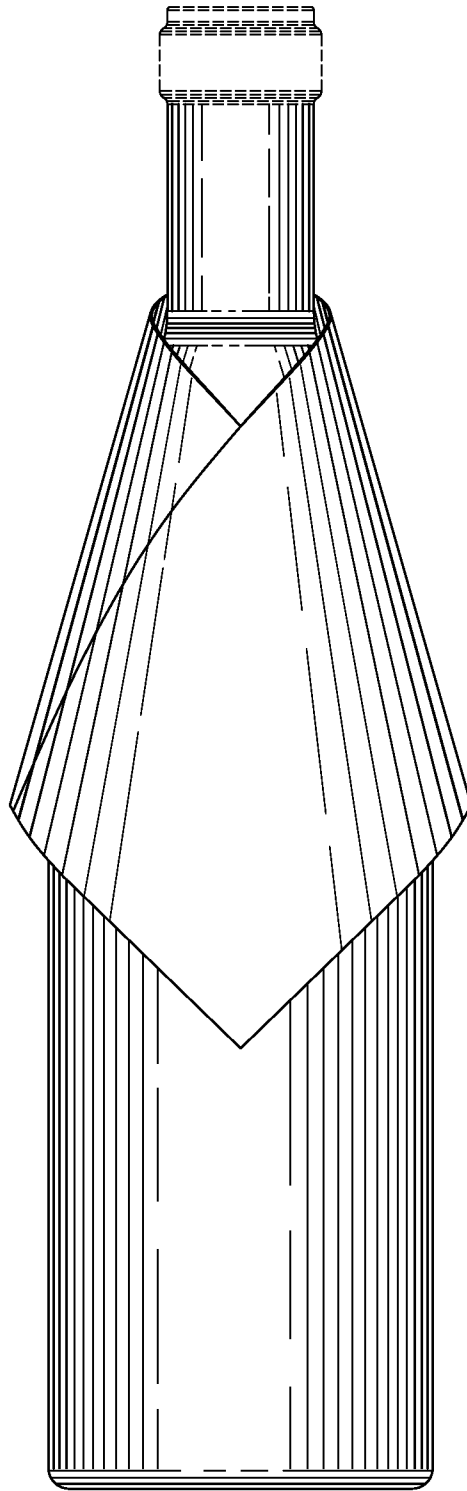

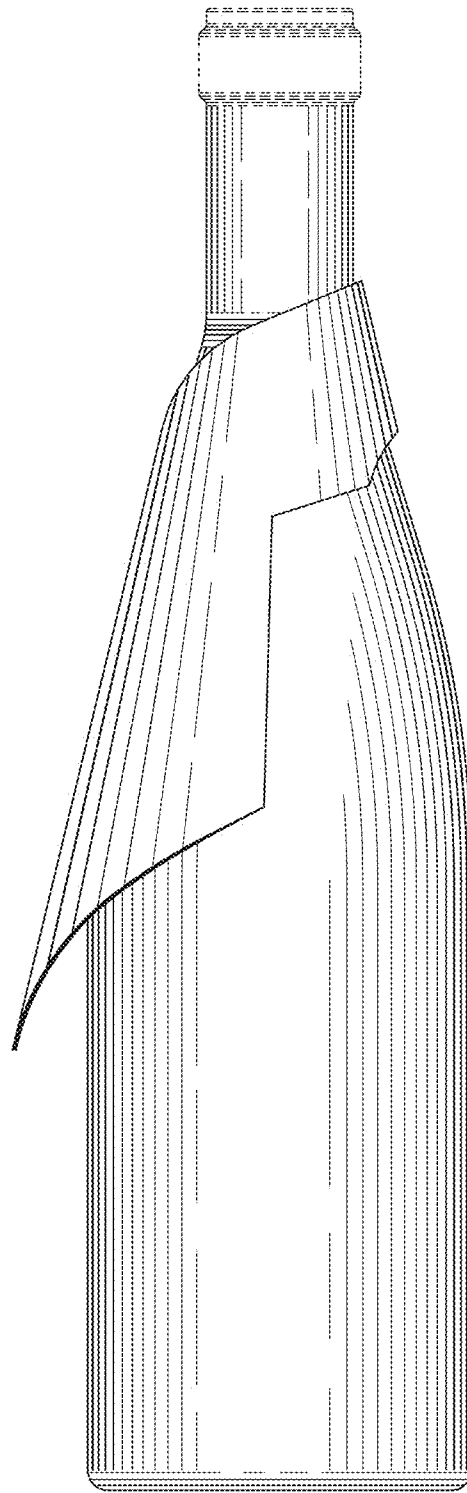

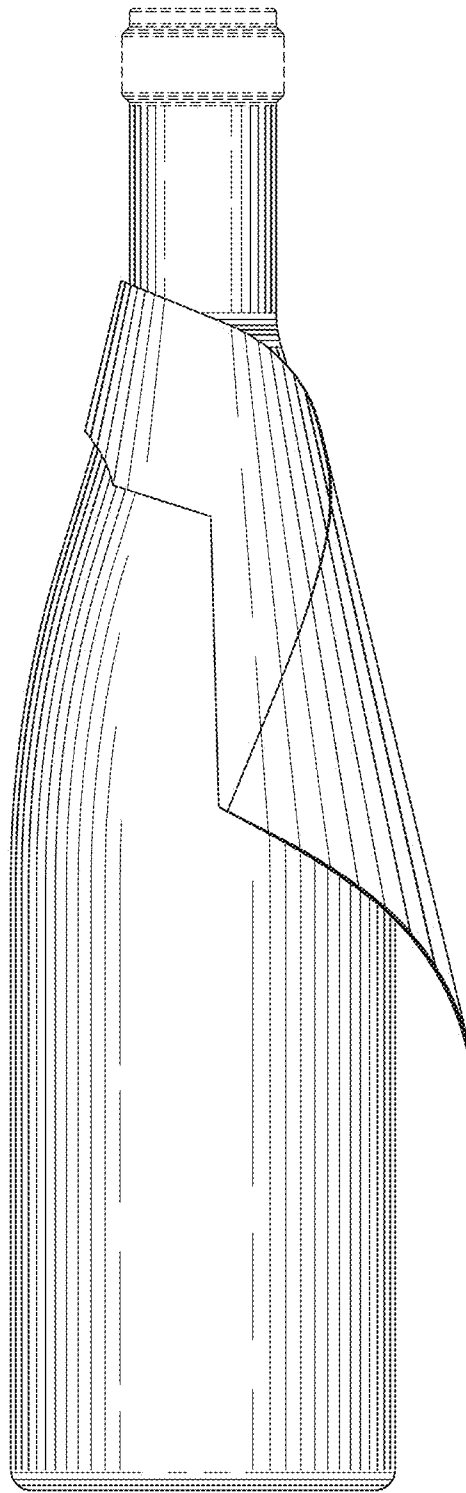

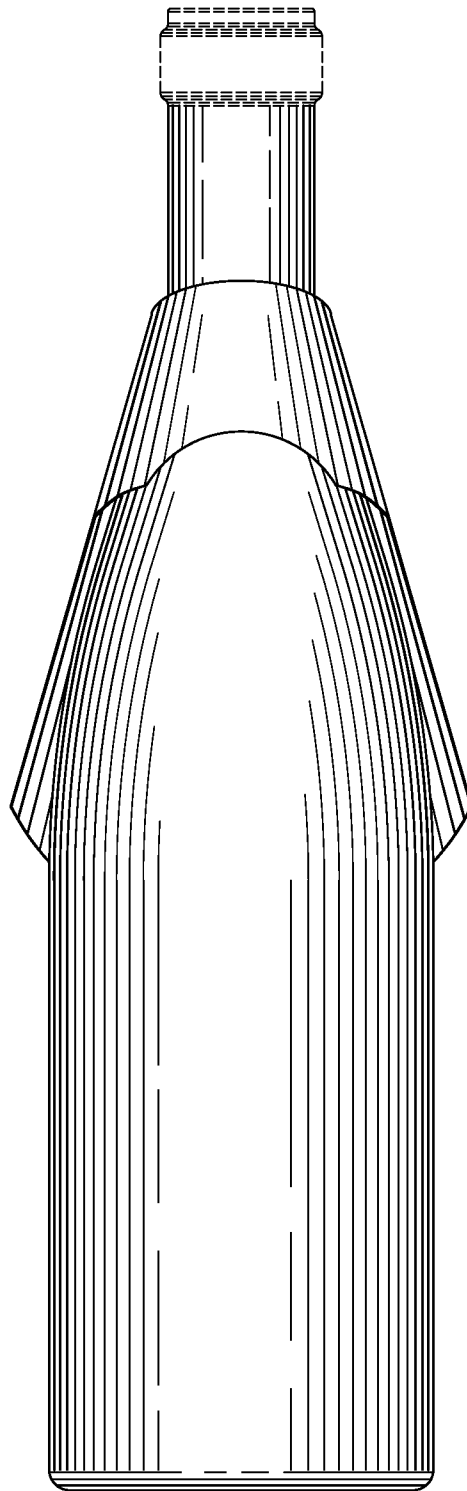

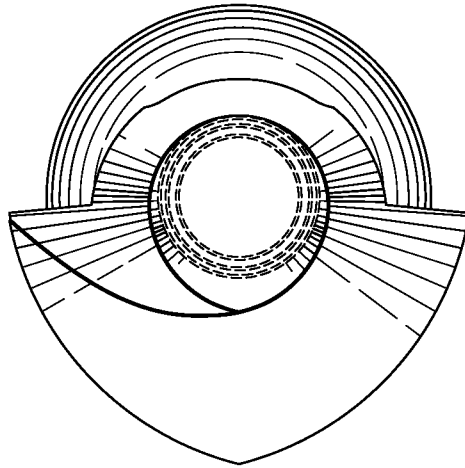

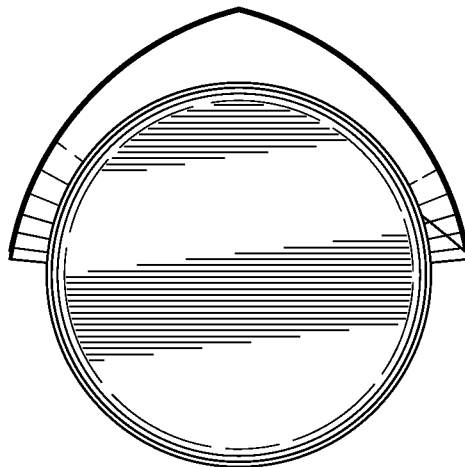
