What is claimed is the ornamental design for a hair clip holder, as shown and described.



DESCRIPTION

FIG. 1 is a perspective view of a hair clip holder, showing the new design in an open position;
 FIG. 2 is a front elevational view thereof;
 FIG. 3 is a rear elevational view thereof;
 FIG. 4 is a left-side elevational view thereof, the right-side elevational view being a mirror image thereof;
 FIG. 5 is a top plan view thereof;
 FIG. 6 is a bottom plan view thereof;
 FIG. 7 is a perspective view thereof in a closed position;
 FIG. 8 is a front elevational view of FIG. 7;
 FIG. 9 is a rear elevational view of FIG. 7;
 FIG. 10 is a right-side elevational view of FIG. 7, the left-side elevational view being a mirror image thereof;
 FIG. 11 is a top plan view of FIG. 7; and,
 FIG. 12 is a bottom plan view of FIG. 7.

The broken lines showing hair clips in FIG. 1 are included for the purpose of illustrating the invention in use, and form no part of the claimed design.

The dashed lines shown in FIGS. 1, 5-9 and 11 are shown to indicate stitching and form part of the claimed design.


















