
(57) **CLAIM**

We claim the ornamental design for the aerating wine glass, as shown and described in the drawings attached.

DESCRIPTION

FIG. 1 is a front isometric view of the aerating wine glass, showing our ornamental design; FIG. 2 is top orthographic view of the aerating wine glass; FIG. 3 is front elevation view of the aerating wine glass; and, FIG. 4 is a bottom orthographic view of the aerating wine glass.








