FIG. 4 is a front view of the design;

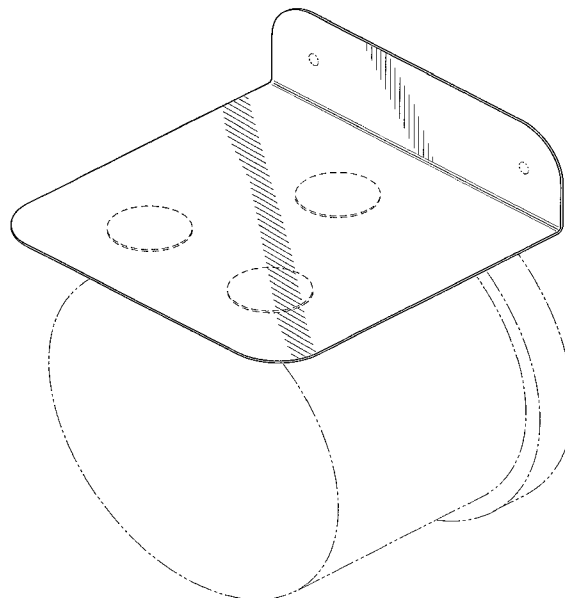
FIG. 5 is a rear view of the design;

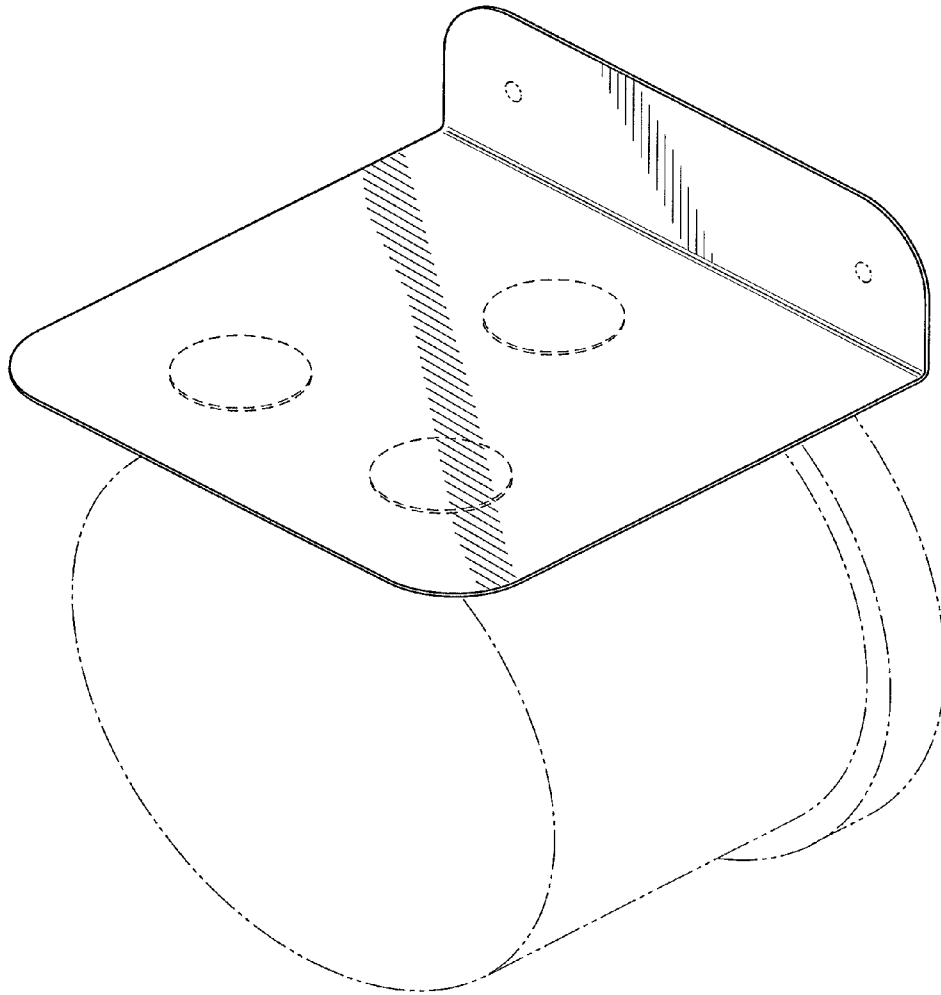

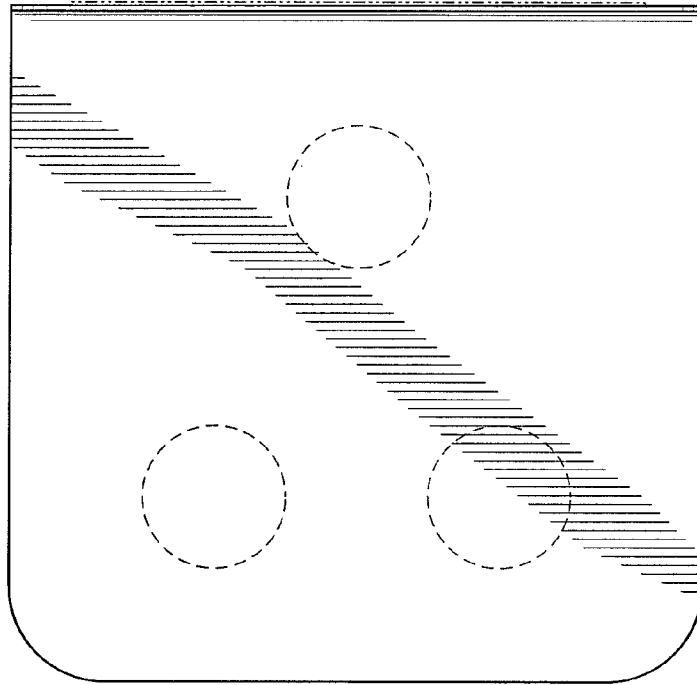

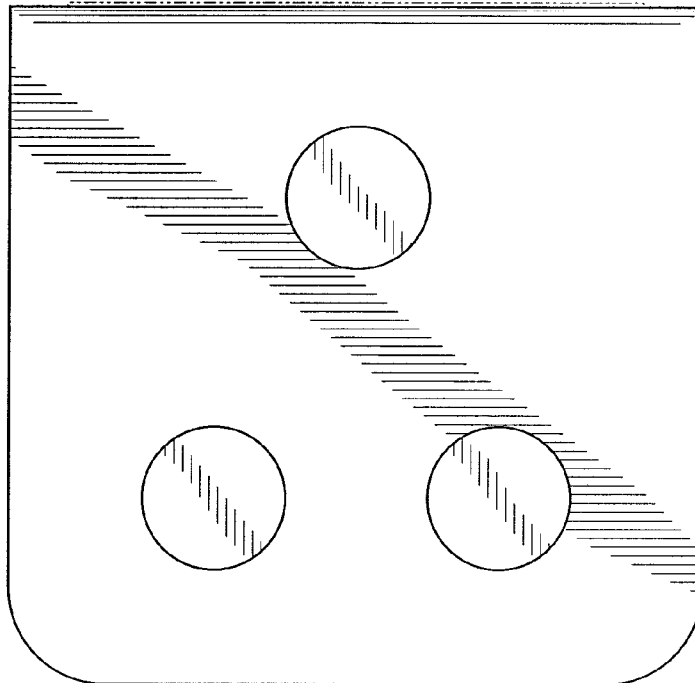

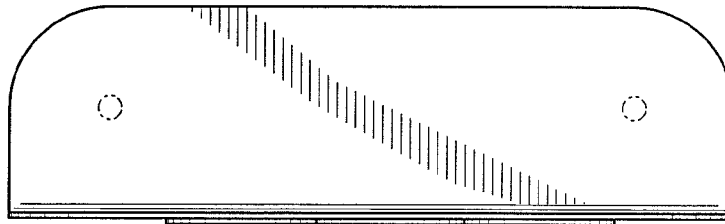

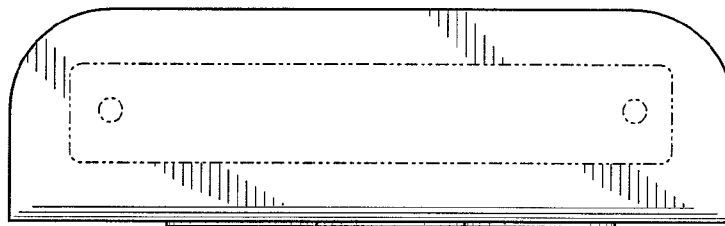

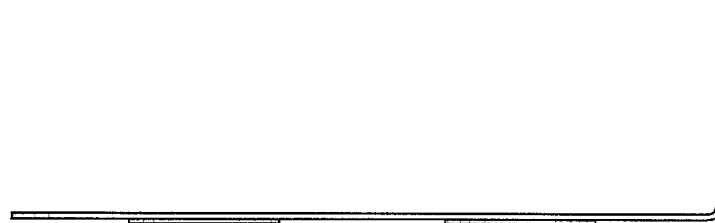

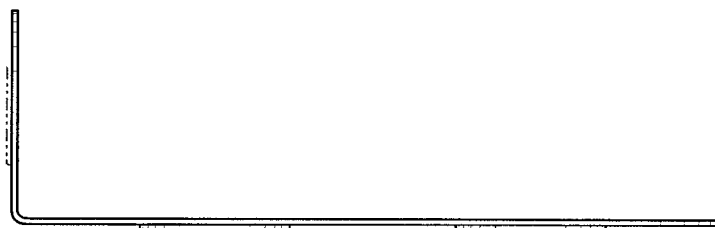
