
CLAIM

The ornamental design for a two pocket small framer pouch, as shown and described.

DESCRIPTION

FIG. 1 is a front, right perspective view in accordance with a new two pocket small framer pouch design; FIG. 2 is a front view of the design of FIG. 1; FIG. 3 is a rear view of the design of FIG. 1; FIG. 4 is a left side view of the design of FIG. 1; FIG. 5 is a right side view of the design of FIG. 1; FIG. 6 is a top view of the design of FIG. 1; and, FIG. 7 is a bottom view of the design of FIG. 1. The broken lines depict environmental structure and form no part of the claimed design.














