CLAIM

The ornamental design for a cordless leaf blower head,
as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a cordless blower head
showing the new design;

FIG. 2 is a right side elevational view of the cordless
blower head;

FIG. 3 is front elevational view of the cordless blower
head;


FIG. 4 is a left side elevational view of the cordless
blower head;

FIG. 5 is a rear elevational view of the cordless blower
head;

FIG. 6 is a top elevational view of the cordless blower
head; and,

FIG. 7 is a bottom elevational view of the cordless

claimed design.
















