
(57) **CLAIM**

The ornamental design for a turning toy, as shown and described.

DESCRIPTION

FIG. 1 is a first perspective view of our turning toy; FIG. 2 is a second perspective view thereof; FIG. 3 is a side view thereof; FIG. 4 is a top view thereof; FIG. 5 is a bottom view thereof; and, FIG. 6 is a cross sectional view thereof, taken in a plane containing a vertical axis through its center. The design is axisymmetric about a vertical axis through its center.












