(57) **ABSTRACT**

A new cultivar of *Dianthus* plant named ‘Angel of Forgiveness’ that is characterized by a compact habit and a large number of double flowers having red-purple petals with white markings and pink margins.

Botanical classification: *Dianthus plumarius*.

BACKGROUND OF THE INVENTION

The present invention relates to a new and distinct cultivar of *Dianthus* plant botanically known as *Dianthus plumarius* and hereinafter referred to by the cultivar name ‘Angel of Forgiveness’.

The new *Dianthus* is the product of a planned breeding program conducted by the inventor in Auckland, New Zealand. The objective of the breeding program is to create new *Dianthus* cultivars with attractive flower colors.

‘Angel of Forgiveness’ originated from a crossing in 1989 of the female or seed parent *Dianthus plumarius* identified as ‘Counterpart’ (not patented) and the male or pollen parent *Dianthus plumarius* identified as ‘Neat n Tidy’ (not patented). The resulting seeds were subsequently planted and grown. The cultivar ‘Angel of Forgiveness’ was selected by the inventor in 2001 as a single plant within the progeny of the stated cross in a cultivated area of Auckland, New Zealand.

Asexual reproduction of the new cultivar ‘Angel of Forgiveness’ first occurred by terminal cuttings in 2002 in Auckland, New Zealand. Since that time, under careful observation, the unique characteristics of the new cultivar have been uniform, stable and reproduced true to type in successive generations of asexual reproduction.

SUMMARY OF THE INVENTION

The following represent the distinguishing characteristics of the new *Dianthus* cultivar ‘Angel of Forgiveness’. These traits in combination distinguish ‘Angel of Forgiveness’ as a new and distinct cultivar apart from other existing known varieties of *Dianthus*.

1. *Dianthus* ‘Angel of Forgiveness’ exhibits a large number of double flowers having red-purple petals with white markings and pink margins.
2. *Dianthus* ‘Angel of Forgiveness’ exhibits a compact habit.

The closest comparison cultivar is *Dianthus* ‘Checkmate’ (not patented). ‘Angel of Forgiveness’ is distinguishable from ‘Checkmate’ by the following characteristics:

1. ‘Angel of Forgiveness’ has red-purple petals with center white markings and pink margins. In comparison, the petals of ‘Checkmate’ are darker red in color with irregular shaped white markings.

5 ‘Angel of Forgiveness’ is distinguishable from the female or seed parent ‘Counterpart’ by the following characteristics:

1. ‘Angel of Forgiveness’ has red-purple petals with center white markings and pink margins. In comparison, ‘Counterpart’ has lighter colored red petals with center pink markings and pink margins
2. ‘Angel of Forgiveness’ has smaller diameter flowers when compared to the diameter of the flowers of ‘Counterpart’.

15 ‘Angel of Forgiveness’ is distinguishable from the male or pollen parent ‘Neat n Tidy’ by the following characteristics:

1. ‘Angel of Forgiveness’ has red-purple petals with center white markings and pink margins. In comparison, ‘Neat n Tidy’ has darker colored red petals with center white markings and white margins
2. ‘Angel of Forgiveness’ has a larger number of flowers when compared to the number of flowers on ‘Neat n Tidy’.

BRIEF DESCRIPTION OF THE DRAWING

The accompanying photograph illustrates the distinguishing traits of *Dianthus* ‘Angel of Forgiveness’. The plant in the photograph shows an overall view of an 8 month old plant. The photograph was taken using conventional techniques and although colors may appear different from actual colors due to light reflectance it is as accurate as possible by conventional photographic techniques.

BOTANICAL DESCRIPTION OF THE PLANT

The following is a detailed description of the new *Dianthus* cultivar named ‘Angel of Forgiveness’. Data was collected in Auckland, New Zealand, from 8 month old greenhouse grown plants in 10 cm. diameter containers. The time of year was Summer in the Southern Hemisphere and the temperature range was 18-26 degrees Centigrade during the day and 10-18 degrees Centigrade at night. The light level was natural light. No photoperiodic treatments or growth retardants were used. Color determinations are in accordance with The Royal

Horticultural Society Colour Chart 2007 edition, except where general color terms of ordinary dictionary significance are used. The growing requirements are similar to the species. 'Angel of Forgiveness' has not been tested under all possible conditions and phenotypic differences may be observed with variations in environmental, climatic, and cultural conditions, however, without any variance in genotype.

Botanical classification: *Dianthus plumarius* 'Angel of Forgiveness'.

Annual or perennial: Perennial.

Parentage: 'Angel of Forgiveness' is the product of the female or seed parent *Dianthus* 'Counterpart' and the male or pollen parent *Dianthus* 'Neat n Tidy'.

Vigor: Moderate.

Growth habit: Upright.

Plant shape: Rounded.

Suitable container size: 10 cm. pots.

Height: 20 cm. in height.

Width: 20 cm. in width.

Low temperature tolerance: -15° Centigrade.

High temperature tolerance: 35° Centigrade.

Propagation: Terminal cuttings.

Crop time: Approximately 4 months.

Root system: Fine and fibrous.

Petal color when opening (upper side).—61B with markings of N155A and margins 62A.

Petal color when opening (under side).—61B.

Petal color fully opened (upper side).—61B with markings of N155A and margins 62A.

Self-cleaning or persistent.—Persistent.

Fruit and seed: Fruit and seed production has not been observed.

1. A new and distinct variety of *Dianthus* plant named 'Angel of Forgiveness' as described and illustrated.
