(57) **CLAIM**

The ornamental design for a transfer assistance machine, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a transfer assistance machine showing our new design;

FIG. 2 is a rear view thereof;

FIG. 3 is a left side view thereof;

FIG. 4 is a right side view thereof;

FIG. 5 is a top view thereof;

FIG. 6 is a bottom view thereof;

FIG. 7 is a front, left side perspective view thereof;


FIG. 8 is a rear, right side perspective view thereof;

FIG. 9 is a right side view thereof with the holding part holding the body of the care receiver in a seating position; and,




















