(57) **CLAIM**

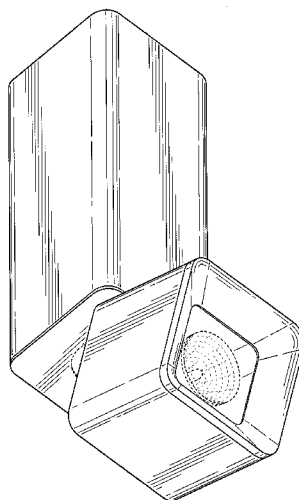
The ornamental design for a light fixture, as shown and described.

DESCRIPTION

FIG. 1 is a bottom perspective view of a light fixture in accordance with the present invention;
 FIG. 2 is a front view of the light fixture depicted in FIG. 1;
 FIG. 3 is a rear side view of the light fixture depicted in FIG. 1;
 FIG. 4 is a left side view of the light fixture depicted in FIG. 1;
 FIG. 5 is a right side view of the light fixture depicted in FIG. 1;
 FIG. 6 is a bottom view of the light fixture depicted in FIG. 1;
 FIG. 7 is a top view of the light fixture depicted in FIG. 1; and,
 FIG. 8 is a rear perspective view of the light fixture depicted in FIG. 1.

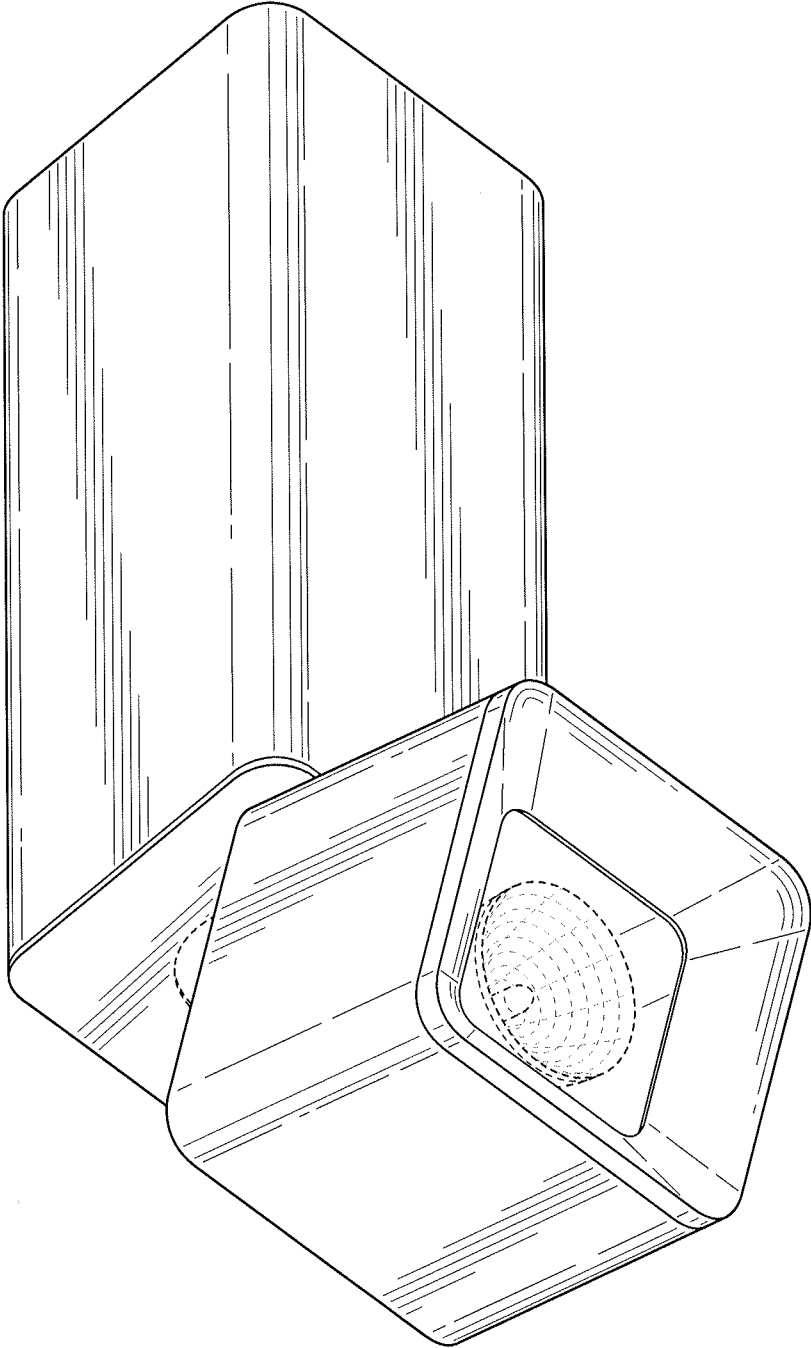

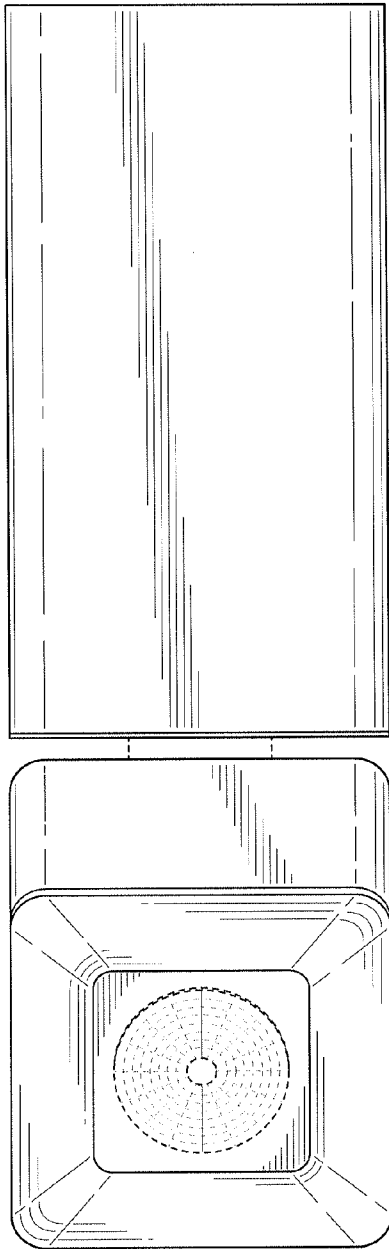

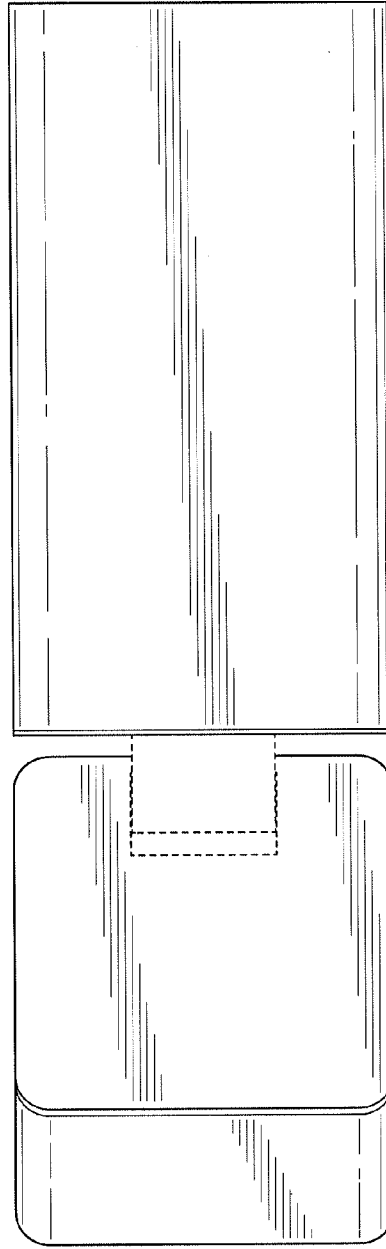

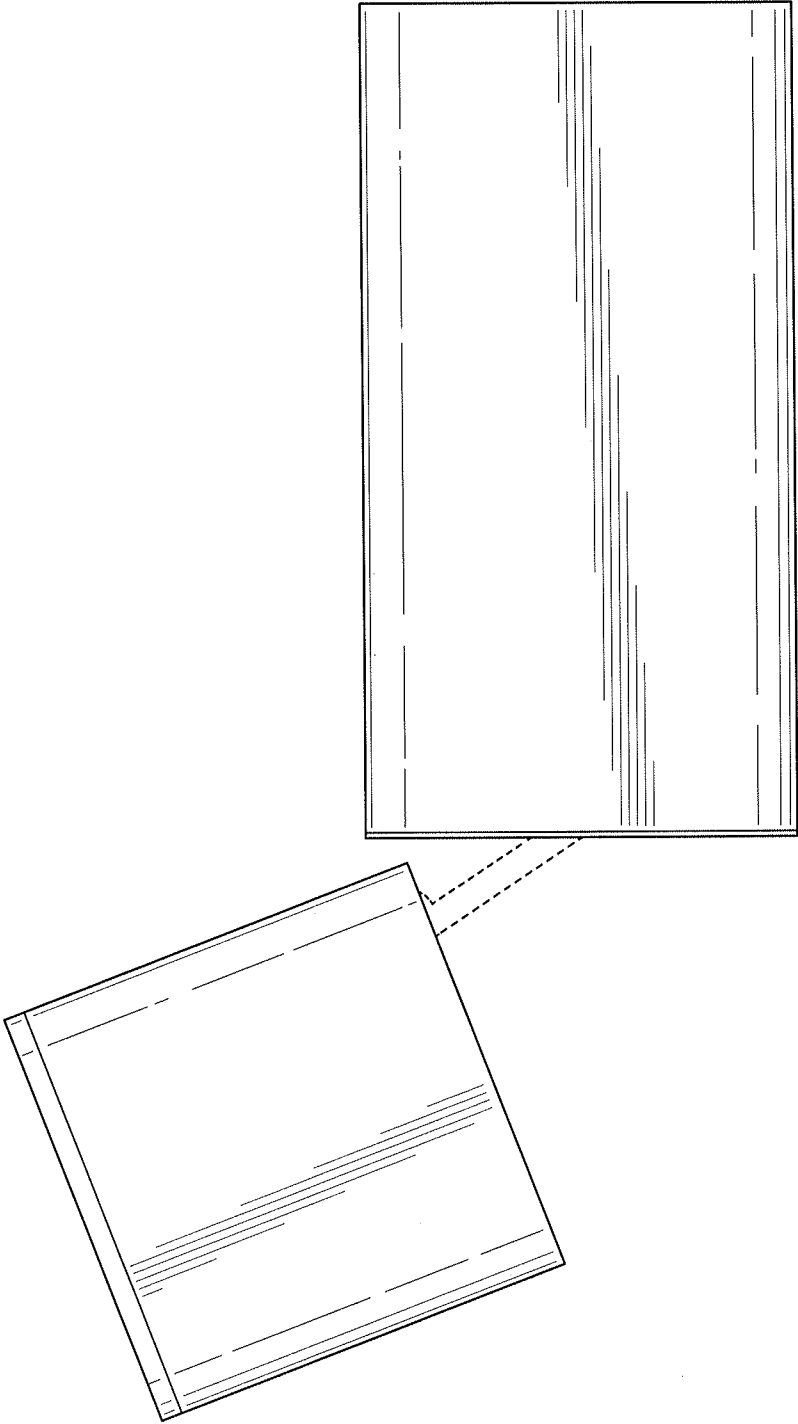

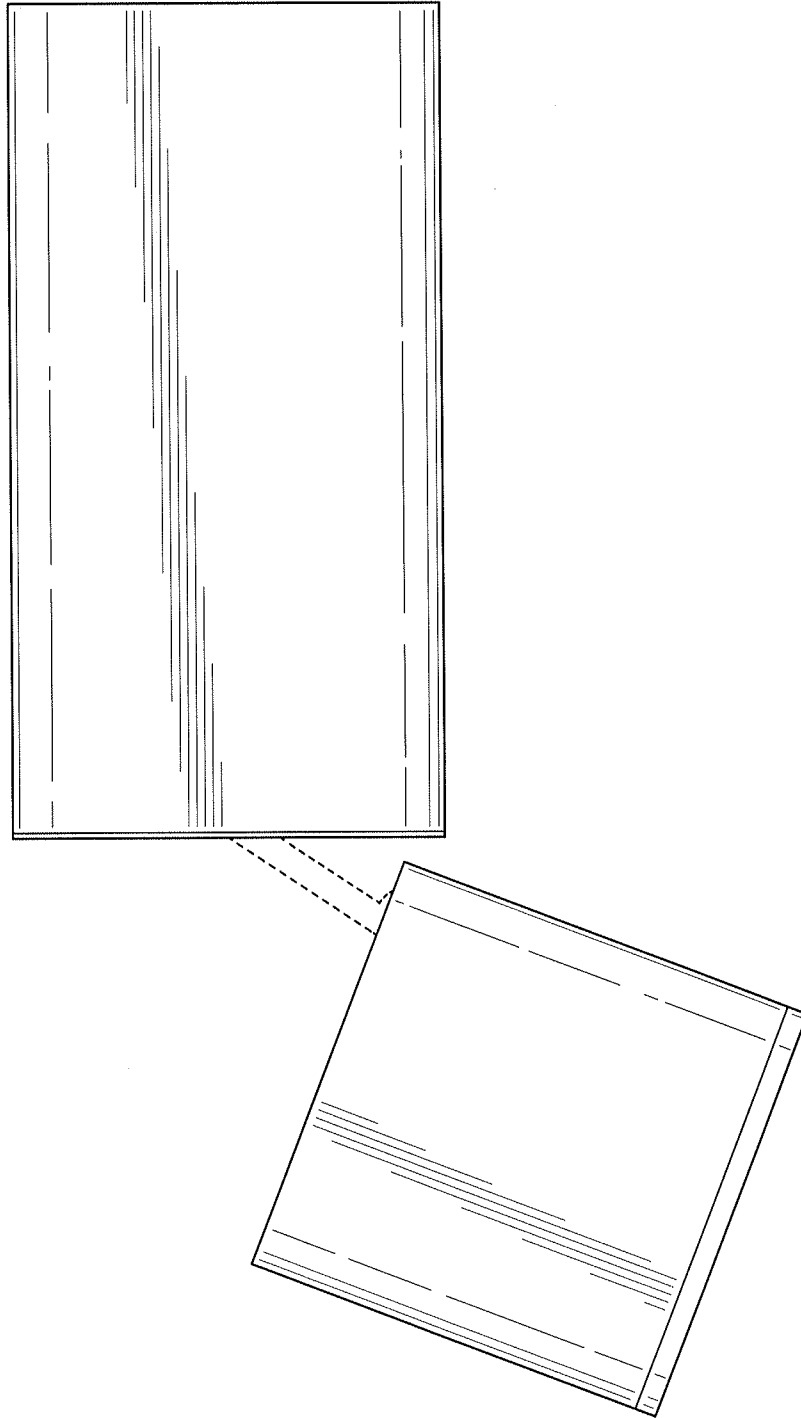

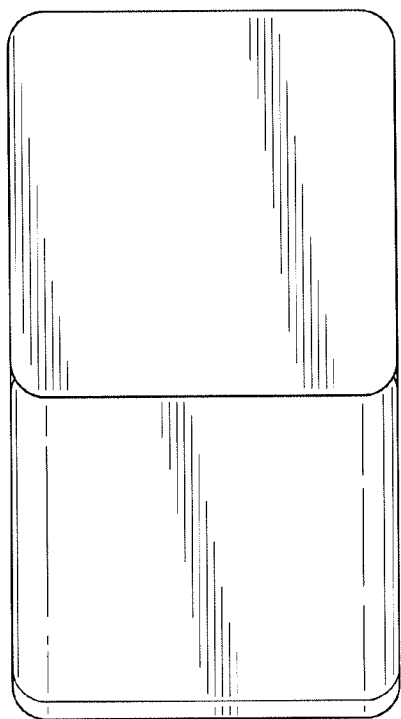

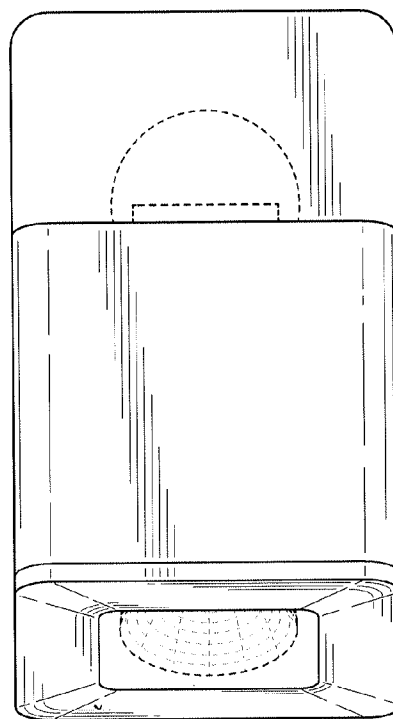

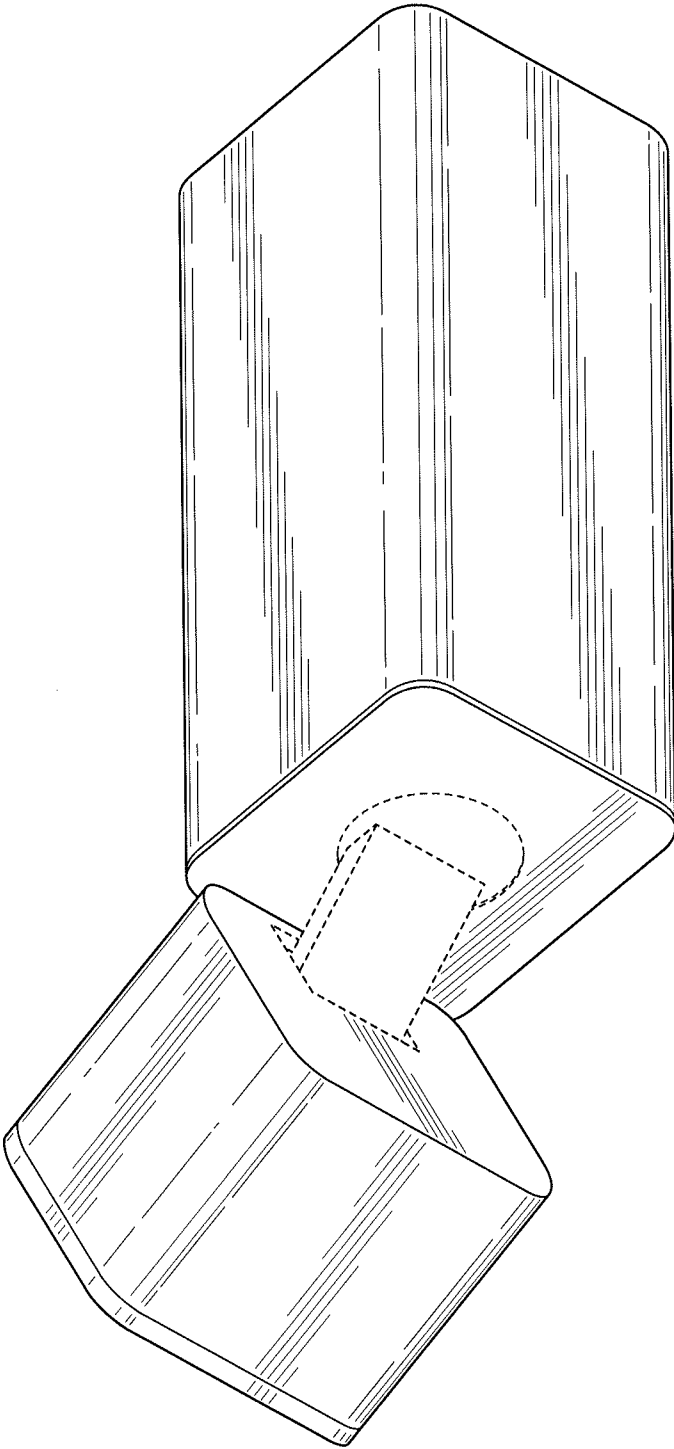
