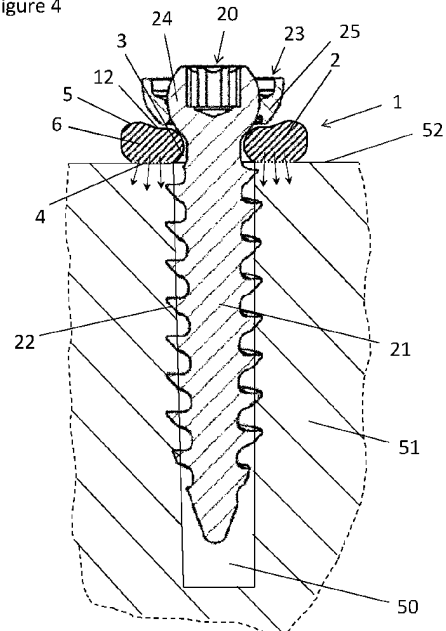

(54) **DEFORMABLE BODY AND COMBINATION OF SUCH DEFORMABLE BODY AND A SURGICAL SCREW ELEMENT**

(57) The present invention provides a deformable body, wherein the deformable body comprises a bone contact surface to be pressed against periosteum of a bone surface of a bone such that the bone contact surface adapts its shape to the shape of the bone surface, wherein the deformable body comprises one or more through-going openings and/or one or more fixation locations arranged to receive a fixation element, and wherein the deformable body comprises an anaesthetic that is released from or through the bone contact surface.
