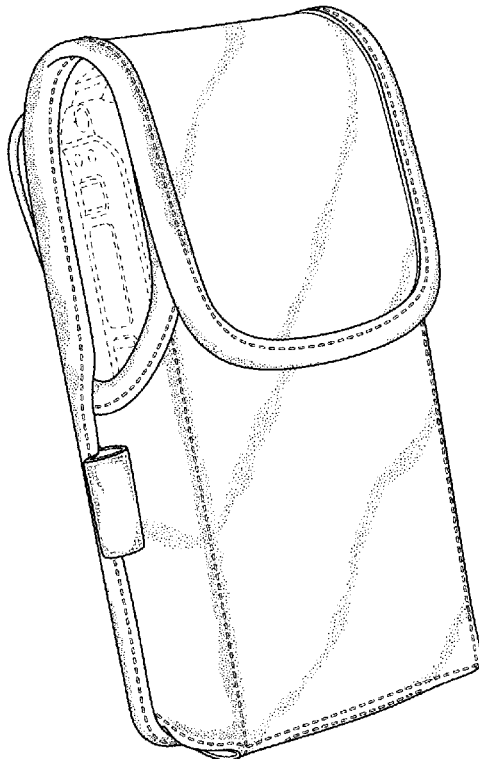
The ornamental design for a vertical phone pouch with closure and belt loop, as shown and described.

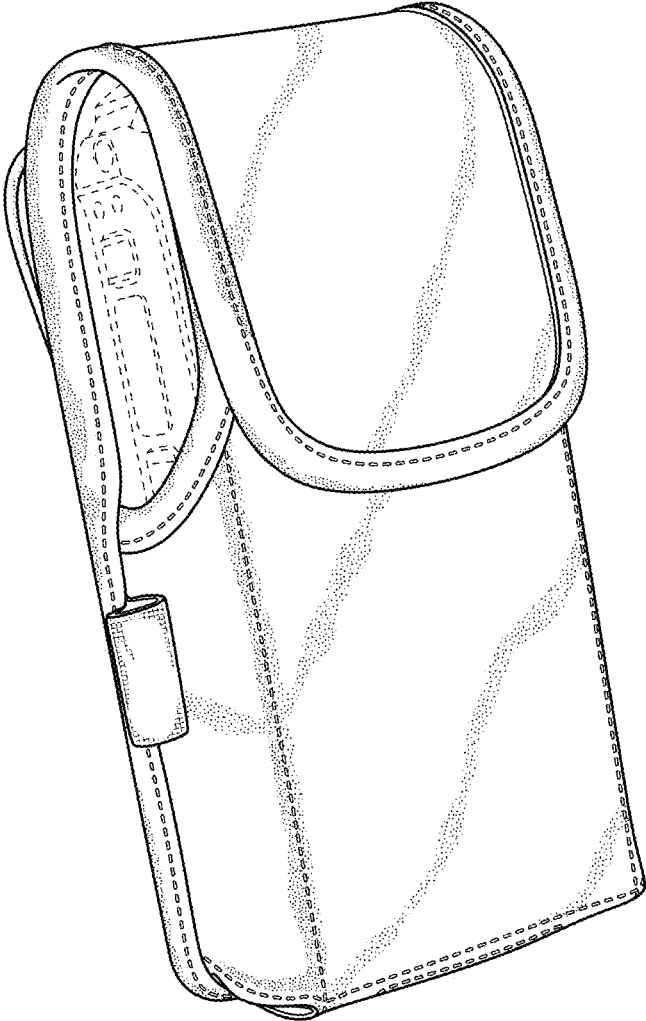
**DESCRIPTION**

FIG. 9 is a bottom plan view thereof.

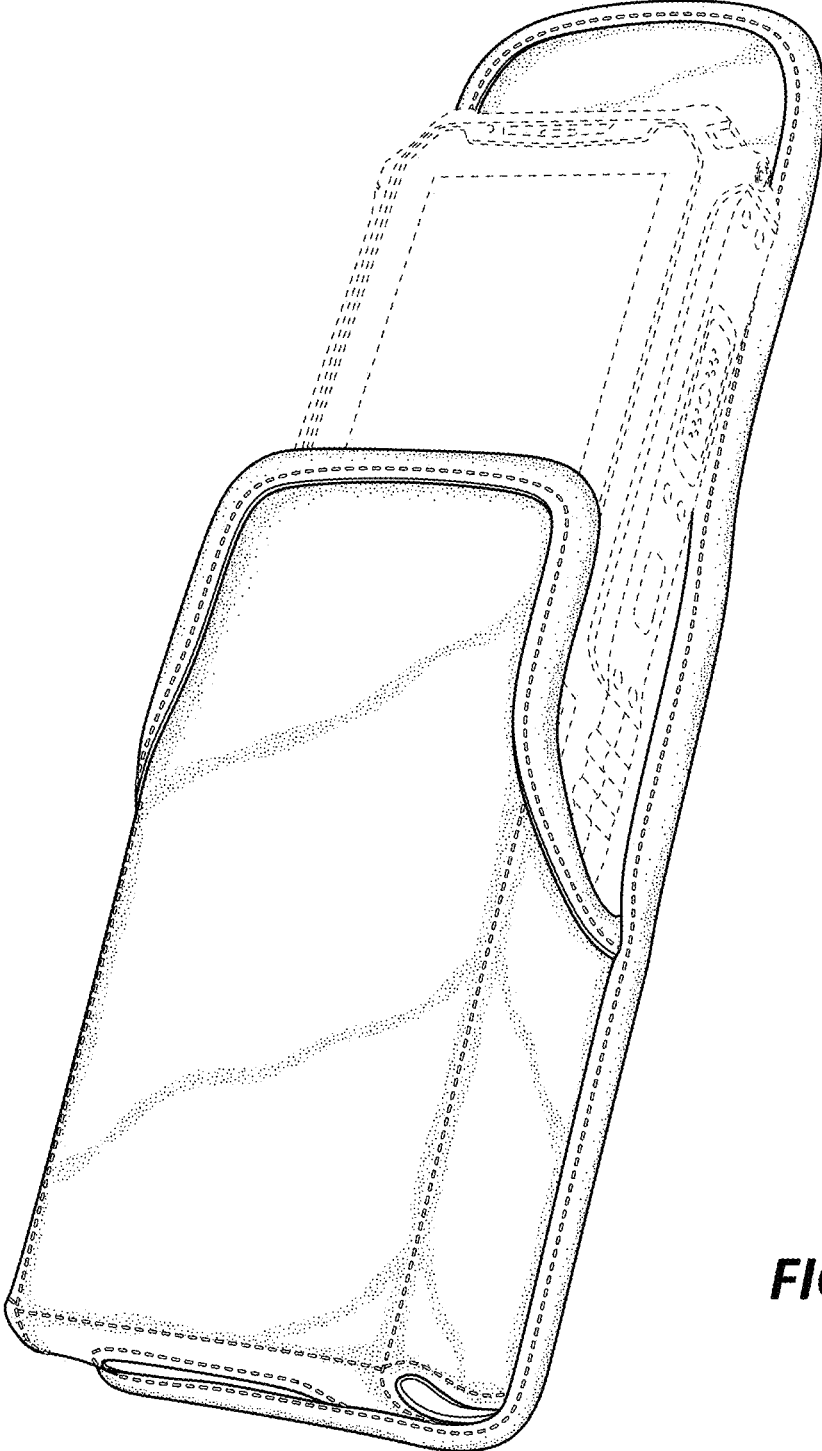

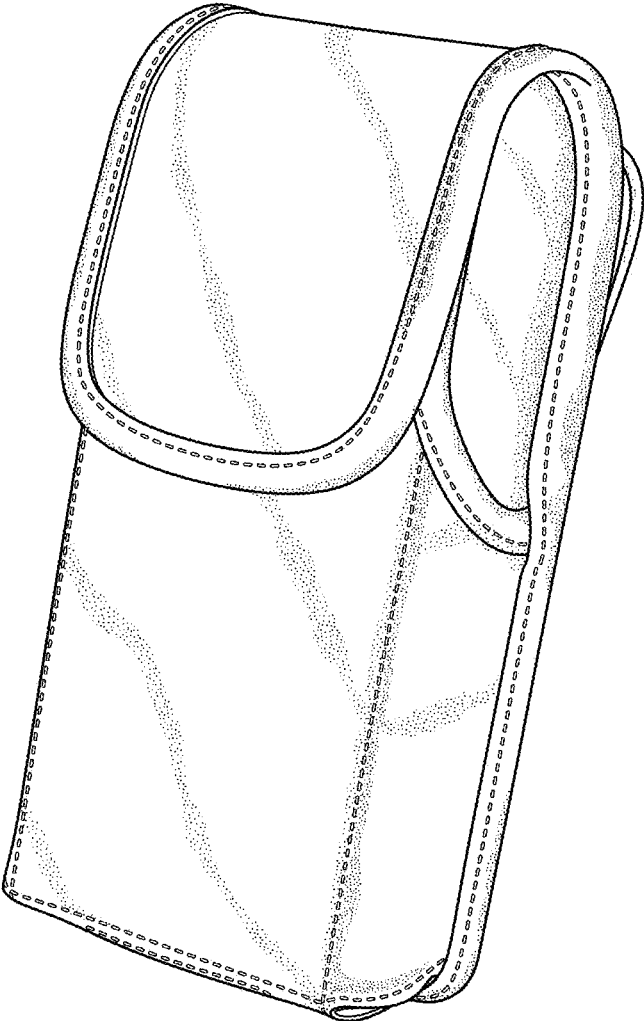




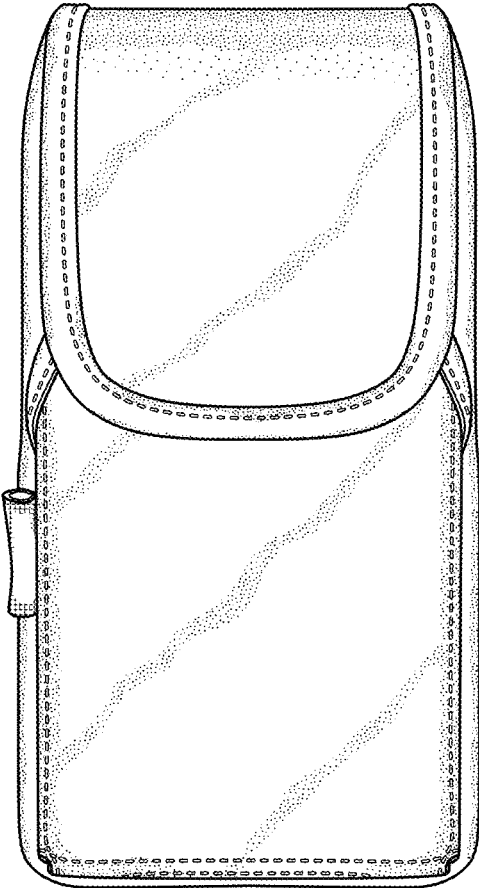

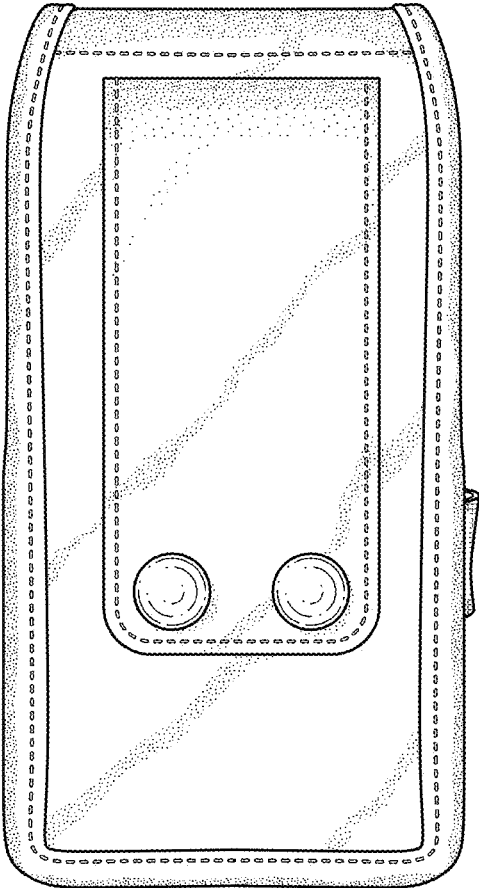

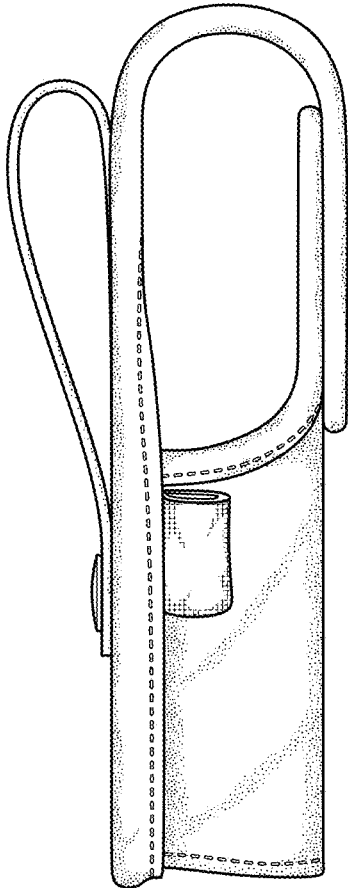

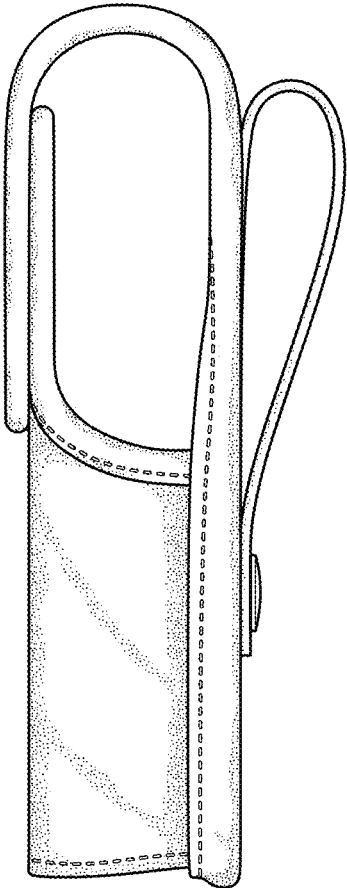

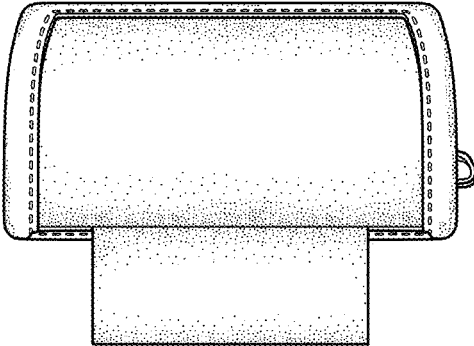

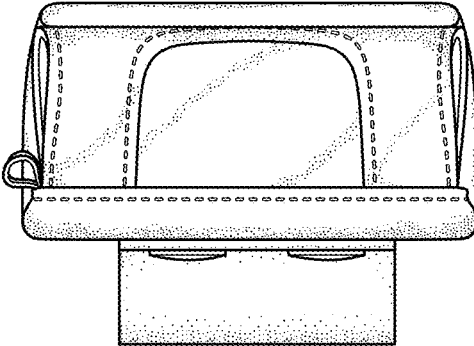
