The ornamental design for a flosser tip holding cartridge for interproximal flossing tips, as shown and described.

FIG. 2 is a top plan view thereof;

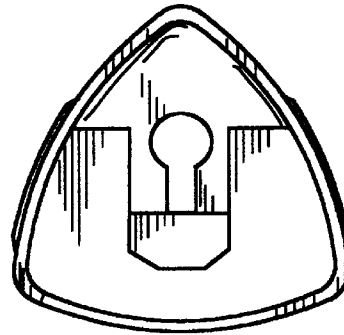
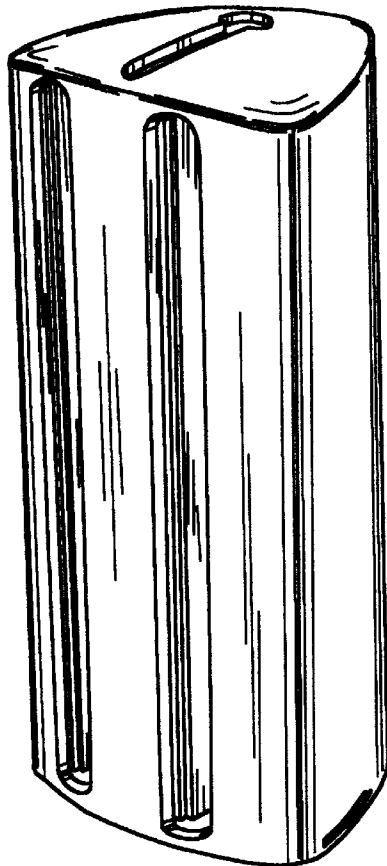
FIG. 3 is a front side elevation view thereof;

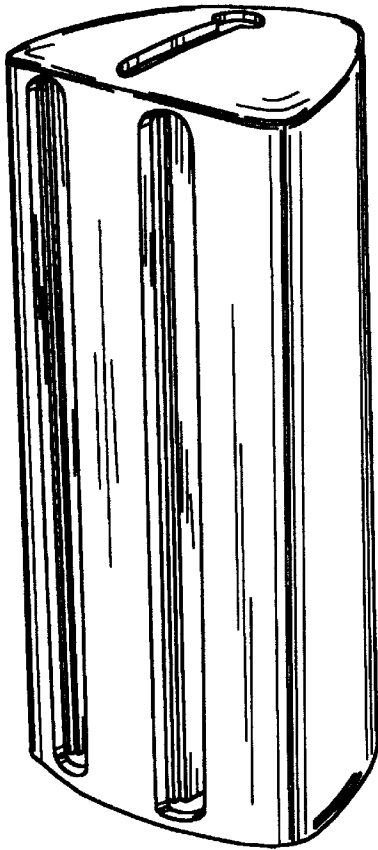
FIG. 4 is a left side elevation view thereof, with the right side elevation view being a mirror image thereof;

FIG. 5 is back side elevation view thereof; and,

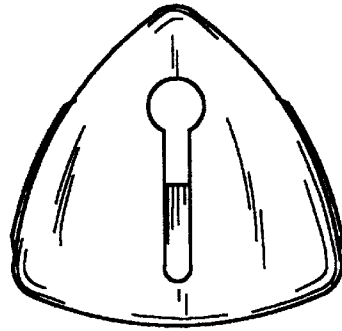
FIG. 6 is a bottom plan view thereof.

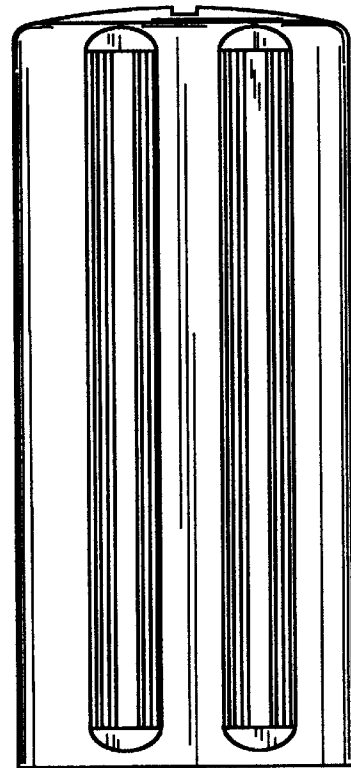




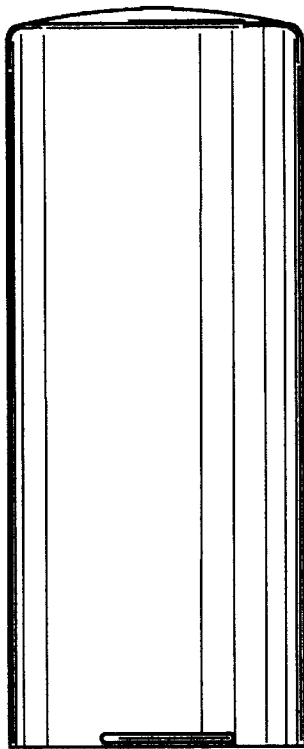

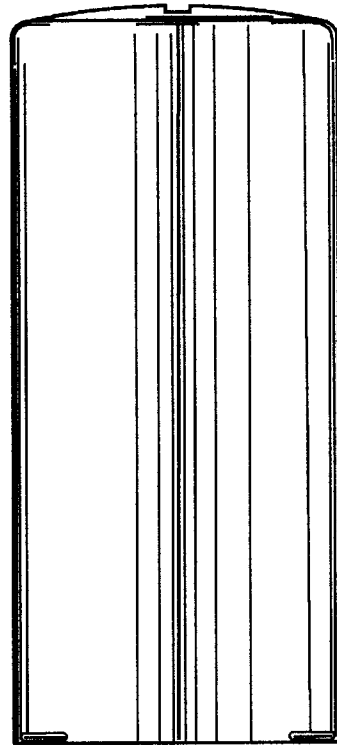

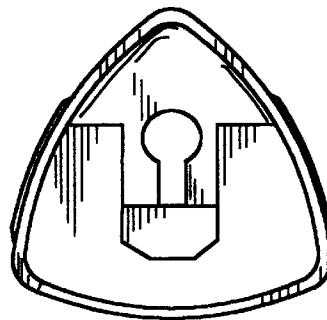
