The ornamental design for a lid grabber, as shown and described.



DESCRIPTION

FIG. 1 is a perspective view of the lid grabber;
FIG. 2 is a front plane view thereof, the rear plane being a mirror image;
FIG. 3 is a top plan view thereof;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a left side view thereof;
FIG. 6 is a cross sectional view taken in the direction of line 6-6 on FIG. 5; and,
FIG. 7 is a perspective view of FIG. 6.

The evenly broken lines are shown for the purpose of illustrating parts of the lid grabber that form no part of the claimed design. The dot-dot-dash lines shown on FIG. 5 are for the purpose of indicating a cross sectional view and form no part thereof.














