(57) **CLAIM**

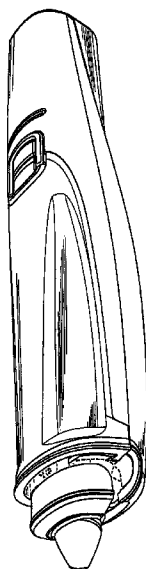
The ornamental design for a digital pen, as shown and described.

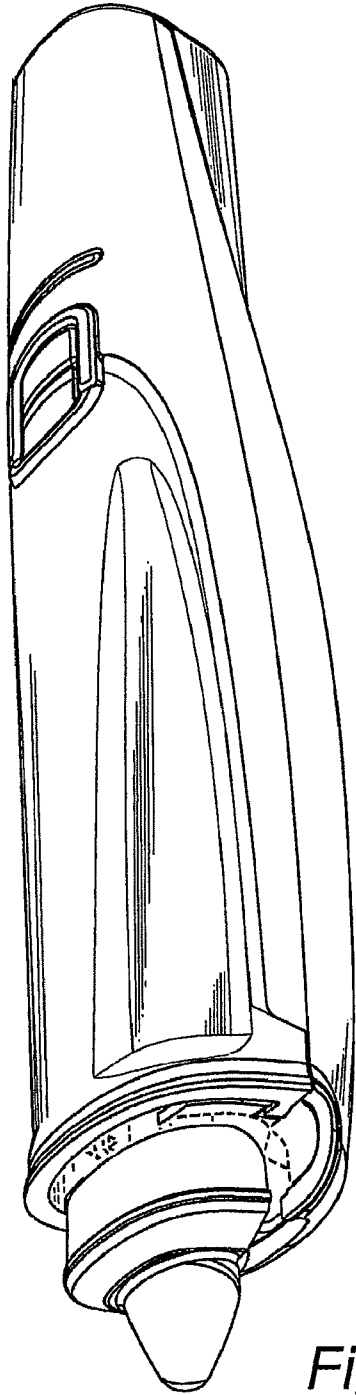

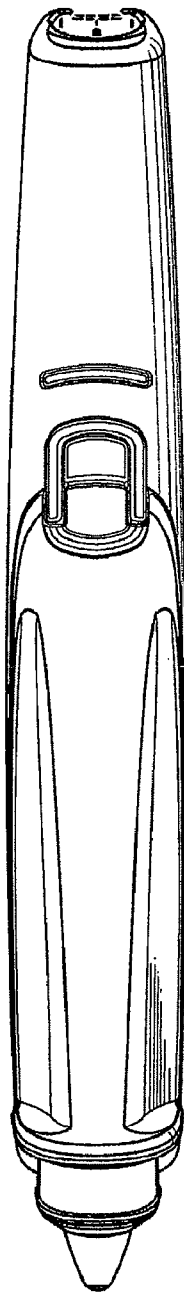

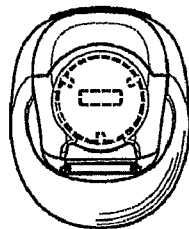
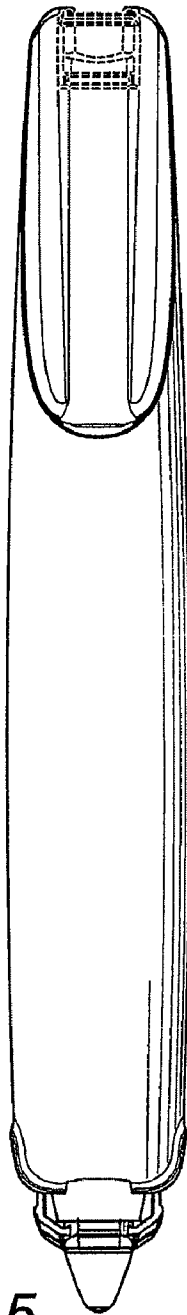
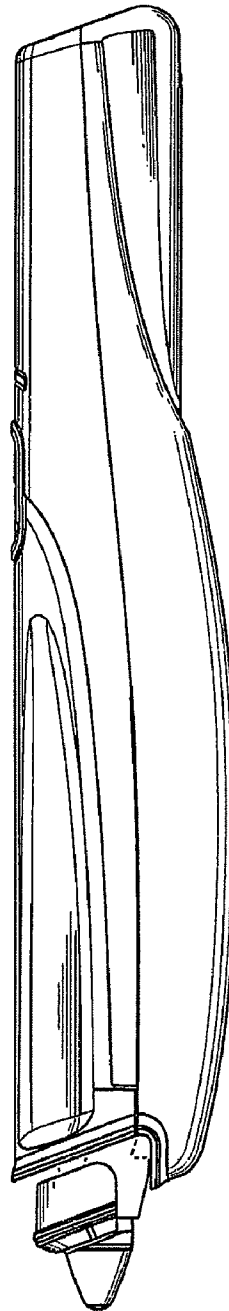


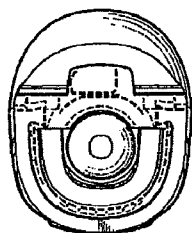
