
(57) **CLAIM**

The ornamental design for a sheet pile connector, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the sheet pile connector for connecting sheet piles according to my design;
 FIG. 2 is an end view of the sheet pile connector of FIG. 1, the opposite end view being a mirror image thereof;
 FIG. 3 is a right side view of the sheet pile connector of FIG. 1;
 FIG. 4 is a left side view of the sheet pile connector of FIG. 1;
 FIG. 5 is a top view of the sheet pile connector of FIG. 1; and
 FIG. 6 is a bottom view of the sheet pile connector of FIG. 1.
 The broken lines represent environment and form no part of the claimed design.








