
(57) **CLAIM**

The ornamental design for an ear cleaning device, as shown and described.

DESCRIPTION

FIG. 1 is a front, top, and left side perspective view of an ear cleaning device of the present disclosure;
FIG. 2 is a right side elevation view of the ear cleaning device of the present disclosure;
FIG. 3 is a left side elevation view of the ear cleaning device of the present disclosure;
FIG. 4 is a front elevation view of the ear cleaning device of the present disclosure;
FIG. 5 is a rear elevation view of the ear cleaning device of the present disclosure;
FIG. 6 is a top view of the ear cleaning device of the present disclosure; and,
FIG. 7 is a bottom view of the ear cleaning device of the present disclosure.














