(57) **CLAIM**

We claim the ornamental design for a fan, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a fan showing our new design;

FIG. 2 is a side view thereof;

FIG. 3 is a front view thereof;

FIG. 4 is a side view of the opposite side of FIG. 2;

FIG. 5 is a rear view thereof;

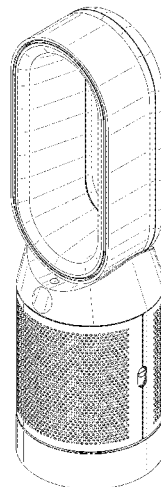
FIG. 6 is a top view thereof; and,

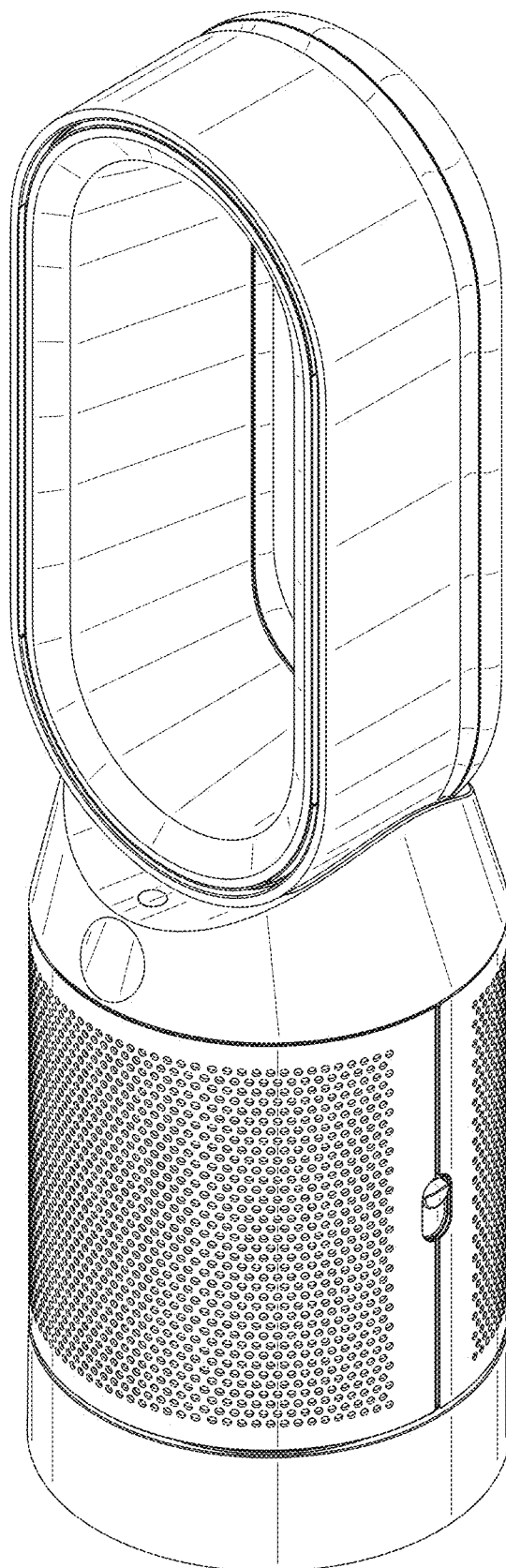

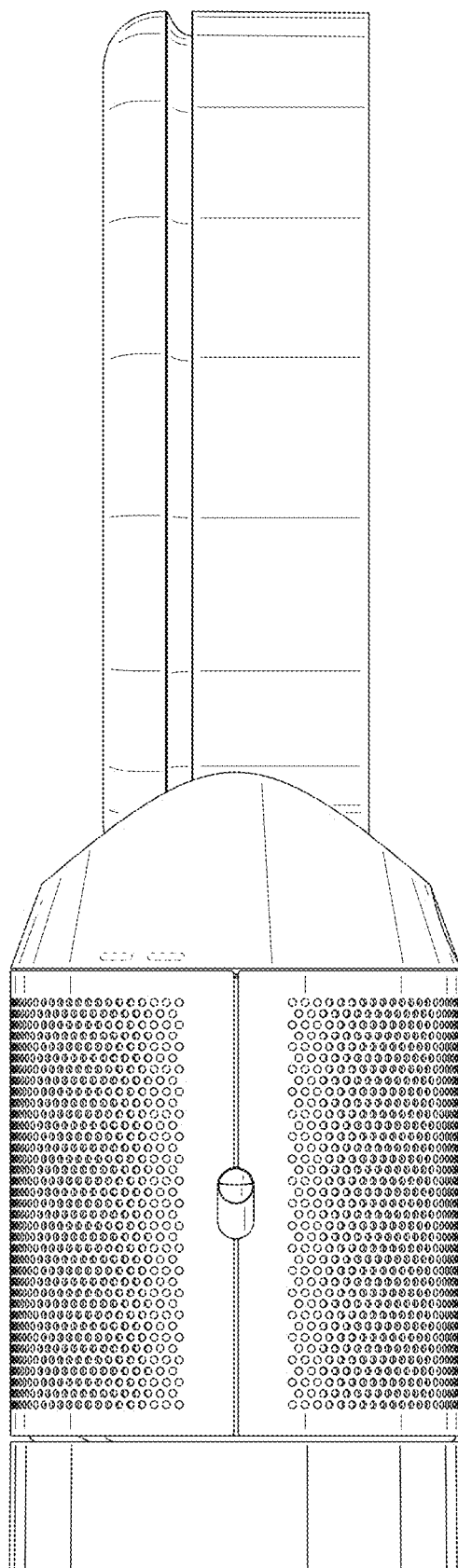

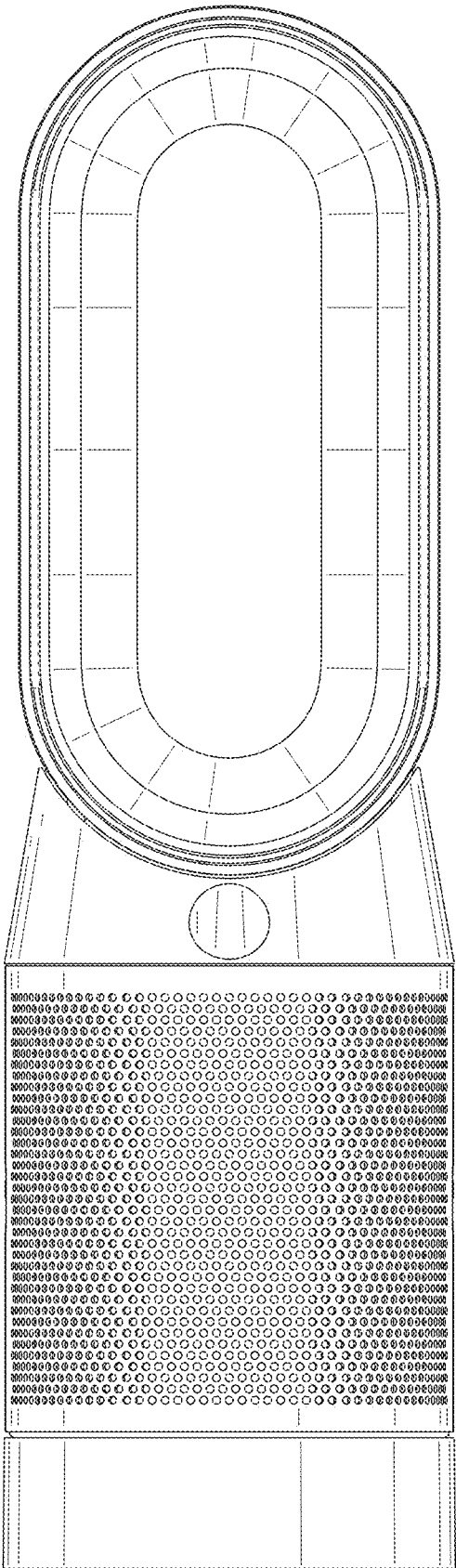

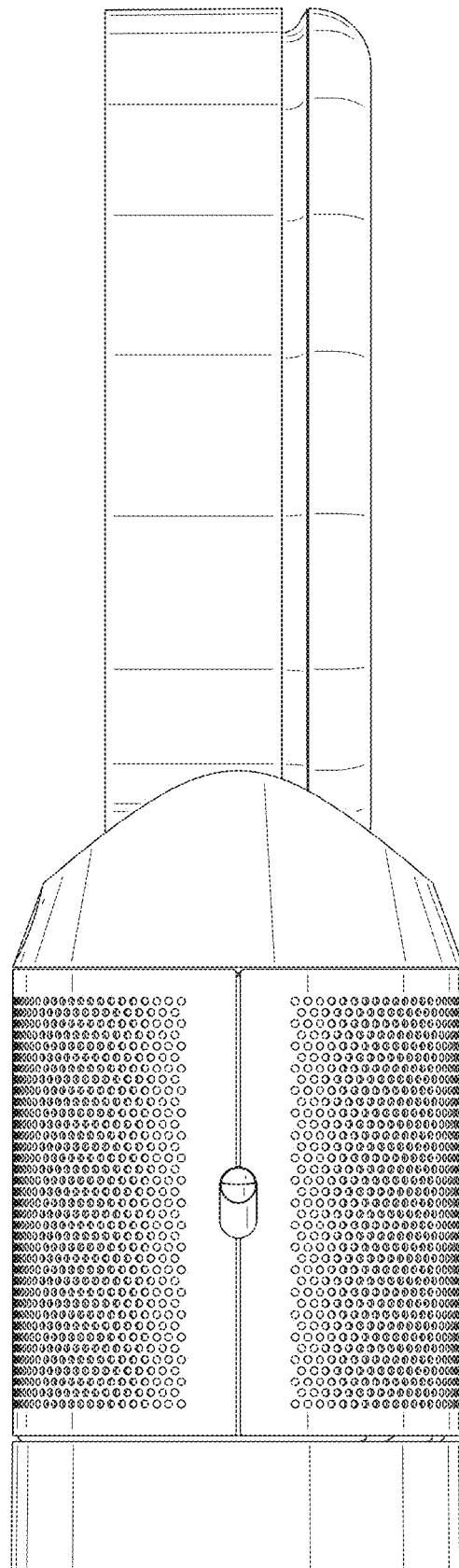

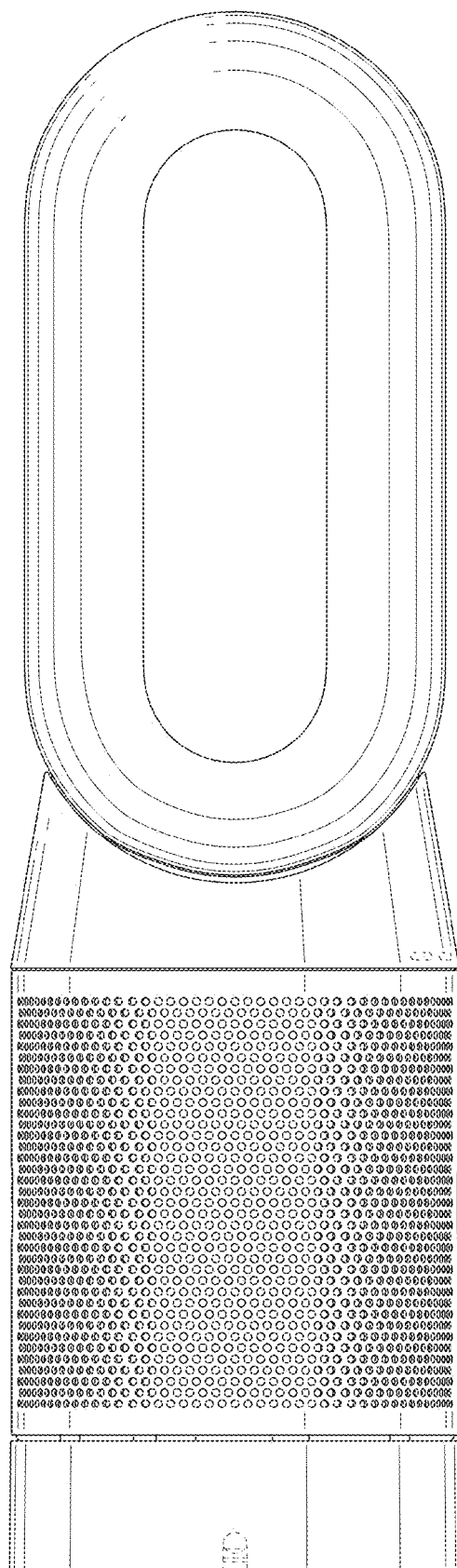

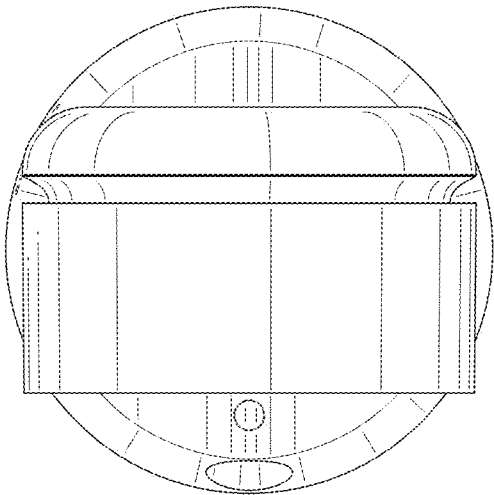

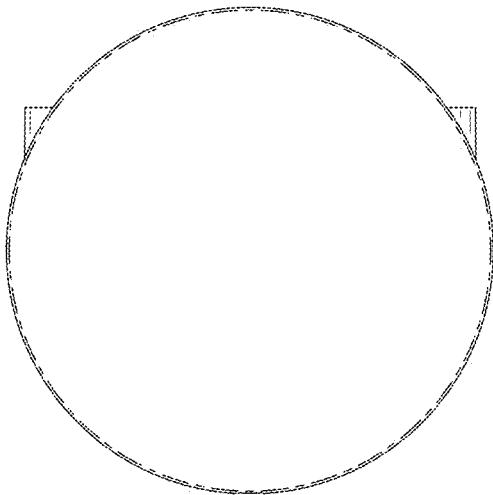
