(57) **CLAIM**


The ornamental design for a bull dog stationery tab, as shown and described.


**DESCRIPTION**

FIG. 1 is a front view of the bull dog stationery tab in accordance with my new design,  
FIG. 2 is a rear view of the bull dog stationery tab shown in FIG. 1;  
FIG. 3 is a perspective view of the bull dog stationery tab shown in FIG. 1;  
FIG. 4 is a left side view of the bull dog stationery tab shown in FIG. 1;  
FIG. 5 is a right side view of the bull dog stationery tab shown in FIG. 1;  
FIG. 6 is a top view of the bull dog stationery tab shown in FIG. 1; and,  
FIG. 7 is a bottom view of the bull dog stationery tab shown in FIG. 1.


The long and short broken lines around the inside edge of the bull dog stationery tab define the bounds of the claimed design and form no part thereof.  
The evenly spaced broken lines showing the clip and apertures in the middle of the bull dog stationery tab are included to show features that form no part of the claimed design.






