
(57) **CLAIM**

The ornamental design for a transparent box locker door with finger pull latch, as shown and described.

DESCRIPTION

FIG. 1 is a front top perspective view of a transparent box locker door showing our new design;
 FIG. 2 is a bottom plan view thereof, the top plan view being identical to the bottom plan view;
 FIG. 3 is a rear elevational view thereof;
 FIG. 4 is a left end elevational view thereof, the right end elevational view being identical thereto;
 FIG. 5 is a top front perspective view of a further embodiment of the transparent box locker door design; and,
 FIG. 6 is a top perspective view of yet another embodiment of the transparent box locker door design.







